FOOTNOTES

1: DCSIs and Principals of SIG and ESF-FSG awardees that did not attend the required ESC trainings in 2021 need to attend ESC training in the Fall of 2022.

2: 2nd year *Overall F* campuses are encouraged to implement the Commissioner approved Turnaround Plan (TAP) from the 2019-2020 school year. Campuses will have an opportunity to submit a revised TAP during the 2022-2023 school year if it wishes.

3: 3rd year+ *Overall F* campuses must implement the Commissioner approved TAP.

4: *Additional Targeted* and *Targeted Support* campuses must engage in necessary requirements in relation to its state accountability rating.

5: All *CSI* and ESF-FSG campuses must hold a public meeting to discuss the respective campus and campus performance objectives. This row indicates whether a public meeting to solicit input on the development of the TIP is required.

6: For 2022 state academic accountability, except in certain circumstances, LEAs will receive ratings of A, B, C, or Not Rated: Senate Bill 1365. As with other Not Rated labels, when a district or campus receives a Not Rated: Senate Bill 1365 label, the LEA or campus is expected to implement the previously ordered sanctions and interventions. The ratings included here refer to previously issued ratings in 2019.

7: *CSI* campuses in the continuation/implementation years of a SAF grant are not required to create or submit a TIP. These campuses will follow SAF interventions and submissions. Eligible campuses in the Planning Year are still required to develop a TIP and engage in SI interventions.
