It is mutually understood and agreed by and between the undersigned contracting parties of the above numbered contract to amend said contract effective as follows:

WHEREAS, Standard and Poor's Financial Services LLC, as part of an internal reorganization, assigned all of its rights and obligations under the contract to S&P Global Market Intelligence LLC (formerly known as S&P Capital IQ LLC), including its right to receive payment under the contract, whether due prior to the assignment or after the assignment;

WHEREAS, S&P Global Market Intelligence LLC (formerly known as S&P Capital IQ LLC) assumed all rights and obligations of Standard and Poor's Financial Services LLC under the contract and is entitled to receive all payment under the contract, whether due prior to assignment or after the assignment.

THEREFORE,

1. All references in the contract to Standard and Poor's Financial Services LLC shall be amended to refer to S&P Global Market Intelligence LLC (formerly known as S&P Capital IQ LLC).
2. The Federal Tax ID of S&P Global Market Intelligence LLC (formerly known as S&P Capital IQ LLC) is 47-5619682 and the contract is hereby amended to incorporate such Federal Tax ID.
3. All invoices due and payable under the contract shall be paid to the order of S&P Global Market Intelligence LLC.
