It is mutually understood and agreed by and between the undersigned contracting parties of the above numbered contract to amend said Contract effective September 1, 2016 as follows:

ARTICLE II. PERIOD OF CONTRACT

TEA is exercising option to renew the contract for the period from September 1, 2016 – August 31, 2017 as allowed in the original Contract term.

ARTICLE III. PURPOSE OF CONTRACT

This is to request an amendment to the Sistema Technologies, Inc for TSDS/PEIMS DBITS #701-16-013 to allow for the following:

Amendment for the first renewal period from 9/1/16 – 8/31/17 for the development, maintenance and support of Texas Student Data System (TSDS) Public Education Information Management System (PEIMS). The work load will significantly increase as the remaining 600+ districts are required to use TSDS PEIMS in FY17 beginning 9/1/2016.

The development requires an increase the contract by \$180,000 (2000hrs * \$90.00/hr) to pay for development and support (required enhancements and defect fixes) of the TSDS PEIMS product.


Texas Government Code §2252.901 prohibits the agency from entering into an employment contract, a professional services contract, or a consulting services contract with a former or retired TEA employee before the first anniversary of their last date of regular employment. If TEA enters into a "professional services" contract with a corporation, firm, or other business entity that employs a former or retired employee during the first year of the past employee's departure from the agency, the former or retired employee is restricted from performing services on projects that the employee worked on while employed at TEA.

Texas Government Code §572.069. CERTAIN EMPLOYMENT FOR FORMER STATE OFFICER OR EMPLOYEE RESTRICTED. A former state officer or employee of a state agency who during the period of state service or employment participated on behalf of a state agency in a procurement or contract negotiation involving a person may not accept employment from that person before the second anniversary of the date the officer's or employee's service or employment with the state agency ceased.

Effective 01/01/16, the mileage reimbursement rate is .54¢, the previous rate was 57.5¢ from 01/01/15 – 12/31/15. The Comptroller's website for travel rules and regulations – textravel:
