School Improvement Grants, authorized under section 1003(g) of Title I of the Elementary and Secondary Education Act of 1965 (Title I or ESEA) as amended by ARRA, are grants, through the Texas Education Agency, to local educational agencies (LEAs) for use in Title I schools identified for improvement, corrective action, or restructuring and other eligible campuses that demonstrate the greatest need for the funds and the strongest commitment to use the funds to provide adequate resources in order to raise substantially the achievement of their students so as to enable the schools to make adequate yearly progress and exit improvement status. Under the final requirements, as amended through the interim final requirements published in the Federal Register in January 2010 school improvement funds are to be focused on each State's "Tier I" and "Tier II" schools.

Tier I schools are a State's persistently lowest-achieving Title I schools in improvement, corrective action, or restructuring and certain Title I eligible elementary schools that are as low achieving as the State's other Tier I schools. Tier II schools are a State's persistently-lowest achieving secondary schools that are eligible for, but do not receive, Title I, Part A funds and certain additional Title I eligible secondary schools that are as low achieving as the State's other Tier II schools or that have had a graduation rate below 60 percent over a number of years. An LEA may also use school improvement funds in Title I schools in improvement, corrective action, or restructuring that are not identified as persistently lowest-achieving schools and certain additional Title I eligible schools ("Tier III schools").

In the Tier I and Tier II schools an LEA chooses to serve, the LEA must implement one of four school intervention models: turnaround model, restart model, school closure, or transformation model.

Allowable Activities

Tier I and Tier II Grantees

- Grantees must expend grant funds for the required activities delineated for the selected intervention model as defined in the final federal regulations.
- Grantees may expend grant funds for the permissible activities delineated for the selected intervention model as defined in the final federal regulations.
- Grantees may expend grant funds for other school improvement activities deemed needed to address identified needs not addressed by the intervention model selected.

Tier III Grantees

- Tier III grantees may select one of the four intervention models in the federal regulations or the state's Tier III Transformation Model.
- If selecting one of the four models in the federal regulations, grantees must expend grant funds for the required activities delineated for the selected intervention model as defined in the final federal regulations. Grantees may expend grant funds for the permissible activities delineated for the selected intervention model as defined in the final federal regulations.
- Grantees may expend grant funds for other school improvement activities deemed needed to address identified needs not addressed by the intervention model selected.

In addition, a Tier I, Tier III grantee campus that has implemented, in whole or in part, either the Turnaround, Restart, or Transformation models within the last two years may continue or complete the implementation of the intervention model with the TTIPS grant funds. For example, if a grantee campus has replaced its principal within the last two years, the LEA/campus will not be required to hire another new principal. An LEA/campus that receives TTIPS SIG funds in accordance with this flexibility must fully implement the selected model as required by the final federal requirements. In other words, if the school had been implementing the model only in part, it must use the funds it receives to expand its implementation so that it fully complies with the federal regulatory requirements.

The detailed required and permissible activities for each intervention model, as defined in the final federal regulations are listed on Schedule #4—Program Requirements and are incorporated by reference herein.

Our program comes in two parts. Primarily, we must change the school climate. Schools must be a positive, safe place to learn. Schools face a perception by some that courses are not relevant, and that staff is apathetic. We want to assure that students see and feel that they are enveloped by a caring staff by developing professional mentoring relationships that actively show a caring, and committed attitude toward the success of each student. In an article in the December 2004 issue of Best Practice Briefs the author explains that, school climate is a significant element in discussions about improving academic performance and school reform." We want to create a school that targets the long-term interests and goals of students. Our research indicates that interested, engaged students will have a better overall school experience which includes academic achievement and stronger positive rapport with staff. The resulting outcome reduces future drop-out concerns. To achieve this, they would develop a "looping" master schedule. "The rising interest in looping has been in direct response to the diverse needs of students. Looping provides stability for the growing number of students with less stable home environments. Looping classes develop a family-like environment, providing teachers with the opportunity to build strong, meaningful relationships with students," according to Tim Johnson and Paul Grant. Looping is researched and practiced by the national Waldorf school. This practice has proven effective in intervening before problems become apparent. Second, they will continue to focus on improving student achievement by addressing AYP, AEIS, and PBMAS deficiencies in math, ELA, and science among various student groups. We will continue to improve our knowledge and practice of the database system which creates a baseline from various data sources and overlays benchmark data that shows a margin of improvement for each student. This information helps schedule small groups for intervention and remediation. It also helps to evaluate staff and gauge curriculum being taught. Data is just a sea of numbers without implementation. Teachers play the most important role because they use the information to the directly effect the success of students. However, disaggregation and compilation is equally important. Our manual system is effective, but antiquated and time-consuming for administrators. Staying current is virtually impossible. We lack the time and resources to maintain this data; consequently, a new database system will alleviate the need of improvement over the manual calculations with a system that runs more efficiently is great. We believe that a great staff will be better served by staff development that drives our instructional strategies. We believe that a disconnect exists here. Many times staff development is planned according to availability. This shift in approach will offer a narrow, clear focus. Staff development should be carefully planned according to weakness as discovered from benchmark testing and state testing. Liberty Elementary School has selected the Tier III Transformation model.

This approach will continue as the planning tool. Specifically, the campus followed the following process: a. We gathered information from various sources including but not limited to TAKS scores. TAKS longevity reports, AYP data, I-NOVA and benchmark assessments; b. Staff was divided into content area to identify campus needs. These groups analyzed demographic as well sub-population data; c. Core subject area teachers met in groups to study specific TAKS results and trends. They developed instructional strategies to address the weaknesses. d. Other campus staff met to review attendance data and review other instructional needs or concerns. The group suggested positive ideas that were added to the Campus Improvement Plan (CIP). e. The site-based Campus Improvement Team (CIT) and faculty met throughout the year adjusting the CIP and addressing current needs and concerns. Department level meeting with curriculum personnel were held to evaluate progress and optimize results.

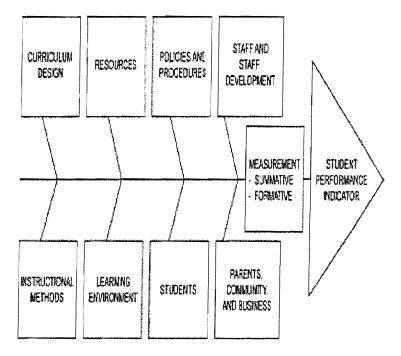

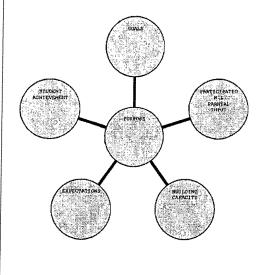

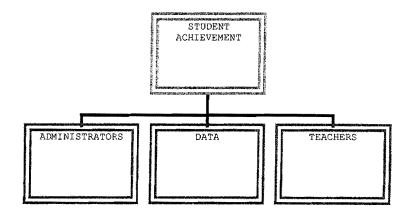

Hiring some new personnel and moving ineffective staff was addressed as well as the development of new curriculum. Significant district resources were used to address the deficiencies. A new accountability system was established that focused on increased responsibility by core teachers. CBA's (Curriculum Based Assessments) were implemented to track effectiveness of strategies. The principal has seen positive results with the sweeping changes. The first year was steep with opposition, but he was steadfast with his reformation. He handled the job like a professional; it was business, not personal. Along with the rest of the administrative team including, but not limited to, the assistant principal, the curriculum director, the counselors, the principal will surrounded himself with a strong support system creating a pipeline of leadership capable of keeping him on track to achieve the goals of this grant. The principal reflects on the possibilities of this grant.

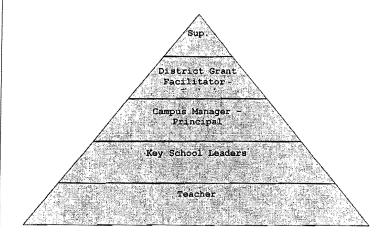

Program Continuation and Sustainability – Describe how the LEA will sustain the campus reforms after the funding period ends.

Because of the nature of how the grant money will be spent, the lasting effects are infinite. Much of the money is centered on professional development and technology. So when the money ceases to be available, the long-term advantages will still be paying off. One goal for Liberty Elementary School is to increase teacher quality. The benefits of meaningful professional development cannot be eradicated once the money runs out. The knowledge will hopefully stay with the teachers for many years. From Charles Achilles and Christopher Tienken's article on *The Effects of Professional Development: A View From Plato's Cave.* They determined that educators should evaluate the emphasis on professional development against three criteria.

- 1) "Those who receive the professional development demonstrate positive change in skills, knowledge, attitudes, and behaviors. The new professional practice will be sustained as part of the professional's armamentarium.
- 2) The desired changes and improvements should be measurable and observable in the short term and in the long term: They become the norm until better knowledge; skills (etc.) are available.
- 3) Because the ultimate beneficiary of professional development should include the clients (i.e., students) the results of professional development should lead directly to observable, measurable positive change in student outcomes on clearly defined criteria."

Technology software and hardware will be bought to enhance the instructional process on the campus. Predominately this is a one time large expense and after that the maintenance and operation of the technology can be handled by the district. Several goals of the District Technology Plan will be met in this process.

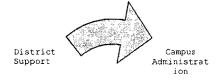

Robert Frost wrote a poem entitled The Road Not Taken. This poem, familiar to many, epitomizes the uncertainty of a "new path" and the comfort in traveling "the path" that is familiar; Liberty Elementary School wants to take the "new, less traveled path". Consequently, they are committed to change that will "...make all the difference" in the lives of the children of this rural community. Liberty sitting about 40 miles east of Houston, the county seat of Liberty County, fringes almost directly between the piney woods of east Texas and the coastal region bordering the Gulf of Mexico. For over 100 years this school district has been servicing the needs of the children of the community. At one time the town was flourishing with natural resources from the oil industry; however, those resources have all but dried up. Not only has this impacted the school district, local businesses, but also the families. Accordingly, the school district comprises 63% economically disadvantaged students, and unfortunately with a high economically disadvantaged percentage comes an overabundance of at-risk students. Also according to the 1999 US Census data 44% of the children reside in single-parent homes. This number is certain to go up when the 2010 census data becomes available. The population has a very different dynamic than it did during the "oil days." The community has a much more multi-cultural flavor than it did 25 years ago. Although the new multi-cultural atmosphere has been embraced by the community, it offers new challenges for a school district struggling to stay financially secure. As much as possible the district has not let funding be an issue where academics are concerned, but regardless of the best intentions, many programs have been "put aside" for lack of financial support. Over the past several years our community has been faced with managing the devastation of Hurricanes Katrina/Rita and Ike. These Hurricanes caused unprecedented economic damage to the community/schools, and in some cases signs of the disorder continue. Despite these challenges, we are and will remain committed to offering the students in the school district every opportunity to be well-educated productive citizens.

Like Achilles in Greek mythology, public education has a critical weakness, an Achilles heel; a weakness of which it is unaware. Through a comprehensive campus needs assessment, Liberty Elementary School has determined that gathering data is not exclusively the answer to student achievement; the process that drives the data is equally critical to the performance. In order for true reform to occur the focus cannot be too narrowly focused on the performance outcomes, but in conjunction with the process that coerces the outcomes. According to Dr. C. Jackson Grayson of APQC Education, "...without tending to processes as well as outcomes, there's little chance of meaningful improvement." After analysis of the campus needs assessment Liberty Elementary School led by the principal asked the difficult question, "Are we bold enough for our kids to make the kind of drastic changes necessary to see dramatic reform?" The answer was overwhelmingly yes. The culture is ripe for change, and they realize that "nothing changes if nothing changes."

Administr@tor magazine explains that "...schools are now at the epicenter of change. Sitting on the sidelines is not allowed during this burst of education creativity." Schools have to abandon the sit-and-get method of learning, and adults must be willing to change their behavior: One size really does not fit all. Education has evolved into the civil rights of this generation. One has to look no further than Central Falls, Rhode Island, where the actions of Superintendent, Francis Gallo, made national news when she fired the entire staff of 93 in the small town's only high school. Radically dramatic school changes have popped up on the horizon around the nation. In many cases what happens inside the school has not caught up with the changes that have and are happening "outside." Schools are stuck in an antiquated agrarian system. However, schools like The Harlem Children's' Zone in New York, Capital Prep in Connecticut, and KIPP Academy and YES Prep in Texas have blazed a bold trail and not only set a new standard of excellence, but also have created a model of reform for the rest of the country.

On February 7, 2009 President Barack Obama signed the American Recovery and Reinvestment Act of 2009 into law which appropriated billions of dollars to education. This translates into millions at the local level; however, in order for the "Recovery" money to become a reality for local districts, they must commit to bold, courageous change.

This change begins with a look at the school's fundamental strengths and weaknesses starting with the school leadership. According to Hallinger and Heck's article "Exploring the Principal's Contribution in School Effectiveness," "...school leaders exert a powerful, if indirect, influence on teaching quality and student learning." Not only must the leadership be examined, but also the current model of education must be scrutinized. According to research by Robert Freeman, "cultures live by their models." "When it comes to education, our models are not people but, rather, ideas." For school improvement to see fruition, getting the model right does not prove nearly so important as getting the right model. Liberty Elementary, a Tier III school, has chosen the **TEA Tier III Transformation Modified Model.** The school has worked extensively planning to implement this model of education.

After a needs assessment pointed to including the process as well as the performance in order to facilitate school reform, the elementary school began studying the climate of the school and that started with the principal. According to Social Emotional Development Learning (SEDL), an Austin based educational nonprofit, "...effective change requires skilled leadership that can integrate the soft human elements with hard business actions." In the 2007-2008 school year the school leadership changed. The new principal initiated a practice that included extensive data collection. This practice, along with various other changes kept the elementary school from becoming in danger with AYP or AEIS status. The principal has been and continues to be involved in ongoing professional development. Based on the positive changes that have occurred within the school, the campus committee has determined that it is not necessary to change the principal. SEDL also finds that "...instructional leadership is a significant aspect of effective schools and includes characteristics such as high expectations of students and teachers, an emphasis on instruction, provision of professional development, and the use of data to evaluate students' progress among others." SEDL concludes that, "instructional leadership has been found to be a significant factor in facilitating, improving, and promoting the academic progress of students." The elementary school is confident that their instructional leadership is serious about change and has the instructional course clearly navigated. With the instructional compass keeping the curriculum stable, the school took a critical look at the climate of the school. According to Sanford N. McDonnell, a professor at The University of Missouri. "the nationally recognized Comprehensive School Climate Inventory (CSCI) is a scientifically-based set of measures that provide a comprehensive picture of a range of school climate dimensions, from students, staff and parents." The Best Practices Brief at Michigan State University describes that "...school climate reflects the physical and psychological aspects of the school that are more susceptible to change and that provide the preconditions necessary for teaching and learning to take place."

Liberty Elementary School aims to achieve the following goals:

- 1). Improve overall student achievement with particular emphasis on student groups.
- 2). Improve the quality of instructional leadership.
- 3). Improve teacher quality.
- 4). Improve parent/community relations.

In order to achieve the four goals, the school will 1) continue the extensive <u>data collection</u>. This data sets the instructional compass, and attention and reaction to this data can improve academic performance; 2) continue to give the <u>staff development</u> program regular shots of B-12 to increase teacher quality and improve instructional leadership; and 3) improve the <u>school climate</u> which according to research will improve academic performance and will increase parent/community involvement.

The plan is entitled **"Someday is Now.**" This title is derived from the songs *Sometimes* by the Carpenters and *Our Day Will Come* by Ruby & the Romantics. Both songs speak of reflection and dreams, "sometimes not often enough, we reflect upon the good things," and "our dreams have magic." Liberty Elementary wants to do more than just reflect and dream; they want the trite expression "someday" to not just be a pipe dream for the future, they want and are committed for **Someday** to be **Now**.

The following paragraphs will examine the details of Liberty Elementary School's **Someday is Now** plan. With emphasis on **data collection**, **staff development** and **school climate** the plan will show how the <u>Tier III</u> <u>Transformational Model</u> will narrow the focus of the efforts to cultivate a culture of success rather than one of failure at Liberty Elementary School. The plan follows the Seven Critical Success Factors.

- 1). Improve Academic Performance including (but not limited to) Reading/ELA and Mathematics Gone are the days of spontaneous school lessons planned over a morning cup of coffee. Rather lessons should be generated after studying data. Data should not be rejected, but seen as a tool that is a recipe for quality instruction. According to Dr. Scott McLeod at the University of Minnesota, "...teachers are finding that intelligent and pervasive uses of data can improve their instructional interventions for students, re-energize their enthusiasm for teaching, and increase their feelings of professional fulfillment and job satisfaction." Liberty Elementary School (LES) will give assessments based on instruction in ELA. math, and science. The data from these assessments will navigate the trail for curriculum alignment and classroom instruction. LES will meet individually with students to discuss specific performance. This will make student achievement personal for every student: Even the high achieving students that can "see" that they possibly only lacked one question from being commended. C-SCOPE for Curriculum alignment and Successmaker for curriculum reinforcement will be purchased. Reading and math interventionists will be hired as well as a science lab teacher. Academic looping will foster sustained relationships and rapport among teachers, students, and parents. Differentiated instruction along with 21st Century technology improvements will boost LES in a positive direction toward improved academic performance.
- 2). Increase the Use of Quality Data to Drive Instruction LES has to become a better manager of getting information about students into the hands of classroom teachers. Again according to Dr. McLeod, "...most teachers and other support staff are unprepared to adopt data-driven approaches without extensive professional development and training. LES currently has many sources of student data. At this time only a handful of teachers/administrators are able to disaggregate and analyze the data. This grant will allow for training that will equip all classroom teachers the power of data and its use in driving decision-making and instruction. Teacher conferences can become more powerful with teachers, parents, and campus administrators all speaking the "same language." LES wants to be data-savvy from the main office to the gym. They want to be able to merge the data from several assessments setting the gauge for student achievement and create and maintain a database that will create and store a baseline for every student in core areas. This process is on-going and should not stop with the classroom teacher. A new data system Aimsweb will be purchased to organize the data. The principal will also become adept at reading data, and this knowledge will help when addressing attendance, dropout, and behavioral issues. Dr. McLeod summarizes"...the driving engine behind substantial improvements in student learning outcomes is a strong system of formative assessment, coupled with the opportunity for teachers to collaboratively make sense and act upon the formative data they receive."

- 3). Increase Leadership Effectiveness "The buck" truly does stop in the Principal's office. The Principal is the most visible of any position at a school. Hoy and Brown found that, "...teachers responded more favorably to principals with a leadership style that combines both structure and consideration." Samuel Klug notes in his book about Leadership and Learning that "...school leaders can influence levels of motivation by 'shaping the school's instructional climate,' which in turn shapes 'the attitudes of teachers, students, parents, and the community at large toward education.' By effectively managing this aspect of a school's culture, principals can 'increase both student and teacher motivation and indirectly impact learning gains." At LES the principal will engage in on-going job-embedded professional development. G.M. Sparks explains, "Successful job-embedded staff development requires principals to see themselves as leaders of learning and as designers of structures that support high levels of learning by being the facilitator of adult learning." In order to emerge into the bold, courageous leader necessary to successfully make the transformation, in addition to professional development, the principal will receive SIRC mentoring and attend summer training. We focus our time on what we consider most important. According to the Oregon Reading First Center, "...instructional leadership is, perhaps, the single most important role for principals to play when student achievement is the goal." Wagner reiterates that, "...performing a learning walk (instructional walk-through) is a step that should be informed with an understanding of what constitutes quality instruction. This clarity is key to actually make that instruction happen." Ultimately, continuous Learning Walks by the principal will gauge the instruction at LES eventually affecting student achievement.
- 4). <u>Increase Learning Time</u> Arne Duncan, with the support of President Obama, "...has made clear his view 'that our school day is too short, our week, is too short, our year is too short." Students in the United States spend much less time in school than do students in other industrialized nations. According to Richard Neal in his article in *School Reform News*, "...the NCLB Act has revealed woeful student achievement inadequacies nation-wide...this has led educational entities from the national level to the LEA to take a close look at extending the school day and/or the school year in order to boost student achievement." The 180 day calendar was developed to meet the needs of farms and factories over 100 years ago, and it does not allow children and teachers enough time to meet the goals of a 21st Century Education. LES concurs and wants to extend the school day until 4:30 4 days a week. Additionally LES will create three satellite school locations that will be staffed with professional personnel for homework/parent assistance after school hours.
- 5). Increase Parent/Community Involvement NCLB describes parental involvement as "...the participation of parents in regular, two-way, meaningful communication involving student academic learning and other school activities..."Parent Involvement is key to student success. Schools can no longer hold on to the mindset that sets the parents apart from the school. They are not mutually exclusive. Aided by new technology, LES will not only establish satellite school locations, but also take Field trips that are specific to Career Awareness. Four times a year LES will organize and host a Parent Academy with a Heritage theme. They will also create a community/Parent/Volunteer Bulletin Board that highlights current activities and opportunities. Community mentors will be established for students, and to work on "customer service/relations" office paraprofessionals will be sent to training. Government services will be utilized as much as possible from the game warden, the county extension agent, to elected government officials. New technology will be a valuable tool for many of these endeavors.

In research and study of the latest educational trends Liberty Elementary School believes that it has put together a plan that is efficient and effective given the resources they have; they believe that the process that drives the data will not be their Achilles Heel, but rather what catapults them to a stellar school committed to the children in this community well into the 21st Century global marketplace.

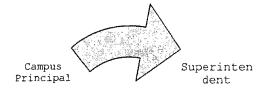

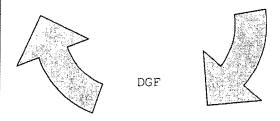

In addition to getting weekly reports from the campus principal, the District Grant Facilitator (DGF) will report weekly to the Superintendent at the weekly District Administrator Meeting. The DGF will visit the campus regularly during each week to monitor the progression of grant activities.

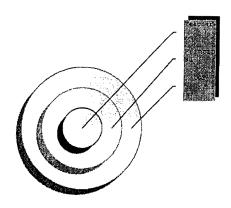

According to an article in *Classroom Assessment*, "Formative assessments are on-going assessments, reviews, and observations." Formative assessments will continually take place in the classroom, on the campus, and at the district level.

Classroom – Teachers are the strongest resource for formative evaluation on student achievement because they are on "the front line" of education. Examples of formative assessment tools could be homework, quizzes, exit tickets, subject area discussions, and tests. Communication about the formative data is essential with the principal and the teacher. This data can then be compared to more summative data for a truer picture of the student's achievement.

Campus – The campus principal will continually seek to communicate with the teachers in order to develop a formative evaluation of the entire school campus that incorporates formative as well as summative data.

District – The District Grant Facilitator (DGF) will continually communicate with the campus principal to formulate a vision that oversees the campus data. This district vision will navigate and constantly be the "lookout" for problem areas. Problems can be remedied immediately with thorough formative evaluations.

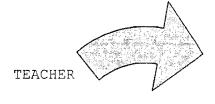

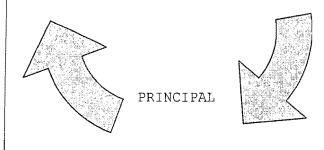

Statement of provisions and assurances for the program(s) in this application:

- A. Terms defined: As used in these Provisions and Assurances,

 - Agency or TEA means the Texas Education Agency;
 - Contractor means the party or parties to this contract other than Agency; including its or their officers, directors, employees, agents, representatives, consultants and subcontractors, and subcontractors' officers, directors, employees, agents, representatives and consultants;
 - Project Administrator means the person representing Agency or Contractor, as indicated by the contract, for the purposes of administering the contract project;
 - Contract Project means the purpose intended to be achieved through the contract of which these Provisions and Assurances are a part;
 - Applicant means the same as Contractor;
 - SAS means the Standard Application System of which the application document is a part;
 - "Application" means the entire package submitted by the Applicant including the schedules contained in the application and so indicated on the General Information page of the application package;
 - Amendment means an application that is revised in budget categories and/or in program activities. It includes both the
 original application and any subsequent amendments; or extensions thereto;
 - Works means all tangible or intangible material, products, ideas, documents or works of authorship prepared or created by Contractor for or on behalf of TEA at any time after the beginning date of the Contract (Works includes but is not limited to computer software, data, information, images, illustrations, designs, graphics, drawings, educational materials, assessment forms, testing materials, logos, trademarks, patentable materials, etc.); and,
 - Intellectual Property Rights means the worldwide intangible legal rights or interests evidenced by or embodied in: (a) any idea, design, concept, method, process, technique, apparatus, invention, discovery, or improvement, including any patents, trade secrets, and know-how; (b) any work of authorship, including any copyrights, moral rights or neighboring rights; (c) any trademark, service mark, trade dress, trade name, or other indicia of source or origin; (d) domain name registrations; and (e) any other similar rights. Expenditures and/or activities for which Contractor may claim reimbursement shall not be accrued or claimed subsequent to receipt of such notice from Agency. This contract may be extended or otherwise amended only by formal written amendment properly executed by both Agency and Contractor. No other agreement, written or oral, purporting to alter or amend this contract shall be valid.
- C. Contractor's Application: Furnished to Agency in response to a request for application, is incorporated in this contract by reference for all necessary purposes. It is specifically provided, however, that the provisions of this contract shall prevail in all cases of conflict arising from the terms of Contractor's application whether such application is a written part of this contract or is attached as a separate document.
- **D. Requirements, Terms, Conditions, and Assurances:** Which are stated in the Request for Application, in response to which Applicant is submitting this application, are incorporated herein by reference for all purposes although the current General Provisions shall prevail in the event of conflict. The instructions to the Standard Application System, as well as the General and Fiscal Guidelines and Program Guidelines, are incorporated herein by reference.

- E. Signature Authority; Final Expression; Superseding Document: Applicant certifies that the person signing this application has been properly delegated this authority. The Contract represents the final and complete expression of the terms of agreement between the parties. The Contract supersedes any previous understandings or negotiations between the parties. Any representations, oral statements, promises or warranties that differ from the Contract shall have no force or effect. The Contract may be modified, amended or extended only by formal written amendment properly executed by both TEA and Contractor.
- **F. State of Texas Laws:** In the conduct of the contract project, Contractor shall be subject to Texas State Board of Education and Commissioner rules pertaining to this contract and the contract project and to the laws of the State of Texas governing this contract and the contract project. This contract constitutes the entire agreement between Agency and Contractor for the accomplishment of the contract project. This contract shall be interpreted according to the laws of the State of Texas except as may be otherwise provided for in this contract.
- **G. Monitoring**: Desk reviews or on-site monitoring reviews may be conducted by Agency to determine compliance with the approved application and the applicable statute(s), law(s), regulations, and guidelines.
- **H. Sanctions for Failure to Perform or for Noncompliance:** If Contractor, in Agency's sole determination, fails or refuses for any reason to comply with or perform any of its obligations under this contract, Agency may impose such sanctions as it may deem appropriate. This includes but is not limited to the withholding of payments to Contractor until Contractor complies; the cancellation, termination, or suspension of this contract in whole or in part; and the seeking of other remedies as may be provided by this contract or by law. Any cancellation, termination, or suspension of this contract, if imposed, shall become effective at the close of business on the day of Contractor's receipt of written notice thereof from Agency.
- I. Contract Cancellation, etc.: If this contract is canceled, terminated, or suspended by Agency prior to its expiration date, the reasonable monetary value of services properly performed by Contractor pursuant to this contract prior to such cancellation, termination or suspension shall be determined by Agency and paid to Contractor as soon as reasonably possible.

J. Indemnification:

K. Encumbrances/Obligations and Liquidations: All encumbrances/obligations shall occur on or between the beginning and ending dates of the contract. All goods must be received and all services rendered between the beginning and ending dates of the contract. The contractor must liquidate (record as an expenditure) all obligations (encumbrances) incurred under the contract no later than 30 days after the ending date of the contract, to coincide with the submission of the final expenditure report, due 30 days after the ending date of the contract. In no manner shall encumbrances be considered or reflected as accounts payable or as expenditures, and an encumbrance cannot be considered an expenditure or accounts payable until the goods have been received and the services have been rendered. - L.  - (G) is a school to which parents choose to send their children, and that admits students on the basis of a lottery, if more students apply for admission than can be accommodated;
 - (H) **agrees to comply with the same Federal and State audit requirements** as do other elementary schools and secondary schools in the State, unless such requirements are specifically waived for the purpose of this program;
 - (I) meets all applicable Federal, State, and local health and safety requirements;
 - (J) operates in accordance with State law; and
 - (K) has a written performance contract with the authorized public chartering agency in the State (i.e., SBOE) that includes a description of how student performance will be measured pursuant to State assessments that are required of other schools and pursuant to any other assessments mutually agreeable to the SBOE.
 - 2. **Community-Based Organization**: A public or private nonprofit organization of demonstrated effectiveness that is representative of a community or significant segment of a community and that provides educational or related services to individuals in the community.
 - 3. **Core Academic Subjects**: English, reading or language arts, mathematics, science, foreign languages, civics and government, economics, art, history, and geography.

- C. Compliance with Other Provisions and Assurances: All provisions and assurances stated in the General Provisions, Certification Regarding Debarment and Suspension, Lobbying Certification and Disclosure of Lobbying, No Child Left Behind Act (NCLB) Special Provisions and Assurances, and all other program-specific provisions and assurances apply unless they conflict or are superseded by the following terms and conditions implementing the American Recovery and Reinvestment Act of 2009 (ARRA) requirements below. This includes compliance with Title VI of the Civil Rights Act of 1964; Section 504 of the Rehabilitation Act of 1973; Title IX of the Education Amendments of 1972; the Age Discrimination Act of 1975; and all other nondiscrimination provisions. - **D. Compliance with Other Program Statutes:** The applicant agrees to comply with the authorizing program statutes, regulations, non-regulatory guidelines, and other guidance in the implementation of the programs receiving funding under ARRA. This includes compliance with comparability; supplement, not supplant; maintenance of effort (MOE); equitable participation for private nonprofit school students and teachers; and all other program-specific provisions and requirements. All such are hereby incorporated by reference.
- **E. DUNS Number:** All entities receiving any federal funds, including ARRA funds, are required to have a DUNS (Dunn & Bradstreet) number. The DUNS number serves as the grantee organization's unique identifier for reporting federal funds received and expended. TEA must use this same DUNS number to report grant awards and expenditures for subrecipients under ARRA to the website specifically provided for in ARRA http://www.FederalReporting.gov/. The assignment of a DUNS number is a condition of award of ARRA funds and must be validated by TEA prior to issuing a NOGA for ARRA funds. - **F. Central Contractor Registration (CCR):** All grantees receiving ARRA funds, as well as any other federal funds, are required to register and maintain current registration with the Central Contractor Registration (CCR) database at http://www.ccr.gov. Registration in CCR is a condition of award of ARRA funds and must be validated by TEA prior to issuing a NOGA for ARRA funds.
- **G. ARRA Reporting Requirements:** The federal Office of Management and Budget (OMB) has issued guidance related to reporting the use of ARRA funds to the various websites. The definition of terms and data elements, as well as any specific instructions for reporting, including required formats, are provided in separate guidance issued by the TEA.

The Texas Education Agency as a direct recipient of funds is required to report certain information at certain intervals throughout the grant period as required in Section 1512 of ARRA. - 3. Quarterly Reporting for ARRA: Not later than 10 calendar days after the end of each calendar quarter, TEA and any other direct recipient of ARRA funds must report to the U.S. Department of Education with regard to recovery funds received in accordance with number 4 below (Section 1512[c]). (A "direct recipient" is a state agency or any entity that applies for and receives funds directly from a federal government agency.) TEA must obtain certain information from grantees in order to comply with this reporting requirement. TEA will notify the grantee in the event status information needs to be collected.)
- k. An estimate of the number of jobs created and the number of jobs retained by the project or activity and a brief description of the types of those jobs (i.e., job titles) (TEA will need to collect this information from grantees.)
- I. The names and total compensation of the five most highly compensated officers of the grantee organization if the organization in its preceding year received 80% or more of its annual gross revenues in Federal awards and \$25,000,000 or more in annual gross revenues from Federal awards and the public does not have access to information about the compensation of senior executives. (It is not known at this time whether this data element will be required once the data elements are finalized by OMB. Fosting the Information on Public Website: Not later than 30 days after the end of each calendar quarter, each federal agency, including the U.S. Department of Education, shall make the information in those reports publicly available by posting the information on the designated public website (Section 1512[d]). Grantees will not be required to post information on the public website unless they apply for and receive other ARRA grants directly from a federal government agency.

Once OMB adopts the final data reporting elements and TEA receives specific instructions for reporting, TEA will provide subsequent guidance to grantees related to required reporting information.

- H. Electronic Drawdown of ARRA Funds from TEA and Use of FAR Fund Codes: Recipients will draw down ARRA funds on an award-specific basis. Pooling of ARRA award funds with other funds for drawdown or other purposes is not permitted. Recipients must account for each ARRA award separately by referencing the assigned FAR (Financial Accounting and Resource) fund code for each award.
- **I. Availability of Records:** The applicant agrees to make all financial and programmatic records available in detail for inspection by TEA auditors, local independent auditors, and the offices described below.
- 1. **Examination of Records:** The Comptroller General of the United States and any of its employees, contractors, agents, representatives, or designees, may examine any records related to obligations and use by any state or local government of funds made available under ARRA. (Section 901[b]).
- 2. Access of Government Accountability Office (GAO): Each contract and each subcontract awarded using funds made available under ARRA shall provide that the Comptroller General of the United States and his representatives are authorized to examine any records of the contractor or any of its subcontractors, or any State or local agency administering such contract, that directly pertain to, and involve transactions relating to, the contract or subcontract and to interview any officer or employee of the contractor or any of its subcontractors, or of any State or local government agency administering the contract, regarding such transactions (Section 902).
- 3. **Reviews by Inspector General:** The inspector general of the U.S. Department of Education shall review, as appropriate, any concerns raised by the public about specific investments using funds made available in this Act. Any findings of such reviews shall be relayed immediately to the Secretary of Education. In addition, the findings of such reviews, along with any audits conducted by any inspector general of ARRA funds, shall be posted on the inspector general's website and linked to the recovery.gov website, except that portions of reports may be redacted to the extent the portions would disclose information that is protected from public disclosure under sections 552 and 552a of Title 5, United States Code (Section 1514).
- 4. Access of Offices of Inspector General to Certain Records and Employees: With respect to each contract or grant awarded using ARRA funds, any representative of an Inspector General of the U.S. Department of Education or other appropriate federal agency is authorized to examine any records of the contractor or grantee, any of its subcontractors or subgrantees, or any State or local agency administering such contract, that pertain to, and involve transactions relating to, the contract, subcontract, grant, or subgrant, and to interview any officer or employee of the contractor, grantee, subgrantee, or agency regarding such transactions (Section 1515).
- 5. Recovery Accountability and Transparency Board: Section 1521 of the ARRA establishes the Recovery Accountability and Transparency Board to coordinate and conduct oversight of ARRA funds to prevent fraud, waste, and abuse. The Board shall submit "flash reports" on potential management and funding problems that require immediate attention; quarterly reports; and annual reports to the President and Congress, including the Committees on Appropriations of the Senate and House of Representatives, summarizing the findings on the use of ARRA funds. The Board may conduct its own independent audits and reviews of ARRA funds. All reports shall be made publicly available on the www.recovery.gov website established by the Board. See paragraphs J and K below with regard to reports of suspected fraud or abuse (Sections 1523 and 1524).

- 6. **Recovery Independent Advisory Panel**: Section 1541 of the ARRA establishes the Recovery Independent Advisory Panel to make recommendations to the Recovery Accountability and Transparency Board on action the Board could take to prevent fraud, waste, and abuse relating to ARRA funds.
- **J. Disclosure of Fraud or Misconduct:** Each grantee awarded funds made available under the ARRA shall promptly refer to the USDE Office of Inspector General any credible evidence that a principal, employee, agent, contractor, subrecipient, subcontractor, or other person has submitted a false claim under the False Claims Act or has committed a criminal or civil violation of laws pertaining to fraud, conflict of interest, bribery, gratuity, or similar misconduct involving those funds.
- K. Protection for Whistleblowers: Section 1553 of the ARRA provides protection for State and local government and contractor whistleblowers. Any employee of any employer receiving ARRA funds may not be discharged, demoted, or otherwise discriminated against as a reprisal for disclosing, including a disclosure made in the ordinary course of an employee's duties, to the Recovery Accountability and Transparency Board, an inspector general, the U. S. Comptroller General, a member of Congress, a State or federal regulatory or law enforcement agency, a person with supervisory authority over the employee (or such other person working for the employer who has the authority to investigate, discover, or terminate misconduct), a court or grand jury, the head of a federal agency, or their representatives, information that the employee reasonably believes is evidence of (1) gross mismanagement of an agency contract or grant relating to ARRA funds; (2) a gross waste of ARRA funds; (3) a substantial and specific danger to public health or safety related to the implementation or use of ARRA funds; (4) an abuse of authority related to the implementation or use of ARRA funds; or (5) a violation of law, rule, or regulation related to an agency contract (including the competition for or negotiation of a contract), or grant, awarded or issued relating to ARRA funds. A person who believes that he or she has been subjected to a reprisal may submit a complaint regarding the reprisal to the inspector general for the appropriate federal agency (in most cases, the U.S. Department of Education).
- **L. Use of Funds:** The grantee agrees to comply with the applicable federal cost principles in the obligation and expenditure of ARRA funds as identified in the General Provisions and Assurances as well as other limitations or restrictions and expenditures identified therein. The grantee also agrees to the following:
- Consolidation of ARRA Administrative Funds: Due to the significant reporting requirements under ARRA, it is
 not known at this time whether grantees may consolidate ARRA administrative funds with other NCLB
 consolidated administrative funds. TEA will issue further guidance with regard to this provision once guidance is
 provided by the U.S. Department of Education. If ARRA funds are permitted to be consolidated with other NCLB
 consolidated administrative funds, grantees must still be able to report the types and number of jobs that were
 created or saved with ARRA funds.
- 2. Combining ARRA funds on a Schoolwide Program. ARRA funds are permitted to be used on a Title I Part A schoolwide Campus/Program, funds may be combined with other funding sources, but grantees still must be able to identify precisely the items of obligation and expenditure for ARRA reporting. You must also be able to report the types and number of jobs that were created or saved with ARRA funds.
- 3. **Special Contracting Provisions**: To the maximum extent possible, contracts funded under the ARRA shall be awarded as fixed-price contracts through the use of competitive procedures. A summary of any new contract awarded with ARRA funds that is not fixed-price and not awarded using competitive procedures shall be posted in a special section of the www.recovery.gov website established by the Recovery Accountability and Transparency Board (Section 1554).

- 4. **Use of Funds for Certain Expenditures Prohibited:** ARRA funds shall not be used for any casino or other gambling establishment, aquarium, zoo, golf course, or swimming pool (Section 1604).
- 5. **Use of Funds for Construction Prohibited:** Unless specifically authorized in the applicable program statute, regulations, guidelines, Request for Application (RFA), TEA Standard Application System (SAS), the approved grant application, or other written authorization, none of the ARRA additional formula funds shall be used for construction, remodeling, or renovation.
- 6. **Buy American Use of American Iron, Steel, and Manufactured Goods:** If construction is allowed and approved pursuant to the previous paragraph pertaining to "Use of Funds for Construction Prohibited", none of the funds may be used for the construction, alteration, maintenance, or repair of a public building or public work unless all of the iron, steel, and manufactured goods used in the project are produced in the United States unless waived by the Secretary of Education (Section 1605).
- 7. Wage Rate Requirements for Contracted Laborers and Mechanics— Compliance with the Davis-Bacon Act: Subject to further clarification issued by the Office of Management and Budget, and notwithstanding any other provision of law and in a manner consistent with other provisions of ARRA, all laborers and mechanics employed by contractors and subcontractors on projects funded directly by or assisted in whole or in part by and through the Federal Government pursuant to this award shall be paid wages at rates not less than those prevailing on projects of a character similar in the locality as determined by the Secretary of Labor in accordance with subchapter IV of chapter 31 of title 40, United States Code. With respect to the labor standards specified in this section, the Secretary of Labor shall have the authority and functions set forth in Reorganization Plan Numbered 14 of 1950 (64 Stat. 1267; 5 U.S.C. App.) and section 3145 of title 40, United States Code (Section 1606).
- M. Compliance with OMB Circular A-133 Audits and Schedule of Expenditures of Federal Awards: Grantees agree to separately identify the expenditures for each grant award funded under ARRA as required by Office of Management and Budget Circular A-133, "Audits of States, Local Governments, and Non-Profit Organizations" and to comply with all other provisions of the Single Audit Act and OMB Circular A-133.
