Reading Instrument Reimbursement Information For Texas Public Schools and Charter Schools Kindergarten through 2nd Grade

Texas public schools and charter schools may choose any instrument listed on the current *Commissioner's List of Reading Instruments for Texas Public Schools and Charter Schools.* All instruments are on a 4-year cycle, and once an assessment is ordered, the school will only be reimbursed once every 4 years.

- ❖ To order TPRI and/or Tejas LEE, you may access the site at <u>www.tpriandtjl.com</u> and disregard further instructions stated below. All directions for TPRI and Tejas LEE will be inclusive on the referenced site.
- ❖ To order instruments other than TPRI and Tejas LEE, school districts and charter schools should choose from the current approved Commissioner's List, and follow the steps below to receive their cost cap reimbursement (\$5 per student once every 4 years). School districts must use a complete option from the current Commissioner's List to be reimbursed. In other words, if an option contains more than one assessment instrument, the district must administer all of the tests to ensure that all reading domains are evaluated.

STEP 1: Select an instrument from the current *Commissioner's List of Reading Instruments for Texas Public Schools and Charter Schools.*

STEP 2: Contact the vendor directly and order selected instruments for K-2. Please do not ask the publisher to send the invoice to the Texas Education Agency (TEA). TEA will NOT pay the publisher directly. Vendors should send the invoice to your school directly. NOTE: If a district uses their Instructional Materials Allotment (IMA) to pay for the K-2 kits then the reimbursement will need to be credited to the district's IMA account.

STEP 3: In order to receive the reimbursement from TEA, the district must provide a copy of the **PAID** invoice from the publisher. Complete the Reimbursement Form for Reading Instruments Other Than TPRI/Tejas LEE and secure appropriate signature(s). (Form included with this document.).

STEP 5: Once the completed information has been received in our office, you will receive an email confirmation that your request for reimbursement has been received.

STEP 6: Reimbursements will be sent directly to districts. **NOTE:** If the district used their instructional materials allotment (IMA) to purchase Kindergarten – Grade 2 Reading Instruments and it is determined the district is eligible for ERI reimbursement, the ERI reimbursement must be used to reimburse the district's IMA account.
