2. Approval of Consent Agenda

(1) Approval of Nominees to Recommend to the Governor for Service on the Board of Trustees of the Teacher Retirement System of Texas

The board approved four nominees, Rolyne L. Kafka, Yolanda Cuellar, David Corpus, and Jamie De'Sean Grant, to be submitted to the governor for consideration of one appointment to the board of trustees of the Teacher Retirement System of Texas for a term expiring on Aug. 31, 2019.

10. Per Capita Apportionment Rate for the 2012-2013 School Year (Moved to Consent Agenda)

The board approved an increase in the per capita apportionment rate from \$448.148 to \$469.215. This increase is possible because of the passage of Senate Bill (SB) 559 by the 83rd Texas Legislature, 2013, which repealed legislation of the 82nd Texas Legislature, First Called Session, 2011, that would have required the comptroller to delay the scheduled monthly July and August transfers of certain tax monies into the Available School Fund for the 2012-2013 fiscal year until September of the following fiscal year. This change makes more money available for distribution.

11. Review of Proposed Repeal of 19 TAC Chapter 231, <u>Assignment of Public School</u> <u>Personnel</u>, and Proposed New 19 TAC Chapter 231, <u>Requirements for Public School</u> <u>Personnel Assignments</u>

The board took no action on the review of the State Board for Educator Certification (SBEC) rule actions that repeal 19 TAC Chapter 231, <u>Assignment of Public School Personnel</u>, and establish new 19 TAC Chapter 231, <u>Requirements for Public School Personnel Assignments</u>. The rule actions are necessary due to the reorganization of the assignment chart codified in current 19 TAC Chapter 231. The new 19 TAC Chapter 231 updates and clarifies the assignments for public school personnel to enable school districts, teacher organizations, and human resource organizations to better understand the appropriate assignments of public school personnel.
