## Approval of Costs of Administering the 2013-2014 State of Texas Assessments of Academic Readiness (STAAR¬) and the Exit-Level Texas Assessment of Knowledge and Skills (TAKS) to Private School Students (Committee on School Finance/Permanent School Fund)

The Board approved the per-student cost to private schools for administering the State of Texas Assessments of Academic Readiness (STAAR) and the exit-level Texas Assessment of Knowledge and Skills (TAKS) for the 2013-14 school year. The costs for the STAAR general assessments range from a low of \$3.25 for the Grade 5 English or Spanish Science to a high of \$18.25 for the English I or English II End of Course exams. The cost may not exceed the cost of administering the same assessment to a student enrolled in a public school district.

The board also approved an agreement with Tristan Capital Partners, L.L.P. to invest €60 million in European Property Investors Special Opportunities 3, L.P. and the relationship between Tristan and Lazard Frares & Co., LLC, and a waiver of the PSF Real Estate Investment Policy Statement requirement for Tristan to be a registered invest-ment advisor with the Securities and Exchange Commission.

# 3. Proposed Amendment to 19 TAC Chapter 126, <u>Texas Essential Knowledge and Skills for</u> <u>Technology Applications</u>, Subchapter C, <u>High School</u>, §126.37, <u>Discrete Mathematics (One-Half to</u> <u>One Credit)</u>, <u>Beginning with School Year 2012-2013</u> (Second Reading and Final Adoption)

The board approved for second reading and final adoption amendments that would change the title of the technology applications discrete mathematics course to Discrete Mathematics for Computer Science in order to distinguish between two discrete mathematics courses.

# 4. Proposed Amendments to 19 TAC Chapter 74, <u>Curriculum Requirements</u>, Subchapter F, <u>Graduation Requirements</u>, <u>Beginning with School Year 2007</u>-2008, and Subchapter G, <u>Graduation Requirements</u>, <u>Beginning with School Year 2012-2013</u> (Second Reading and Final Adoption)

The board approved for second reading and final adoption proposed amendments to 19 TAC Chapter 74, Curriculum Requirements, Subchapter F, Graduation Requirements, Beginning with School Year 2007-2008, and Subchapter G, Graduation Requirements, Beginning with School Year 2012-2013. The amendments added course options for students to satisfy the fourth mathematics and the fourth science credit requirements under the Recommended High School Program and the Distinguished Achievement Program. The board did reverse an earlier decision and eliminated the Veterinary Medical Applications course as a course that could satisfy the fourth science credit requirement.

#### 5. Proposed Revisions to 19 TAC Chapter 74, <u>Curriculum Requirements</u>, Subchapter B, <u>Graduation</u> <u>Requirements</u> (First Reading and Filing Authorization)

After extensive debate, the board approved 19 TAC Chapter 74, Curriculum Requirements, Subchapter B, Graduation Requirements, as amended for first reading and filing authorization. These rules detail the requirements and options available under the state's new foundation high school graduation program, as

required by House Bill (HB) 5, 83rd Texas Legislature, Regular Session, 2013. The rule, as approved in November, is expected to be filed with the Texas Register in December. Final approval of the rules is expected on Jan. 31.

## 6. Report and Recommendations from the Commissioner of Education Regarding Instructional Materials Offered for Adoption under Proclamation 2014

The board approved more than 400 new instructional material products for science, grades K-12; mathematics, grades K-8; and Technology Applications. One biology textbook in which alleged errors are in dispute will go through a mediation process to determine whether there are in fact mistakes. If mistakes are identified and the publisher updates the material, the book will be approved. If mistakes are identified and the publisher is unwilling to change them in this textbook, then the publisher may either withdraw the book or the State Board will take action to reject it at the January board meeting. The new material approved under Proclamation 2014 will be available for use in Texas public schools beginning in the 2014-2015 school year.

# 8. Amendments to Proclamation 2015 of the State Board of Education Advertising for Bids on Instructional Materials

Proclamation 2015 advertises for bids on new instructional materials to be used by school districts and open-enrollment charter schools beginning in school year 2015-2016. The subjects and grade levels included in Proclamation 2015 are social studies, grades K-12; mathematics, grades 9-12; fine arts; three Career and Technical Education (CTE) courses for which students may receive mathematics credit; one Technology Applications course for which students may receive mathematics credit; and one CTE course for which students may receive fine arts credit. The board approved amendments, such as clarifying the accessibility standards that must be followed when producing electronic instructional materials.

# 11. Proposed Amendment to 19 TAC Chapter 33, <u>Statement of Investment Objectives, Policies, and</u> <u>Guidelines of the Texas Permanent School Fund</u>, §33.65, <u>Bond Guarantee Program</u> (Second Reading and Final Adoption)

The board approved the amendment to the Statement of Investment Objectives, Policies, and Guidelines of the Texas Permanent School Fund, Bond Guarantee Program, that updates the rule to refer to the recently implemented online application for the guarantee administered through the website of the Municipal Advisory Council (MAC) of Texas. The amendment also provides for a lower application fee of \$1,500 that was better aligned with the current cost of administering the Fund's Bond Guarantee Program. In addition, the amendment provides for clarity and adds language explaining how the commissioner determines and applies the limitation on approval for the guarantee related to districts' annual debt service per student in average daily attendance. The amendment also modifies the rule's financial exigency provisions to align with those in 19 TAC ñ109.2001, Financial Exigency. The board added another amendment that requires the commissioner to revoke approval for the guarantee if the commissioner determines an applicant deliberately misrepresented information to secure the guarantee. An additional amendment permits the commissioner to extend the specified 180-day approval period based on extraordinary circumstances on receiving a written report from the district before the expiration of the 180-day period while waiting for approval from the attorney general's office.

# 12. Proposed New 19 TAC Chapter 33, <u>Statement of Investment Objectives</u>, <u>Policies</u>, <u>and Guidelines</u> <u>of the Texas Permanent School Fund</u>, §33.67, <u>Bond Guarantee Program for Charter Schools</u> (First Reading and Filing Authorization)

The board approved for first reading and filing authorization new rules, as amended, for the Bond Guarantee Program for Charter Schools. The new rule implements provisions of the Texas Education Code (TEC), Chapter 12, Subchapter D, and Chapter 45, Subchapter C, that were added by Senate Bill (SB) 1, Article 59, 82nd Texas Legislature, First Called Session, 2011, and amended by House Bill (HB) 885, 83rd Texas Legislature, Regular Session, 2013. These provisions expand the Permanent School Fund Bond Guarantee Program to allow for guarantee of bonds issued for the benefit of open-enrollment charter schools.

# 13. Review of Proposed Amendments to 19 TAC Chapter 249, <u>Disciplinary Proceedings, Sanctions,</u> <u>and Contested Cases</u>, Subchapter A, <u>General Provisions</u>, and Subchapter B, <u>Enforcement Actions</u> <u>and Guidelines</u>

The board took no action on amendments to the State Board for Educator Certification (SBEC) rules dealing with enforcement actions and guidelines on decision-making guidelines. The amendments incorporate parts of the SBEC disciplinary policy guidelines into rule. The SBOE may only veto or take no action on an SBEC item. Taking no action is tantamount to approving the rule.

# 14. Review of Proposed Amendment to 19 TAC Chapter 233, <u>Categories of Classroom Teaching</u> <u>Certificates</u>, §233.14, <u>Career and Technical Education</u> (<u>Certificates requiring experience and</u> <u>preparation in a skill area</u>)

The board took no action on the SBEC rule amending the Categories of Classroom Teaching Certificates for Career and Technical Education (Certificates requiring experience and preparation in a skill area). The amendment is necessary as a result of House Bill (HB) 3573, 83rd Texas Legislature, Regular Session, 2013, which limits the requirements that can be imposed by the SBEC for obtaining a certificate to teach a health science technology education course. The amendment states the board cannot require anything higher than an associates degrees to obtain the certificate and aligns the requirements to conform with the limits set by HB 3573. The SBOE may only veto or take no action on an SBEC item. Taking no action is tantamount to approving the rule.

# 15. Review of Proposed New 19 TAC Chapter 230, <u>Professional Educator Preparation and</u> <u>Certification</u>, Subchapter B, <u>General Certification Requirements</u>, §230.15, <u>Certification of</u> <u>Military Service Members</u>, <u>Military Spouses</u>, and <u>Military Veterans</u>, and Proposed New 19 TAC Chapter 232, <u>General Certification Provisions</u>, Subchapter A, <u>Certificate Renewal</u> and <u>Continuing</u> <u>Professional Education Requirements</u>, §232.27, <u>Renewal</u> and <u>Continuing Education Requirements</u> for <u>Military Service Members</u>

The board took no action on the amendments to the SBEC rules expediting the certification process for out-of-state applicants for teacher certification who are military service members, military spouses, and military veterans.

The new sections are necessary as a result of Senate Bill (SB) 162, 83rd Texas Legislature, Regular Session, 2013, which requires all state licensing agencies to adopt rules that implement the requirements of the Texas Occupations Code, Chapter 55, regarding the licensing of military service members, military spouses, and military veterans. The amendment establishes the requirements to conform with SB 162. The SBOE may only veto or take no action on an SBEC item. Taking no action is tantamount to approving the rule.

## 16. Review of the Commissioner of Education's Generation 18 Charter Proposals

The board reviewed and took no action on two of four Generation 18 open-enrollment charter applicants selected by the Commissioner of Education to receive a charter and begin operation in the 2014-15 school year. Both the El Paso Leadership Academy and the Magnolia Montessori for All and the Red Montessori for All applications were considered and because no action was taken, the two applicants will be awarded charters once all final contingencies are passed.

A motion to veto the commissioner's selection of Carpe Diem Schools - San Antonio failed on a 6-8 vote and the school will be awarded a charter once all contingencies are passed.

A motion to veto the Great Hearts Academies Dallas passed on a 9-6 vote and the school was rejected from receiving a charter contract.
