STATE BOARD OF EDUCATION Summary of Action Items November 18, 2016

The State Board of Education met in Austin on November 18, 2016 and took the following actions.

Student Performance

1. Resolutions and Presentations

The board approved a resolution honoring winners of the 2016 National History Day contest. The winners were Denisse Cordova of Aldine Independent School District (ISD); Harper Hoover of Waco ISD; John Leeds and Evan Weldon of Austin; and Benjamin Warford-Johnston, Priscila Garcia, Danielle Garcia and Tomas de la Rosa, all of Goose Creek Consolidated ISD.

The board approved resolutions honoring departing State Board of Education members Martha Dominguez of El Paso and Thomas Ratliff of Mount Pleasant.

2. Approval of Consent Agenda

Any agenda item may be placed on the Consent Agenda by any State Board of Education committee.

(1) Selection Process for the Long-Range Plan Steering Committee and Authorization to Explore Funding Options and Craft a Request for Qualifications (Committee of the Full Board)

This board approved a long-range planning process that creates an 18-member steering committee on which five board members will serve. Those members will select 10 additional steering committee members from 30 people nominated by the remaining 10 board members. One representative from the Texas Education Agency, the Texas Higher Education Coordinating Board and the Texas Workforce Commission will also be appointed to the steering committee. The board authorized board members to explore funding options for the project, authorized board member Marty Rowley to work with staff to draft a Request for Qualifications (RFQ) for a project facilitator; and authorized the commissioner or his designee to execute any funding documents.

(2) Approval of Costs to Administer the 2016-2017 State-Developed Assessments to Private School Students (Committee on School Finance/Permanent School Fund)

Texas Education Code, §39.033, allows a private school to voluntarily assess its students with the State of Texas Assessments of Academic Readiness (STAAR) and the Texas English Language Proficiency Assessment System (TELPAS) assessments. The board in November approved the per-student cost to private schools, which may not exceed the cost of administering the same assessment to a student enrolled in a public school district. The costs, which vary by test, range from \$3.74 to \$16.90 per test for the 2016-2017 school year. Twenty-seven private schools administered state tests during the 2015-2016 school year.

(3) Ratification of the Purchases and Sales of the Investment Portfolio of the Permanent School Fund for the Months of August and September 2016 (Committee on School Finance/Permanent School Fund)

The board ratified the purchase and sales of investments executed in the portfolio of the Permanent School Fund for the months of August and September 2016 in the amounts of \$841,579,353 and \$726,730,498, respectively.

The board voted to execute agreements with Manageco, IX, L.L.C. as general partner, necessary to make an investment commitment of up to \$75 million in DRA Growth and Income Fund IX, L.L.C, subject to continued due diligence and negotiation of fund terms, and authorization for contract execution by the commissioner of education. Board member Geraldine Miller recused herself on this matter.

(9) Approval of 2017-2021 Rule Review Plan for State Board of Education Rules (Committee on School Initiatives)

The board approved the 2017-2021 Rule Review Plan for State Board of Education (SBOE) Rules. Texas Government Code, §2001.039, requires an ongoing four-year rule review of existing state agency rules, including SBOE rules. The rule review

requirement in §2001.039 is designed to ensure that the reason for initially adopting or readopting a rule continues to exist.

3. Decision on the Percentage Distribution of the Permanent School Fund

The board voted to set a 3.7 percent distribution rate to the Available School Fund from the Permanent School Fund for the 2018-2019 biennium. This will generate \$2.46 billion over the two-year period.

5. Proclamation 2018 of the State Board of Education Advertising for Bids for Instructional Materials

The board agreed to issue Proclamation 2018, calling for instructional material for Special Topics in Social Studies to be submitted. The board noted that this broad course title covers courses such as Mexican-American studies, African-American studies, Asian-American studies and Native American studies. Materials approved under this proclamation would be available for use in Texas classrooms, beginning in fall 2018.

The board did not approve seven CTE submissions, as well as a textbook submitted for use in a Special Topics in Social Studies course known as Mexican American studies.

9. Proposed Amendment to 19 TAC Chapter 89, <u>Adaptations for Special Populations</u>, Subchapter C, <u>Texas Certificate of High School Equivalency</u>, §89.42, <u>Official Testing</u> Centers

The board approved for second reading and final adoption proposed amendment to 19 TAC Chapter 89, <u>Adaptations for Special Populations</u>, Subchapter C, <u>Texas Certificate of High School Equivalency</u>, §89.42, <u>Official Testing Centers</u>. The approved amendment would expand the entities eligible to serve as official paper-based testing centers and define the requirements for paper-based testing centers.

In response to a petition to amend 19 TAC Chapter 130, <u>Texas Essential Knowledge and Skills for Career and Technical Education</u>, Subchapter J, <u>Human Services</u>, §130.283, <u>Cosmetology I (Two Credits)</u>, <u>Adopted 2015</u>, and §130.284, <u>Cosmetology II (Two Credits)</u>, <u>Adopted 2015</u>, the board agreed to initiate rulemaking to adopt additional one-credit lab-based courses to be taught concurrently with the two-credit Cosmetology I and II courses for implementation in the 2018-2019 school year.

12. Proposed Amendment to 19 TAC Chapter 33, <u>Statement of Investment Objectives</u>, <u>Policies</u>, and <u>Guidelines of the Texas Permanent School Fund</u>, Subchapter A, <u>State Board of Education Rules</u>, §33.65, <u>Bond Guarantee Program for School Districts</u> (First Reading and Filing Authorization)

The board approved for first reading and filing authorization proposed amendment to 19 TAC Chapter 33, Statement of Investment Objectives, Policies, and Guidelines of the Texas Permanent School Fund, Subchapter A, State Board of Education Rules, §33.65, Bond Guarantee Program for School Districts. The proposed amendment increases the multiplier used in calculating the capacity of the Permanent School Fund (PSF). If given final approval at the next meeting on Feb. 3, this action will provide an estimated \$249 million more in bonding capacity for charter schools as of March 2017 and approximately an additional \$317 million in capacity as of Sept. 1, 2017.

Proposed Amendment to 19 TAC Chapter 33, <u>Statement of Investment Objectives</u>, <u>Policies</u>, and <u>Guidelines of the Texas Permanent School Fund</u>, Subchapter A, <u>State Board of Education Rules</u>, §33.67, <u>Bond Guarantee Program for Charter Schools</u> (First Reading and Filing Authorization)

The board took no action on this item, which proposed adding language to require charter schools accessing the Permanent School Fund (PSF) Bond Guarantee Program (BGP) to have attained a certain level of student academic proficiency and would specify how applications will be prioritized if the available capacity is insufficient to guarantee the total value of the bonds for all applicant charter districts.

COMMITTEE ON SCHOOL INITIATIVES

14. Review of Proposed Revisions to 19 TAC Chapter 230, <u>Professional Educator Preparation and Certification</u>, Subchapter A, <u>General Provisions</u>; Subchapter B, <u>General Certification Requirements</u>; Subchapter D, <u>Types and Classes of Certificates Issued</u>; Subchapter E, <u>Educational Aide Certificate</u>; Subchapter F, <u>Permits</u>; Subchapter G, <u>Certificate Issuance Procedures</u>; and Subchapter H, <u>Texas Educator Certificates Based on Certification and College Credentials from Other States or Territories of the United States</u>

The board took no action on this item. Under Texas law, the State Board of Education may only reject or take no action on a proposed State Board for Educator Certification rule.

This rule establishes a two-tiered certification for individuals who are in alternative certification programs with an intern and probationary certificate effective Sept. 1, 2017. The rule also limits emergency permits for most areas to one year.

15. Review of Proposed Revisions to 19 TAC Chapter 228, Requirements for Educator Preparation Programs

The board took no action on this item. Under Texas law, the State Board of Education may only reject or take no action on a proposed State Board for Educator Certification rule.

This item:

- increases the rigor of requirements to be a field supervisor or cooperating teacher or mentor;
- increases the minimum number of coursework hours and specific components of coursework to be completed before student teaching or serving in an internship from 80 to 150 hours;

- increases the length of clinical teaching from 12 to 14 weeks;
- increases the number of observations for an intern from three to five; and
- requires at least one in-person observation for candidates pursing principal, counselor, librarian, superintendent or other non-teacher certifications.

16. Review of Proposed Revisions to 19 TAC Chapter 229, <u>Accountability System for</u> Educator Preparation Programs

The board took no action on this item. Under Texas law, the State Board of Education may only reject or take no action on a proposed State Board for Educator Certification rule.

The revisions to Chapter 229 establish a more accurate and transparent certification exam performance standard to better differentiate program performance as part of the accountability system for educator preparation. It also sets performance standards and a phase-in schedule for other statutorily required performance indicators and adds a fee to cover the cost of administering the statutorily required accreditation system, annual performance information, and consumer information requirements for preparation programs.

Review of Proposed Revisions to 19 TAC Chapter 231, <u>Requirements for Public School Personnel Assignments</u>, Subchapter D, <u>Electives, Disciplinary Courses, Local Credit Courses</u>, and <u>Innovative Courses</u>, <u>Grades 6-12 Assignments</u>, Subchapter E, <u>Grades 9-12 Assignments</u>, and <u>Subchapter F</u>, <u>Special Education-Related Services Personnel Assignments</u>

The board took no action on this item. Under Texas law, the State Board of Education may only reject or take no action on a proposed State Board for Educator Certification rule.

This rule identifies the appropriate credential for placement in a particular teaching assignment, incorporates courses approved by the State Board of Education (SBOE), and provide guidance to districts on special education assignments.

18. Review of Proposed Amendments to 19 TAC Chapter 233, <u>Categories of Classroom Teaching Certificates</u>

The board took no action on this item. Under Texas law, the State Board of Education may only reject or take no action on a proposed State Board for Educator Certification rule.

This rule updates the list of courses eligible to be taught with certain certificates, identifies any additional requirements to obtain certification, provides guidance to districts on special education assignments, and establishes a new Dance: Grades 6-12 certificate.

19. Review of Proposed Amendments to 19 TAC Chapter 247, Educators' Code of Ethics

The board took no action on this item. Under Texas law, the State Board of Education may only reject or take no action on a proposed State Board for Educator Certification rule.

The amendment to 19 TAC §247.2 would implement the Every Student Succeeds Act (ESSA) to prohibit school employees from assisting other schools employees from obtaining new jobs if the individual knows or has probable cause to believe that the individual has engaged in sexual misconduct regarding a minor or student. It also makes it a violation of the Educators' Code of Ethics for an educator to be intoxicated on school property or during school activities when students are present.

Review of Proposed Amendments to 19 TAC Chapter 249, <u>Disciplinary Proceedings</u>, <u>Sanctions</u>, and <u>Contested Cases</u>, Subchapter B, <u>Enforcement Actions and Guidelines</u>, §249.14, <u>Complaint</u>, <u>Required Reporting</u>, and <u>Investigation</u>; <u>Investigative Notice</u>; <u>Filing of Petition</u>; and §249.17, <u>Decision-Making Guidelines</u>

The board took no action on this item. Under Texas law, the State Board of Education may only reject or take no action on a proposed State Board for Educator Certification rule.

This item would conform the rule on superintendent reporting to SBEC to reflect changes required by House Bill (HB) 1783, 84th Texas Legislature, Regular Session, 2015. The amendments to 19 TAC §249.14(h) clarifies that inappropriate communications with a student and inappropriate educator-student relationships and boundaries to the behaviors by an educator toward students qualify as "Priority 1" conduct for purposes of investigation priority, investigative notices, and sanction authority. The amendment to 19 TAC §249.17 creates a mandatory minimum sanction for an educator who tests positive for, possesses, or is under the influence of drugs or alcohol on campus. Additionally, the amendment requires permanent revocation for an educator who injures a student but is not immune from disciplinary action.
