Components of the 2016 Texas Assessment Program

- State of Texas Assessments of Academic Readiness (STAAR)
- STAAR Alternate 2
- TAKS (exit level)
- Texas English Language Proficiency Assessment System (TELPAS)

Answer Documents

- STAAR and STAAR Spanish — one combined answer document
- STAAR with embedded supports, incl. braille – if approved TEA

Answer Documents (continued)

- STAAR Score Codes
 - “S” – tested
 - “A” – absent
 - “O” – other (illness, testing irregularity, EOC/above grade level, substitute assessment, etc.)
 - “*” – paper/online combination within the same administration

NOTE: For each subject area, only ONE score code should be gridded.

STAAR Scoring and Reporting

Answer Documents (continued)

- An “*” score code is present on all STAAR answer documents that have two subject areas tested.
- TEST TAKEN INFO field — information about the language version (English or Spanish) must be recorded in this field.
 - “EN” or “SP” for grades 3, 4, and 5
- NEW TO TEXAS - §101.3014. Scoring and Reporting.
 - (f) A school district, charter school, or private school that administers criterion-referenced tests under the TEC, Chapter 39, Subchapter B, shall accurately report to the Texas Education Agency (TEA) whether that student transferred into the school or district from out of state during the current school year.

STAAR Standard Reports

- Confidential Student Report (CSR)
- Confidential Student Label
- Confidential Campus Roster
- Campus and District Summary Report—
including combined and cumulative (grades 5 & 8 retests) summary reports
- Data File – individual student data file
- Item Analysis Summary and Individual Reports
- Images of Essays

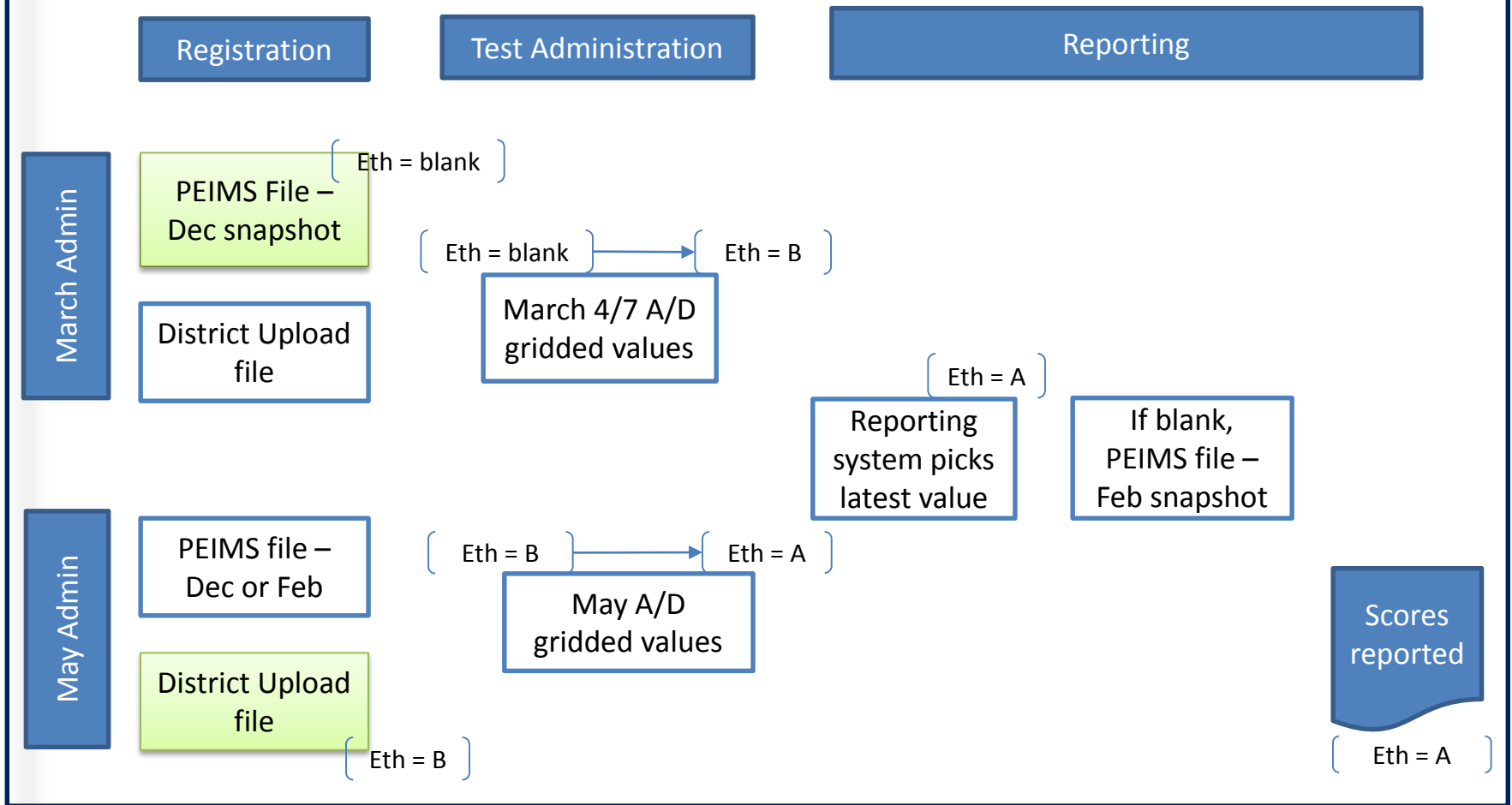
STAAR Additional Reports

- CSRs – extra copy, spring only
- Labels – extra copy, all administrations
- Confidential Campus Rosters – no paper
- Summary Reports – no paper

Redesigned CSR

- Four page report
- Letter from the Commissioner
- New performance labels
- Cumulative history
- Percentiles
- Growth charts – grades 3-8 only
- Lexiles – grades 3-8 only
- Resources for parents

- Request rescores in the STAAR Assessment Management System

Timelines

- Weekly CSRs (updates) posted every Thursday
 - Submit changes by Friday to include in weekly CSRs
- Monthly data file (cumulative) posted 7th of the month
 - Includes all changes up to and including the last weekly CSR prior to the monthly file
- Rescores
 - Processed and results updated (if applicable) within 30 days
- Service requests
 - Processed and results updated within 30 days
