### What's New in Performance Reporting

### **A-F** Development

All campuses serving prekindergarten (PK) through grade 12 must receive an accountability rating. Campuses that do not serve any grade level for which STAAR assessments are administered are paired with another campus in the same district for accountability purposes. Campuses that are paired should have a "feeder" relationship and should serve students in contiguous grades. For example, a kindergarten (K) through grade 2 campus should be paired with the campus that serves its students in grade 3.

A campus may be paired with its district instead of with another campus. This option is suggested for cases in which the campus has no clear relationship with another single campus in the district. A campus paired with its district will be evaluated using the district's assessment results (for all grades tested in the district). Note that pairing with a district is not required in these cases; districts may select another campus for pairing.

For 2018 accountability, a campus paired with its district will receive a Met Standard rating if its district receives an A, B, C, or D. If its district receives an F, the campus will be rated Improvement Required.

TEA has been fortunate to receive support from the Texas Comprehensive Center (TXCC) at the American Institutes for Research (AIR). The March 7 press release, "TEA submits final ESSA state plan to U.S. Department of Education", mentions shifting the proficiency level for students from Approaches Grade Level on STAAR to Meets Grade Level. Can you clarify whether the press release refers to a shift in the student-level passing standard or a shift to accountability?

The press release refers to an update in the accountability portion of the ESSA plan. The Academic Achievement indicator in the Closing the Gaps domain will evaluate disaggregated student performance at the Meets Grade Level standard.
