- 4. Advise TEA in developing corrective action plans to address findings identified in federal monitoring reports under Part B of the Act
- 5. Advise TEA in developing and implementing policies relating to the coordination of services for children with disabilities
- 6. Advise TEA in setting standards related to Significant Disproportionality Determination

The CAC is required to submit a report to the legislature biennially with recommended changes to state law and agency rules relating to special education. [Texas Education Code §29.006]
