Welcome and Opening - Teresa Bronsky, CAC Chair

Ms. Teresa Bronsky opened the meeting and reviewed meeting guidelines.

Review and approval of minutes from the April 3, 2018 meeting – Teresa Bronsky

Ms. Agatha Thibodeaux made a motion to accept minutes. Ms. Karen Beasley seconded. All approved. All in favor to accept minutes from April 3, 2018 meeting.

Discussion regarding recording meeting – Teresa Bronsky

Ms. Bronsky started the discussion regarding recording the CAC meetings. Ms. Jana Burns feels some of the openness in the meeting would be lost if meetings were recorded. Ms. Bronsky started a pros and cons list. Ms. Rachel Dreiling was in favor of recording meeting. She gave an example of how the Health and Human Services Committee (HHSC) Early Childhood Intervention (ECI) Advisory Committee records and livestreams their meetings. Ms. JoAnn Wofford asked about funding to record and transcribe meetings. Ms. Burns stated the meeting recordings would have to be transcribed in both English and Spanish. Translation from English to Spanish is 17 cents per word. Ms. Wofford expressed concern on spending time and funding on recordings. Ms. Dreiling suggested contacting the ECI Advisory Committee to investigate how they record and livestream their meetings.

- Ms. Burns will be investigating the cost to transcribe a recorded meeting and report back at the August 29th meeting.
- Ms. Beasley is going to investigate programs that translate from English to Spanish and report back at the August 29th meeting.
- Ms. Dreiling reported that the rooms at ESC 13 all have the capability to record audio and video.

Legislative Report Work Groups - Teresa Bronsky
