Foundation School Program Six-Week Attendance Reporting Crosswalk

The table is a crosswalk between select attendance line items of the Foundation School Program (FSP) Six-Week Report Detail and the Texas Student Data System (TSDS) Public Education Information Management System (PEIMS), Superintendent's Report of Student Attendance (PDM3-130-001). Charter administrators may use the crosswalk to ensure data from their local Student Information System (SIS) with line items that match a TSDS PDM3-130-001 report, is correctly entered into the FSP Six-Week Report Detail.

For example, sum the values for G.2 D1 – Eligible Days Bil Dual Language and G.3 D2 (EL) – Eligible Days Bilingual Dual Language to report the correct number of Bilingual LEP Dual Language Eligible Days in the FSP Six-Week Report Detail.
