9:15 Presentation from TEA Matt Montaño regarding Supplemental Education Services

Matt Montaño presented an Overview of Supplemental Special Education services. Students enrolled in the 2020-2021 school year are eligible to apply. The LEA outreach campaign has a goal of 18,000 accounts created by June 30th, 2021. TEA provides the name of students that qualify for the program.

- Will this open up to all kids with an IEP?
 - Only those in K-12
- Parents have expressed unwillingness because of the financial questions required in the application?
 - Difference of opinion on the issue is there, TEA has stated that they are trying to help families and are getting positive feed.
