Monica Martinez, associate commissioner, standards and support services, explained that an item related to dyslexia will be included in the agenda for the January/February 2018 meeting. At that time, the committee will have an opportunity to discuss possible revisions to its rules. Ms. Martinez also explained that TEA anticipates presenting the proposed repeal of older graduation requirements at a future meeting.

MOTION AND VOTE: It was moved by Mrs. Miller, seconded by Ms. Beltran, and carried unanimously to recommend that the State Board of Education adopt the review of 19 TAC Chapter 74, Curriculum Requirements, Subchapter A, Required Curriculum; Subchapter B, Graduation Requirements; Subchapter C, Other Provisions; Subchapter D, Graduation Requirements, Beginning with School Year 2001-2002; Subchapter E, Graduation Requirements, Beginning with School Year 2007-2008; and Subchapter G, Graduation Requirements, Beginning with School Year 2012-2013.

ACTION ITEMS

2. Proposed Repeal of 19 TAC Chapter 112, <u>Texas Essential Knowledge and Skills for Science</u>, Subchapter D, <u>Other Science Courses</u>, §112.71, <u>Principles of Technology (One Physics Credit)</u>, and §112.72, <u>Other Courses for Which Students May Receive Science Credit</u> (Second Reading and Final Adoption)

(Board agenda page II-21) [Official agenda item #8]

Shelly Ramos, senior director, curriculum standards and student support, explained this item would repeal rules that are outdated and no longer necessary. Ms. Ramos further explained that no public comments had been received.

MOTION AND VOTE: It was moved by Mrs. Miller, seconded by Ms. Bahorich, and carried unanimously to recommend that the State Board of Education, by an affirmative vote of two-thirds of the members of the board, approve for second reading and final adoption proposed repeal of 19 TAC Chapter 112, Texas Essential Knowledge and Skills for Science, Subchapter D, Other Science Courses, §112.71, Principles of Technology (One Physics Credit), and §112.72, Other Courses for Which Students May Receive Science Credit, with an effective date of 20 days after filing as adopted with the Texas Register.

3. Proposed Amendment to 19 TAC Chapter 130, <u>Texas Essential Knowledge and Skills for Career and Technical Education</u>, Subchapter C, <u>Arts, Audio/Video Technology, and Communications</u>, §130.121, <u>Extended Practicum in Fashion Design (Two to Three Credits)</u>, <u>Adopted 2015</u> (Second Reading and Final Adoption)

(Board agenda page II-35) [Official agenda item #9] Ms. Ramos explained that this item would correct an error in the number of credits for the Extended Practicum in Fashion Design course, which is inconsistent with other extended practicum courses.

MOTION AND VOTE: It was moved by Mrs. Miller, seconded by Mrs. Bahorich, and carried unanimously to recommend that the State Board of Education, by an affirmative vote of two-thirds of the members of the board, approve for second reading and final adoption proposed amendment to 19 TAC Chapter 130, Texas Essential Knowledge and Skills for Career and Technical Education, Subchapter C, Arts, Audio/Video Technology, and Communications, §130.121, Extended Practicum in Fashion Design (Two to Three Credits), Adopted 2015, with an effective date of 20 days after filing with the Texas Register.
