MOTION: It was moved by Mr. Rowley that the State Board of Education approve for second reading and final adoption proposed amendments to 19 TAC Chapter 112, <u>Texas Essential Knowledge and Skills for Science</u>, Subchapter A, <u>Elementary</u>, Subchapter B, <u>Middle School</u>, and Subchapter C, <u>High School</u>, as amended and recommended by the Committee of the Full Board.

MOTION AND VOTE: It was moved by Mr. Mercer and carried to amend \$\$112.11(a)(4), 112.12(a)(4), and 112.13(a)(4) to read:

"The study of elementary science includes planning and safely implementing classroom and outdoor descriptive (observational) investigations using scientific processes, including inquiry methods, analyzing information, making informed decisions, and using tools to collect and record information, while addressing the major concepts and vocabulary, in the context of physical, earth, and life sciences. Districts are encouraged to facilitate classroom and outdoor descriptive (observational) investigations for at least 60% of instructional time."

"identify, describe, and demonstrate safe and healthy practices as outlined in Texas Education Agency-approved safety standards during classroom and outdoor <u>descriptive (observational)</u> investigations, including wearing safety goggles or chemical splash goggles, as appropriate, washing hands, and using materials appropriately; and"

MOTION AND VOTE: It was moved by Mr. Mercer and carried to amend \$112.14(b)(2) and \$112.15(b)(2) to read:

"Scientific investigation and reasoning. The student uses scientific practices during laboratory and outdoor descriptive investigations. The student is expected to:"

MOTION AND VOTE: It was moved by Mr. Mercer and carried to amend \$112.13(a)(1)(B) to read:

"Within the physical environment, students expand their understanding of the properties of objects such as weight, temperature, and flexibility then use those properties to compare, classify, and then combine the objects to do something that they could not do before. Students manipulate objects to demonstrate a change in motion and position."

Mr. Cortez asked if the science experts could come and address the board on Mr. Rowley's motion. Two-thirds of the members of the board objected to having the science experts address the board.

MOTION AND VOTE: It was moved by Ms. Pérez and carried by an affirmative vote of twothirds of the members of the board that the State Board of Education take a 10-minute recess to consult with the science experts.

Identify changes that can occur in the physical properties of the ingredients of <u>solutions</u> mixtures such as creating solutions by dissolving salt in water or adding lemon juice to water."

The motion failed for lack of a second.

MOTION AND VOTE: It was moved by Mr. Rowley, seconded by Dr. Ellis, and carried to add an effective date of August 27, 2018 for proposed amendments to 19 TAC Chapter 112, <u>Texas</u> <u>Essential Knowledge and Skills for Science</u>, Subchapter A, <u>Elementary</u>, Subchapter B, <u>Middle</u> <u>School</u>, and Subchapter C, <u>High School</u>.
