The board approved a request from Texas State University to update content in two of its adopted products: Math Explorations I for grade 6 and Math Explorations II for grades 6-8. The updated content has been reviewed by curriculum subject-area specialists and determined to address the pertinent student expectations in a manner equal to the content initially reviewed and approved by the state review panel.

3. Proposed Amendments to 19 TAC Chapter 74, <u>Curriculum Requirements</u>, Subchapter B, <u>Graduation Requirements</u> (Second Reading and Final Adoption)

The board approved for second reading and final adoption proposed amendments to 19 TAC Chapter 74, Curriculum Requirements, Subchapter B, Graduation

Requirements, to update the rules and to align with recent legislative changes.

4. Proposed Amendments to Proclamation 2017 of the State Board of Education Advertising for Bids on Instructional Materials

The board approved amendments to Proclamation 2017 to incorporate approved revisions to 19 TAC Chapter 66, clarify requirements related to accessible instructional materials, and accurately reflect final action regarding career and technical education (CTE) courses. The subjects and courses included in Proclamation 2017 are CTE, languages other than English, Special Topics in Social Studies, Statistics, and Algebraic Reasoning. Materials adopted under this proclamation will be available for use in the schools beginning with the 2017-2018 school year.

10. Proposed Amendment to 19 TAC Chapter 74, <u>Curriculum Requirements</u>, Subchapter A, <u>Required Curriculum</u>, §74.5, <u>Academic Achievement Record (Transcript) and High School Diploma</u> (Second Reading and Final Adoption)

The board approved for second reading and final adoption proposed amendment to 19 TAC Chapter 74, Curriculum Requirements, Subchapter A, Required Curriculum, §74.5, Academic Achievement Record (Transcript) and High School Diploma, to update the rule to align with recent legislative changes. The changes delete the requirements that a high school diploma note when a student has earned endorsements, performance acknowledgments or a distinguished level of achievement. The academic achievement record will still list these accomplishments.

The board approved for second reading and final adoption proposed new 19 TAC Chapter 126, Texas Essential Knowledge and Skills for Technology Applications, Subchapter D, Other Technology Applications Courses, §126.65, Advanced Placement (AP) Computer Science Principles (One Credit), Adopted 2016. The changes add a new AP computer science course as an option for a student to use to earn credit toward high school graduation requirements.

ment, Subchapter B, High School, §127.16, Extended Career Preparation (One Credit), Adopted 2016. The rule adds the Texas Essential Knowledge and Skills for a new career preparation course to allow students to earn up to a total of three credits each in Career Preparation I and Career Preparation II. The new course would be implemented in the 2017-2018 school year.

The amendments update the rules related to the administration of high school equivalency examinations by multiple providers, including offering both paper-based and computer-based testing formats; accommodations for applicants with documented disabilities; court-ordered examinations; and fees and other provisions for the issuance of certificates.

Review of Proposed Amendments to 19 TAC Chapter 231, Requirements for Public School Personnel Assignments, Subchapter B, Prekindergarten-Grade 6 Assignments, Subchapter C, Grades 6-8 Assignments, Subchapter D, Electives, Disciplinary Courses, Local Credit Courses, and Innovative Courses, Grades 6-12 Assignments, and Subchapter E, Grades 9-12 Assignments

The board voted to take no action on the State Board for Educator Certification (SBEC) rule actions that amend 19 TAC Chapter 231, Requirements for Public School Personnel Assignments, Subchapter B, Prekindergarten-Grade 6 Assignments, Subchapter C, Grades 6-8 Assignments, Subchapter D, Electives, Disciplinary Courses, Local Credit Courses, and Innovative Courses, Grades 6-12 Assignments, and Subchapter E, Grades 9-12 Assignments. The amendments clarify the appropriate credential for placement in a particular teaching assignment and implement applicable requirements from the 84th Texas Legislature, Regular Session, 2015.

19. Review of Proposed Revisions to 19 TAC Chapter 233, <u>Categories of Classroom Teaching Certificates</u>

The new 19 TAC §233.17 establishes a new Junior Reserve Officer Training Corps: Grades 6-12 certificate.

The board voted to take no action on the amendments to the SBEC rules that amend 19 TAC §§249.5, 249.15, 249.17, and 249.35 to create more specific penalty guidelines for Texas Education Agency (TEA) staff to follow in settling or prosecuting educator discipline cases. In addition, the amendments set out the process that the SBEC will use when the State Office of Administrative Hearings (SOAH) dismisses and remands a case in accordance with Texas Government Code, §2001.058(d-1), as amended by House Bill (HB) 2154, 84th Texas Legislature, Regular Session, 2015, after a respondent fails to appear for a contested case hearing.
