1. Resolutions and Presentations

Resolution honoring the 2017 National Geographic Bee Winner

(1) Per Capita Apportionment Rate for the 2017-2018 School Year (Committee on School Finance/Permanent School Fund)

The State Board of Education approved a per capita apportionment rate of \$206.566 for the 2017-2018 school year.

The State Board of Education voted to execute an agreement with BREP Asia II, L.L.C., its general partner, necessary to make an investment of up to \$75 million in Blackstone Real Estate Partners Asia II, L.P., subject to continued due diligence and negotiation of fund terms, and authorized the commissioner of education to execute the contract.
