- **Jana Burns (Saginaw)** Stakeholder: McKinney-Vento Homeless Act representative. Jana Burns is the Assistant Director of Special Populations and the McKinney-Vento Homeless Act at Region 10 Education Service Center. Prior to the Education Service Center, she worked as teacher, coordinator, campus administrator, and Special Education Director in the Eagle Mountain – Saginaw Independent School District for over twenty-two years. Jana received her Bachelor of Business Administration from the University of North Texas; Master of Education from Texas Woman's University and completed the Superintendent Certification program at Tarleton State University.
- **Julia Erwin (Montgomery)** Stakeholder: Parent. Julia W. Erwin of Montgomery is a former sales representative for West Publishing Inc.
