It is mutually understood and agreed by and between the undersigned contracting parties of the above numbered Contract to amend said Contract effective January 25, 2017 as follows:

ARTICLE III. PURPOSE OF CONTRACT

The purpose of the Amendment is to allocate additional funds for the Human Resources Reporting System (HRRS), Budget Analysis Tool (BAT), and Time and Effort applications for the integration and/or enhancement with TCAPPS, test and deploy the changes.

ARTICLE IV. PAYMENT UNDER CONTRACT

The HRRS will be increased by \$150,000.00, and BAT will be increased by \$150,000.00. The contract total is increasing from \$1,645,858.00 to \$1,945,858.00.


Effective January 1, 2017, the mileage reimbursement rate is 53.5¢.
