Observation Reporting Guidance for EPPs

Effective 8/24/2018 - 9/15/2018 ONLY

Starting 8/24/2018, the necessary data for Observation records is changing slightly. This change does not affect any observations that are already entered for 2017-18. Programs do not need to edit observations that are already in ECOS. Observations for 2017-18 that are not uploaded into the system before 8/23/2018 at 6pm (Central Time) will need to contain the additional data elements described below. This change will affect the individual observation entry and the observation upload. For a full description of how to report observations after 8/23, see the 2018 Data Reporting Manual.

- Assignment Type
- Assignment End Date

For all observations reported starting 8/24/2018:

Use the end date for the assignment. This assignment end date cannot be more than 1 year after the assignment begin date.
