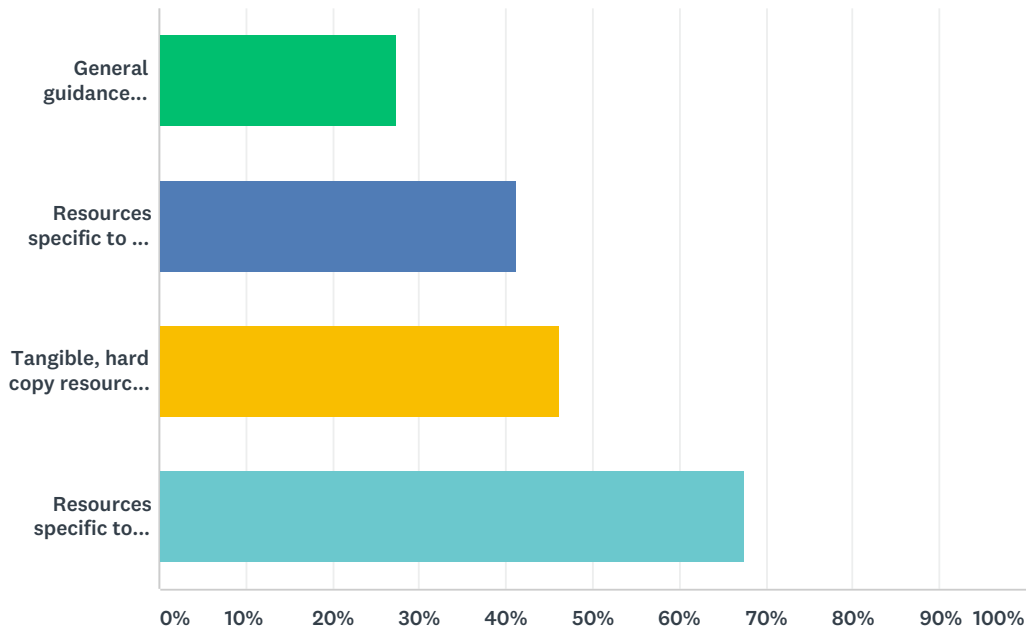

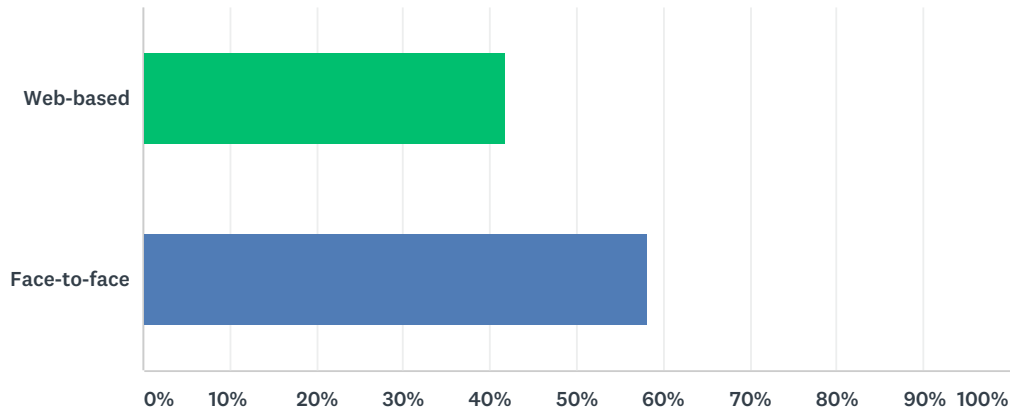

## Q2 What type of professional activities do you prefer? (choose one)

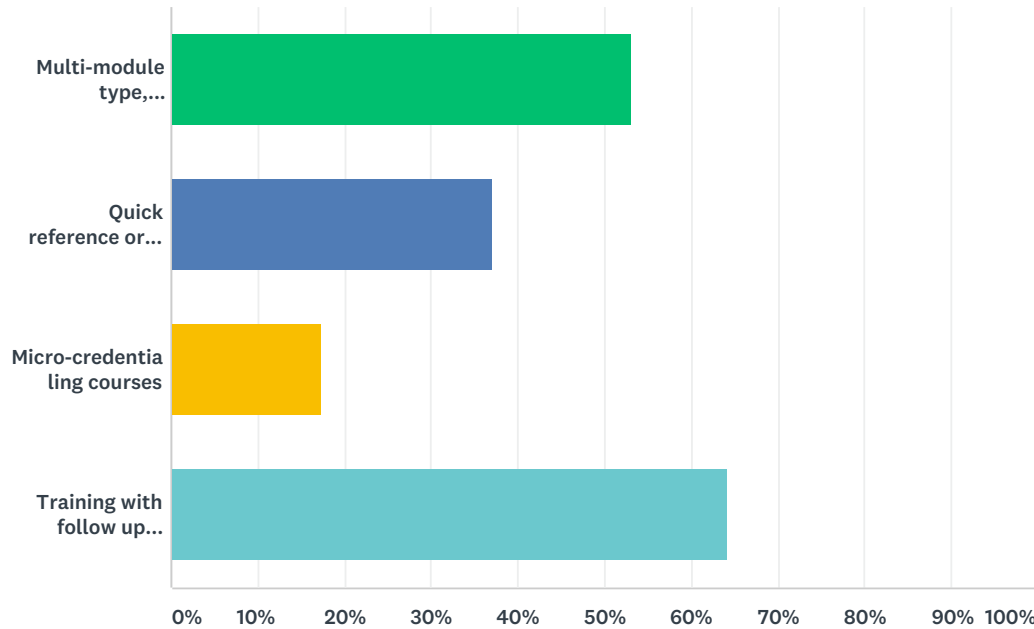

### Q3 What type of professional development opportunities in the area of intervention best practices would you find most helpful? (select up to two)

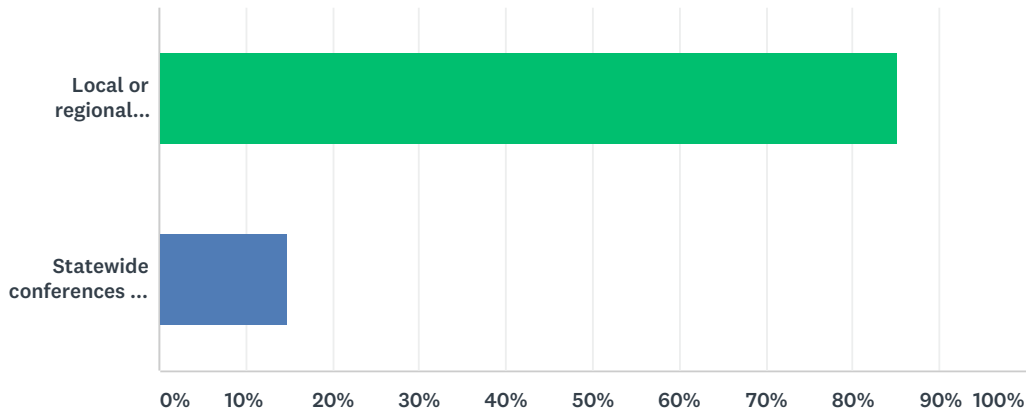
