Texas State Board of Education

The State Board of Education established the **Heroes for Children** award program in 1994. The award is designed to recognize excellence in advocacy for education and to spotlight the many outstanding volunteers whose efforts represent significant contributions to public school education in Texas.

Since its beginning, the award has provided a means to recognize Texas residents whose efforts have benefited the public schoolchildren of our state or who have, in the Board's judgment, been advocates for Texas schoolchildren. The award honors volunteers who have made outstanding contributions to student learning or who have demonstrated sustained periods of involvement and support of public education. Each year, the 15-member Board recognizes one **Hero** from each of their districts. The **Heroes** are honored each fall at a <u>ceremony</u> during a board meeting.

Nomination Guidelines

Who may be nominated?

An individual person --a resident of Texas --who gives time, effort, service, and support to public schools and students and who advocates for students and for public education in general in Texas

Who may **<u>NOT</u>** be nominated?

- An elected government office-holder, or an educational employee, such as a school employee or an education agency employee
- Organizations

Who may do the nominating?

An individual, a group of individuals, or an organization

What are the steps for making a nomination?

- ► Fill out the three-part application and send to TEA. Be sure the application includes all pertinent facts about the nominee, the nominee's permission to be nominated, an essay written by the nominee about his or her advocacy for Texas public education, and an essay from the person or group making the nomination about the **Hero for Children** nominee.
- This is an Adobe PDF form that may be digitally filled out with a current version of Acrobat Reader. Once the electronic form is completed, please either email or print and mail the completed form to the TEA. Please print a copy of the application as submitted applications will not be returned.

Other Guidelines?

- Application should be typed or computer printed. It should not be handwritten.
- Be sure to carefully read and follow the instructions on each part of the application.
- Determine which State Board of Education district the nominee <u>lives</u> in, and write the district number in the space provided on the application. To determine the State Board districts, go to: <u>www.fyi.legis.state.tx.us</u>, under "Find Your Incumbent," click on "By Address," then type in the home address of the nominee and find the State Board member's district number.
- Make sure the application is <u>completely filled out</u> and includes <u>all signatures</u> and <u>both essays</u>. If the application is incomplete, it will not be reviewed.
- Be sure to keep a copy of the application, submitted applications will not be returned.


