Ron Rowell, director, school governance, presented to the Committee on School Initiatives regarding adoption of 19 TAC Chapter 61regarding school districts and board of Trustees relationships

MOTION AND VOTE: It was moved by Mr. Cortez, seconded by Mr. Rowley, and carried unanimously, to recommend that the State Board of Education amend language in $\S61.1(b)(1)(A)$ to read as follows:

"Any Each sitting board member may attend or participate in the is also required to receive annual training on local district orientation. The local district orientation shall address local district practices in the following, in addition to topics chosen by the local district must include:"

<u>MOTION AND VOTE</u>: It was moved by Mr. Cortez, seconded by Mrs. Knight, and carried unanimously, to recommend that the State Board of Education amend $\S61.1(b)(1)(B)$ to strike the phrase, "and received within 60 days of re-election."

MOTION AND VOTE: It was moved by Mr. Cortez, seconded by Mr. Rowley, and carried unanimously, to recommend that the State Board of Education amend §61.1(b)(2) to add the sentence, "The session shall include a review of the roles, rights, and responsibilities of a local board as outlined in the framework for governance leadership."

MOTION AND VOTE: It was moved by Mr. Cortez, seconded by Mrs. Knight, and carried unanimously, to recommend that the State Board of Education amend §61.1(b)(3) to strike the phrase, "including governance training."

MOTION AND VOTE: It was moved by Mr. Cortez, seconded by Mrs. Knight, and carried unanimously, to recommend that the State Board of Education amend §61.1(b)(3)(B) to strike the proposed requirement for eight hours of continuing education and maintain the five-hour requirement.

MOTION AND VOTE: It was moved by Mr. Cortez, seconded by Mrs. Knight, and carried unanimously, to recommend that the State Board of Education amend §61.1(C)(j) to add the sentence, "The announcement shall state that completing the annual required continuing education is a basic obligation and expectation of any sitting board member under State Board of Education rule."

MOTION AND VOTE: It was moved by Mr. Cortez, seconded by Mrs. Cargill, and carried unanimously, to recommend that the State Board of Education amend §61.1(b)(1) to strike subparagraph (C) and add language to subparagraph (B) to read as follows:

"A newly elected or appointed board member of an independent school district shall receive the orientation to the TEC within the first 120 days of service. The orientation to the TEC shall be open to any sitting board member who chooses to attend."

MOTION AND VOTE: It was moved by Mrs. Knight, seconded by Mr. Rowley, and carried unanimously, to recommend that the State Board of Education approve for first reading and filing authorization the proposed amendment to 19 TAC Chapter 61, School Districts, Subchapter A, Board of Trustees Relationship, §61.1, Continuing Education for School Board Members, as amended and shown in Attachment A.

DISCUSSION ITEMS

7. Review of 19 TAC Chapter 61, <u>School Districts</u>, <u>Subchapter A</u>, <u>Board of Trustees Relationship</u> (Board agenda page IV-79)

The Texas Government Code, §2001.039, establishes a four-year rule review cycle for all state agency rules, including State Board of Education (SBOE) rules. Ron Rowell, director of school governance, presented this item, 19 TAC Chapter 61, <u>School Districts</u>, Subchapter A, <u>Board of Trustees Relationship</u>, as part of the four-year rule review process. The review is intended to ensure that the need for the rule still exists.

8. Long-Range Planning Efforts for Texas Public Schools

(Board agenda page IV-87)

The Committee on School Initiatives discussed whether to pursue a long-range planning effort for public education. Mrs. Bahorich asked Mr. Cortez and Mr. Rowley to discuss the issue further and come back with suggestions at the next meeting. Mr. Cortez suggested that they seek input from school administrators.

9. Discussion of Proposed Revisions to 19 TAC Chapter 100, <u>Charters</u>, Subchapter A, <u>Open-Enrollment Charter Schools</u>

Heather Mauzé, director, division of charter school administration, explained the need to amend board rules in 19 TAC Chapter 100, Charters, Subchapter A, Open-Enrollment Charter Schools to conform to new statutory language in Texas Education Code, §12.101.
