Item 7:

Consider and Take Appropriate Action on Passing Standards for Agriculture, Food, and Natural Resources, 6-12; Business and Finance, 6-12; Health Science, 6-12; and Marketing, 6-12

DISCUSSION AND ACTION

SUMMARY: This item provides the State Board for Educator Certification (SBEC) the opportunity to review and approve passing standards for four new Texas Examinations of Educator Standards (TExES): Agriculture, Food, and Natural Resources,6-12; Business and Finance, 6-12; Health Science, 6-12; and Marketing,6-12. These passing standards will allow test results to be calculated and reported to candidates taking these examinations during the 2015-2016 administration year and subsequent administrations. Candidates in preparation programs and educators pursuing a new area need to demonstrate content mastery in particular subject areas in order to qualify for their certificates. This item requests consideration for the SBEC to review and approve a new passing standard for the examinations as recommended by the standard-setting committees of educators.

STATUTORY AUTHORITY: Statutory authority for setting passing test standards is Texas Education Code §21.048(a) and §21.031(a) and Texas Administrative Code §230.21(e).

EFFECTIVE DATE: The passing standards will be effective after SBEC approval. The new examinations are scheduled to be administered for the first time on various dates during the 2015-2016 administration; but the earliest administration for any of these examinations is October 19, 2015. These passing standards will be applied to the first administration of these four new examinations and all future administrations.

PREVIOUS BOARD ACTION: None for these new tests.

BACKGROUND INFORMATION AND SIGNIFICANT ISSUES:

Changes in the Texas Essential Knowledge and Skills (TEKS) have prompted a need to revise the examinations currently in place. While the current examinations will be administered for one more year as part of the overlap policy, the revisions to the new grade-level tests require a new passing standard be established prior to the first test administration date(s).

Committees of stakeholders were recruited to recommend a passing standard for each of these new examinations. These passing standard recommendation committees met April 15-17, 2015. The recommended cut scores on the two test forms reviewed by each committee represent the total number of items needed to pass each form of the test. Representatives from TEA and ETS attended the meetings and agree that the recommended passing standards are reasonable.

FISCAL IMPACT: None.

PUBLIC AND STUDENT BENEFIT: Texas students, educators, and constituents will benefit by having highly qualified educators preparing students.

PROCEDURAL AND REPORTING IMPLICATIONS: The passing standard will allow test results to be calculated and reported to candidates taking the examinations after each administration.

ASSOCIATE COMMISSIONER'S RECOMMENDATION: I recommend that the State Board for Educator Certification:
