## SECTION ONE: INTRODUCTION AND PURPOSE

#### 1.1 PURPOSE OF THE REQUEST FOR QUALIFICATIONS (RFQ)

The Texas Education Agency (TEA) is seeking a qualified individual(s) or company to provide facilitation services for the Texas Continuous Improvement Process (TCIP) project.

The Texas Continuous Improvement Process is a permanent, annual process that the State uses to continuously identify areas for improvement strategies to improve the provision of special education in Texas. The State created this process based on a similar process used by the U.S. Department of Education's Office of Special Education Programs (OSEP) when they monitored Texas using the Continuous Improvement Monitoring Process. The TCIP has four major components:

#### • Self-Assessment

The State examines itself to determine how it is doing in the provision of Special Education through a Texas Steering Committee consisting of approximately twenty-five special education stakeholders (parents, teachers, administrators, etc.). The Steering Committee reviews data and current activities related to the twenty performance and compliance indicators in the State Performance Plan (SPP) / Annual Performance Report (APR). The Texas Steering Committee advises the State on performance indicators in the SPP/APR.

#### • Public Meetings

The Texas Education Agency and Education Service Centers conduct public meetings to provide the State with a different perspective on the special education system. The public meetings provide a qualitative view based on people input across the state. The information gathered during the public meetings is used for continuous improvement at the regional and state level.

#### Improvement Planning

Review data and statewide activities to understand what needs to be improved, them implementing actions to improve that part of the special education system. There are seven TCIP Improvement Groups that have a focus aligned to the indicators in the State Performance Plan. The improvement groups are comprised of approximately twenty-five special education stakeholders (parents, teachers, administrators, etc). These improvement groups review data and current activities related to the twenty performance and compliance indicators in the State Performance Plan (SPP) / Annual Performance Report (APR) and advise the State on continuous improvement.

#### • TCIP = Multi-Level Model

TCIP is intended to be a multi-level model; the self-assessment, public meetings, and improvement planning will occur at the State level, and will yield information and data which will be shared at the regional and district levels so that ultimately all levels in the system are assessment, public meetings, and improvement planning, will be used to determine what to check in on as part of the following year's continuous improvement process, and assist in determining how progress has been made and improving over time.

Eligible proposers are nonprofit organizations, private companies, and individuals.

#### 1.2 BACKGROUND

Texas was among fourteen states, Puerto Rico, and Washington, D.C. monitored by the U.S. Department of Education Office of Special Education Programs (OSEP) in 2000 – 2001. Texas is following the OSEP Continuous Improvement Monitoring Process (CIMP) to assess the impact and effectiveness of State and local efforts in the implementation of the Individuals with Disabilities Education Act (IDEA), and to identify promising practices and improvement opportunities for the State.

The Continuous Improvement Monitoring Process consists of seven phases:

- Self-Assessment: The State performs an evaluation of its own impact and effectiveness in implementing IDEA.
- Validation Planning: The OSEP monitoring team visits the State to collect information and begin the process of validating the Self-Assessment.
- Validation Data Collection: The OSEP monitoring team validates the Self-Assessment.
- **Reporting to the Public:** OSEP's report evaluating the State's performance in the implementation of IDEA is made available to the public.
- **Improvement Planning:** The State develops an improvement plan to address monitoring results, including compliance and effectiveness.
- Implement Improvement Strategies: The State implements its improvement plan.
- Verification and Consequences: OSEP verifies the effectiveness of the improvement actions and rewards or sanctions the State accordingly.

Note: All references and legal citations may be subject to change or update pending Federal Legislation.

#### **1.3 CONTRACT TERM/OPTION TO EXTEND**

The term of any contract resulting from this RFQ shall be from contract award until August 31, 2014. TEA, at its own discretion, may extend any contract awarded pursuant to the RFQ for up to two (2) additional fiscal years under the same or different terms, subject to appropriation of funds by the Texas Legislature for this project. If renewed, the first renewal period shall be from September 1, 2014 through August 31, 2015, and the final renewal shall be from September 1, 2015 through August 31, 2016.

#### 1.4 BUDGET

TEA will award one contract as a result of this RFQ. Proposers must include a detailed budget in accordance with the requirements of Section 3.4 of this Request for Qualifications. The project budget is estimated at forty thousand dollars (\$40,000).

#### 1.5 PROJECT DESCRIPTION AND REQUIREMENTS

Texas is currently involved in the 'Improvement Planning' phase, referred to as the Texas Continuous Improvement Process (TCIP). This process includes ongoing self-assessment including data review, identification of current status, and subsequent improvement planning. The methodology used for Improvement Planning is standardized among various groups and is overseen by the Texas Steering Committee who reviews the plan to ensure it is on course with the improvement process. In the 2013-2014 school year, the Texas Steering Committee will meet to review data and improvement plan implementation. The Improvement Planning committees in the Continuous Improvement framework will meet to review data and revise plans.

The Facilitator will conduct the fall 2013 and spring 2014 Texas Steering Committee meetings as well as the Improvement Planning meetings held throughout the aforementioned school year. The Texas Steering Committee and Improvement Planning meetings are led by the TCIP Facilitator with responsibilities and deliverables to include:

- Facilitate meetings, which may include individual, small, and large group work
- Communicate with committee members
- Work with TEA staff to provide guidance in planning and preparing materials for meetings
- Provide agenda, notes, materials, and reflection notes regarding Improvement Planning meetings
- Debrief with TEA staff after the meetings

Responsibilities listed are not definitive and may change subject to the needs of the program. Any changes made to the program will be processed through the committee, with all relevant supporting documentation.

#### 1.6 PROPOSER QUALIFICATIONS

Proposers must demonstrate the following minimum requirements:

• Knowledge of the Texas Continuous Improvement Process, including Improvement Planning

and the OSEP federal monitoring process.

- Knowledge of the Individuals with Disabilities Education Act (IDEA) 2004.
- Provide facilitation approach to include style and method of facilitation.
- Describe relevant qualifications and experience working on similar projects and provide the Organization(s) name, contact name, and phone number and identify the activities performed.

## SECTION TWO: GENERAL INSTRUCTIONS AND STANDARD PROPOSAL REQUIREMENTS

All proposals in response to this RFQ must meet the following conditions in order to be considered. Failure to meet these conditions shall result in disqualification of proposal and the proposal shall receive no further consideration.

#### 2.1 PROPOSAL SUBMISSION, DATE AND TIME

Proposals must be submitted in a sealed envelope (or box as appropriate) with the Proposer's name, RFQ number, and closing date prominently visible on the envelope/package. <u>Facsimile</u> transmissions (FAX) of proposals will not be accepted under any circumstances.

Proposers must sign the "Proposal Signature Page" (Attachment B). By signing, the Proposer or the Proposer's legally authorized agent affirms that all statements within the proposal are true and correct. Discovery of any false statement in the proposal is a material breach and shall void the submitted proposal or any resulting contracts and Proposer shall also be removed from all vendor lists maintained by the state of Texas.

#### 2.1.1 <u>Receipt of Proposals</u>

TEA's Purchasing & Contracts Division is open Monday through Friday, 8:00 A.M. to 5:00 P.M., excluding holidays. Proposals will not be considered if received in Texas Education Agency's Purchasing & Contracts Division after 2:00 P.M. (Central Time) on the closing date. In establishing the time and date of receipt, the Commissioner of Education will rely solely on the time/date stamp of the TEA Purchasing & Contracts Division. Please note that all TEA visitors must register with the TEA Receptionist Desk and receive a visitors badge to visit any area of the agency. In addition, all visitors must be escorted by a TEA employee to the respective area. Be sure to incorporate time for parking and the reception desk when delivering proposals in person. #### Method of Submittal

Regardless of the method of submitting the proposal—United States Postal Service (USPS), United Parcel Service, Federal Express or any other delivery service—the proposal must be received in the TEA Purchasing and Contracts Office by 2:00 P.M. (CT) on or before the closing date in order to be considered.

TEA WILL NOT accept a USPS postmark and/or round validation stamp, mail receipt with the date of mailing stamped by the USPS, a dated shipping label, invoice or receipt from a commercial carrier, or any other documentation as proof of receipt of any proposal. Proposers are advised that TEA assume no responsibility, due to any circumstances, for the receipt of a proposal after the deadline time and date established in this RFQ.

#### 2.1.2 <u>Number of Proposal Copies</u>

Six (6) copies of the proposal must be submitted. The required number of copies of the proposal must be received in the TEA office by 2:00 P.M. on the established deadline date. Failure to meet this condition shall result in disqualification of proposal and the proposal shall receive no further consideration. Photocopying is not available at TEA.

Additions or replacements to the proposal will not be accepted after the closing date for receiving the proposal in the Purchasing & Contracts Division of the TEA Office.

#### 2.3.1 <u>Requests for Additional Information</u>

In order to assure that no prospective Proposer may obtain a competitive advantage because of acquisition of information unknown to other prospective Proposers, any additional information that is different from or in addition to information provided in this RFQ will be provided only in response to written inquiries. All questions will be de-identified and the written answers will be posted as an Addendum to the RFQ on the electronic state business daily (ESBD) link: <u>http://esbd.cpa.state.tx.us</u>.

Upon publication of this RFQ, besides written inquiries as described above, employees and representatives of TEA will not answer questions or otherwise discuss the contents of the RFQ with any potential vendor or their representatives. If a potential vendor fails to observe this restriction, that vendor's response to this RFQ may be disqualified. This restriction does not preclude discussions for the purpose of conducting business unrelated to this RFQ.

TEA will not be bound by any communication with Proposers other than the written addenda issued by TEA. If you do not have access to the Internet, you may obtain a copy of the FAQs or additional/clarifying information by contacting: TEA Contracts at (512) 463-9041.

#### 2.4 STANDARD PROPOSAL REQUIREMENTS

- Proposals that address only part of the requirements contained in this Request for Qualifications may be considered non-responsive.
- TEA reserves the right to reject any and all proposals and to negotiate portions thereof.
- TEA reserves the right to select the proposal containing the best proposal considering the outcomes desired. The Proposer shall furnish such additional information that TEA may reasonably require.

#### 2.5 STATE NOT RESPONSIBLE FOR PREPARATION COSTS

The TEA will not be liable for any costs incurred in the preparation and submittal of a proposal.

#### 2.6 DISCLOSURE OF PROPOSAL CONTENT

After contract award, proposals are subject to release under the Texas Government Code, Chapter 552, Public Information Act. Proposers must indicate on their proposal cover if their submission contains proprietary information. It is recommended that a proposer identify the specific sections within the proposal that it considers proprietary.

#### 2.7 CONFLICT OF INTERESTS

A Proposer will not be selected if it has a conflict of interest that will or may arise during the performance of its obligations under the contract. For this reason, Proposer's response to this RFQ must disclose all business interest and all relationships that could be considered to pose possible conflicts of interest in the Proposer's performance of contract obligations. In addition, Proposers must represent and warrant in its response to this RFQ and in the contract that in the performance of services under the contract, (1) Proposer does not have and will not have any actual or potential conflict of interest, and (2) Proposer will take whatever reasonable actions may be necessary and prudent to avoid even the appearance of impropriety.

A TEA employee may not have a direct interest in the proceeds from a contract resulting from this RFQ as defined above. No TEA employee may be related within the second degree of consanguinity or affinity to anyone who has a direct interest in the proceeds of a contract arising from this RFQ as defined above. Each Proposer shall certify that it is in compliance with this provision to the best of its knowledge.

## SECTION THREE: PROPOSAL FORMAT AND CONTENT

#### 3.1 PROPOSAL FORMAT AND CONTENT

Proposals must be typewritten entirely on 8.5" x 11" white paper and must be limited to five pages not including appendices and attachments. Font size must be no smaller than ten (10) points. Proposals must be submitted in a manner which does not carry any benefit, keepsake, or value for members of the review panel. Proposals should include a cover page, which clearly states the name of the firm or organization and the name, position, and telephone number of the Proposer's project administrator who may be contacted regarding the proposal (see Attachment A).

#### 3.1.1 Response Checklist

This checklist is to assist Proposers ensuring that all information is included in their response. Proposers must refer to the appropriate section of the RFQ for detailed information on the following.

#### 3.2 UNDERSTANDING OF THE PROJECT AND METHODOLOGY

Each proposal should contain a clear and concise program summary describing your organization's abilities to meet the requirements of this RFQ. The proposal must describe the project activities, services, and reports to be generated during the contract period and relate them to the stated purposes and specifications described in the RFQ. Technical evidence relating to the Proposer's ability to perform the proposed services must be appended to the proposal.

#### 3.3 MANAGEMENT PLAN FOR PROJECT

The Proposer must provide satisfactory evidence of capability to manage and coordinate the types of activities described in the RFQ and to produce the specified product(s) or service(s) on time. To provide information on qualifications to accomplish the described tasks, Proposers must include in this section the following information:

- Structure of the Proposer organization
- Résumé's of the Proposer and individuals involved in the project
- Evidence that the Proposer has experience working on similar projects; three references must be provided that include the name of the agencies or entities, the contact person name, and phone number from each employing agency/entity

## 3.4 COST PROPOSAL

This is a fixed price contract. The Proposer must submit a pricing proposal associated with the project description (see Section 1). Costs must be justified in terms of activities and expenditures and must be reasonable and necessary to accomplish the objectives of the project. Contractor may be required to submit monthly reports identifying costs associated with the task activity plan or service deliverables at the discretion of the Project Administrator.

Failure to meet these conditions shall result in disqualification of proposal and the proposal shall receive no further consideration.

## 3.5 PROPOSER'S FINANCIAL RESPONSIBILITY

Non-profit organizations may be required to submit indicators of financial stability such as an audited financial statement, a certified public accountant-compiled financial report, or similar document. All non-

profit organizations may be requested to submit proof of non-profit status. A Proposer may show that it is a non-profit organization by any of the following means:

- Copy of a letter from the Internal Revenue Service recognizing that contributions to the organization are tax deductable under Section 501(c)(3) of the Internal Revenue Code;
- Statement from a state taxing body or the State Attorney General certifying that the organization is a non-profit organization operating within the state and that no part of its net earnings may lawfully benefit any private shareholder or individual;
- Certified copy of the Proposer's certificate of incorporation or similar document if it clearly establishes the non-profit status of the Proposer.

## SECTION FOUR: REVIEW OF PROPOSALS

#### 4.1 REVIEW OF PROPOSALS

Review of proposals will begin as soon as practical after receipt. The proposals will be reviewed by TEA and evaluated in accordance with the criteria specified within RFQ. Proposers may be asked to participate in the oral presentation phase of the evaluation process. Proposals will be rated again following oral presentations. The evaluation team shall consist of persons knowledgeable in the content area.

TEA will notify each Proposer in writing of their qualification or non-qualification. Additional copies of proposals **not qualified** will be destroyed in accordance with the agency approved records retention policy.

#### **4.2 SELECTION CRITERIA**

Proposals will be selected based on the ability of each Proposer to carry out all of the requirements contained in this RFQ. TEA will determine satisfaction of minimum requirements by assigning points according to the following scale:

#### 4.3 PAYMENT

All payments are made in accordance with Texas Government Code <u>§2251.001</u> et seq. Payments for Goods and Services. Unless otherwise indicated by the TEA, payment is only by reimbursement upon satisfactory performance of services.

Payment is contingent upon submission of properly prepared and certified invoices.. The information provided on each detailed status report must coincide with the tasks outlined in the approved budget, as negotiated by the TEA. The TEA Project Manager will approve invoices based upon project progress, task completion, reasonable use of project funds, and satisfactory performance of services as outlined in the progress report. The invoice shall note the period of time payment is for, the agreed upon monthly amount, contract number, purchase order number, and the Texas comptroller of Public Accounts Payee Identification Number (TIN).

According to guidelines set forth by the Texas Comptroller of Public Accounts, the payment scheduling policy requires agencies to pay as close to the due date as possible in order to maximize fiscal benefits to the state. Payments are due from TEA 30-days from receipt of a correct and complete invoice.

#### EXECUTION OF OFFER, AFFIRMATION OF TERMS AND CONDITIONS, AND PROPOSAL PREFERENCES

- A. As used in these General Provisions:
  - *Contract* means the entire document, and all of TEA's attachments, appendices, schedules (including but not limited to the General Provisions and the Special Provisions), amendments and extensions of or to the Standard Contract;
  - Receiving Agency or Party or TEA means the Texas Education Agency;
  - Performing Agency or Contractor means the party or parties to this Contract other than TEA, including its
    or their officers, directors, employees, agents, representatives, consultants and subcontractors, and
    subcontractors' officers, directors, employees, agents, representatives and consultants;
  - *Project Manager/Administrator* means the respective person(s) representing TEA or Contractor, as indicated by the Contract, for the purposes of administering the Contract Project;
  - Contract Project means the purpose intended to be achieved through the Contract;
  - Amendment means a Contract that is revised in any respect, and includes both the original Contract, and any subsequent amendments or extensions thereto;
  - Works means all tangible or intangible material, products, ideas, documents or works of authorship prepared or created by Contractor for or on behalf of TEA at any time after the beginning date of the Contract ("Works" includes but is not limited to computer software, data, information, images, illustrations, designs, graphics, drawings, educational materials, assessment forms, testing materials, logos, trademarks, patentable materials, etc.); and,
  - Intellectual Property Rights means the worldwide intangible legal rights or interests evidenced by or embodied in: (a) any idea, design, concept, method, process, technique, apparatus, invention, discovery, or improvement, including any patents, trade secrets, and know-how; (b) any work of authorship, including any copyrights, moral rights or neighboring rights; (c) any trademark, service mark, trade dress, trade name, or other indicia of source or origin; (d) domain name registrations; and (e) any other similar rights. The Intellectual Property Rights of a party include all worldwide intangible legal rights or interests that the party may have acquired by assignment or license with the right to grant sublicenses.
- B. Contingency: The Contract(s), including any amendments, extensions or subsequent contracts, are executed by TEA contingent upon the availability of appropriated funds by legislative act. Notwithstanding any other provision in this Contract or any other document, this Contract is void upon the insufficiency (in TEA's discretion) or unavailability of appropriated funds. In addition, this Contract may be terminated by TEA at any time for any reason upon notice to Contractor. Expenditures and/or activities for which Contractor may claim reimbursement shall not be accrued or claimed subsequent to receipt of such notice from TEA.

#### C. Indemnification:

For local educational agencies (LEAs), regional education service centers (ESCs), institutions of higher education (IHEs), and state agencies: Contractor, to the extent permitted by law, shall hold TEA harmless from and shall indemnify TEA against any and all claims, demands, and causes of action of whatever kind or nature asserted by any third party and occurring or in any way incident to, arising from, or in connection with, any acts of Contractor in performance of the Contract Project.

For all other contractors, including nonprofit organizations and for-profit businesses: Contractor shall indemnify, hold harmless, and defend TEA and the State, all of its officers, agents, and employees from any and all claims, actions, suits, demands, and causes of action of whatever kind or nature asserted by any third party and occurring or in any way incident to, arising from, or in connection with, any acts or omissions of the Contractor or any agent, employee, subcontractor, or supplier of Contractor in performance of the Contract Project.

- D. Subcontracting and Substitutions: Contractor shall not assign, transfer or subcontract any of its rights or responsibilities under this Contract without prior formal written amendment to this Contract properly executed by both TEA and Contractor. TEA reserves the right to request changes in personnel assigned to the project. The TEA Project Manager must pre-approve any changes in key personnel throughout the contract term. Any changes to the HUB Subcontracting Plan (HSP) must be approved by the Agency HUB Coordinator before staffing changes are initiated. Substitutions are not permitted without written approval of the TEA Project Manager.
- E. Encumbrances/Obligations: All encumbrances, accounts payable, and expenditures shall occur on or between the beginning and ending dates of this Contract. All goods must have been received and all services rendered during the Contract period in order for Contractor to recover funds due. In no manner shall encumbrances be considered or reflected as accounts payable or as expenditures.

- F. **Contractor's Proposal**: Contractor's proposal that was furnished to TEA in response to a request for qualifications is incorporated in this Contract by reference. The provisions of this Contract shall prevail, however, in all cases of conflict arising from the terms of Contractor's proposal whether such proposal is a written part of this Contract or is attached as a separate document.
- G. **Requirements, Terms, Conditions, and Assurances**: The terms, conditions, and assurances, which are stated in the Request for Qualifications, in response to which Contractor submitted a proposal, are incorporated herein by reference for all purposes, although the current General Provisions shall prevail in the event of conflict.
- H. Records Retention: Contractor shall maintain its records and accounts in a manner which shall assure a full accounting for all funds received and expended by Contractor in connection with the Contract Project. These records and accounts shall be retained by Contractor and made available for programmatic or financial audit by TEA and by others authorized by law or regulation to make such an audit for a period of not less than five (5) years from the date of completion of the Contract Project or the date of the receipt by TEA of Contractor's final claim for payment or final expenditure report in connection with this Contract, whichever is later. If an audit has been announced, the records shall be retained until such audit has been completed.

Contractor understands that acceptance of funds under this contract acts as acceptance of the authority of the State Auditor's office, or any successor agency, to conduct an audit or investigation in connection with those funds. Contractor further agrees to cooperate fully with the State Auditor's Office or its successor in the conduct of the audit or investigation, including providing all records requested. Contractor will ensure that this clause concerning the authority to audit funds received indirectly by subcontractors through Contractor and the requirements to cooperate is included in any subcontract it awards.

I. Intellectual Property Ownership: Contractor agrees that all Works are, upon creation, works made for hire and the sole property of TEA. If the Works are, under applicable law, not considered works made for hire, Contractor hereby assigns to TEA all worldwide ownership of all rights, including the Intellectual Property Rights, in the Works, without the necessity of any further consideration, and TEA can obtain and hold in its own name all such rights to the Works. Contractor agrees to maintain written agreements with all officers, directors, employees, agents, representatives and subcontractors engaged by Contractor for the Contract Project, granting Contractor rights sufficient to support the performance and grant of rights to TEA by Contractor. Copies of such agreements shall be provided to TEA promptly upon request.

Contractor warrants that (i) it has the authority to grant the rights herein granted, (ii) it has not assigned or transferred any right, title, or interest to the Works or Intellectual Property Rights that would conflict with its obligations under the Contract, and Contractor will not enter into any such agreements, and (iii) the Works will be original and will not infringe any intellectual property rights of any other person or entity. These warranties will survive the termination of the Contract. If any preexisting rights are embodied in the Works, Contractor grants to TEA the irrevocable, perpetual, non-exclusive, worldwide, royalty-free right and license to (i) use, execute, reproduce, display, perform, distribute copies of, and prepare derivative works based upon such preexisting rights and any derivative works thereof and (ii) authorize others to do any or all of the foregoing. Contractor agrees to notify TEA on delivery of the Works if they include any such preexisting rights. On request, Contractor will provide TEA with documentation indicating a third party's written approval for Contractor to use any preexisting rights that may be embodied or reflected in the Works.

Contractor agrees, at Contractors expense, to indemnify, hold harmless and defend TEA and the State from claims involving infringement of third parties' licenses, trademarks, copyrights or patents.

**For School Districts and Nonprofit Organizations**: The foregoing Intellectual Property Ownership provisions apply to any school districts, nonprofit organizations, and their employees, agents, representatives, consultants and subcontractors.

**For Education Service Centers (ESCs)**: The foregoing Intellectual Property Ownership provisions apply to an Education Service Center (ESC) and its employees, agents, representatives, consultants, and subcontractors. If an ESC or any of its subcontractor(s) wish to obtain a license agreement to use, advertise, offer for sale, sell, distribute, publicly display, publicly perform or reproduce the Works, or make derivative works from the Works, then express written permission must first be obtained from TEA Legal Division.

**For Colleges and Universities**: The foregoing Intellectual Property Ownership provisions apply to any colleges and universities and their employees, agents, representatives, consultants, and subcontractors; provided, that for all Works created or conceived by colleges or universities under the Contract, they are granted a non-exclusive, non-transferable, royalty-free license to use the Works for their own academic and educational purposes only. Colleges and universities are prohibited, however, from advertising, offering for sale, selling, distributing, publicly displaying, publicly performing, or reproducing the Works, or

making derivative works from the Works that are created or conceived under this Contract, without the express written permission of TEA Legal Division.

- J. Sanctions for Failure to Perform or for Noncompliance: If Contractor, in TEA's sole determination, fails or refuses for any reason to comply with or perform any of its obligations under this Contract, TEA may impose such sanctions as it may deem appropriate. This includes but is not limited to the withholding of payments to Contractor until Contractor complies; the cancellation, termination, or suspension of this Contract in whole or in part; and the seeking of other remedies as may be provided by this Contract or by law. Any cancellation, termination, or suspension of this Contract, if imposed, shall become effective at the close of business on the day of Contractor's receipt of written notice thereof from TEA.
- K. **Contract Cancellation, etc.**: If this Contract is cancelled, terminated, or suspended by TEA prior to its expiration date, the reasonable monetary value of services properly performed by Contractor pursuant to this Contract prior to such cancellation, termination or suspension shall be determined by TEA and paid to Contractor as soon as reasonably possible.
- L. **Refunds Due to TEA**: If TEA determines that TEA is due a refund of money paid to Contractor pursuant to this Contract, Contractor shall pay the money due to TEA within 30 days of Contractor's receipt of written notice that such money is due to TEA. If Contractor fails to make timely payment, TEA may obtain such money from Contractor by any means permitted by law, including but not limited to offset, counterclaim, cancellation, termination, suspension, total withholding, and/or disapproval of all or any subsequent applications for said funds.
- M. Capital Outlay: If Contractor purchases capital outlay (furniture and/or equipment) to accomplish the Contract Project, title will remain with Contractor for the period of the Contract. TEA reserves the right to transfer capital outlay items for Contract noncompliance during the Contract period or as needed after the ending date of the Contract. This provision applies to any and all furniture and/or equipment regardless of unit price and how the item is classified in Contractor's accounting record. This provision is applicable when federal funds are utilized for the Contract.
- N. TEA Property (terms): In the event of loss, damage or destruction of any property owned by or loaned by TEA while in the custody or control of Contractor, Contractor shall indemnify TEA and pay to TEA the full value of or the full cost of repair or replacement of such property, whichever is the greater, within 30 days of Contractor's receipt of written notice of TEA's determination of the amount due. This applies whether the property is developed or purchased by Contractor pursuant to this Contract or is provided by TEA to Contractor for use in the Contract Project. If Contractor fails to make timely payment, TEA may obtain such money from Contractor by any means permitted by law, including but not limited to offset or counterclaim against any money otherwise due to Contractor by TEA.
- O. **State of Texas Laws**: In the conduct of the Contract Project, Contractor shall be subject to Texas State Board of Education rules pertaining to this Contract and the Contract Project, and to the laws of the State of Texas governing this Contract and the Contract Project. This Contract constitutes the entire agreement between TEA and Contractor for the accomplishment of the Contract Project. This Contract shall be interpreted according to the laws of the State of Texas except as may be otherwise provided for in this Contract.
- P. Federal Regulations Applicable to All Federally Funded Contracts:
  - For Local Education Agencies (LEAs): 28 CFR 35 Subparts A-E, 28 CFR 36 Subparts C & D, Appendix A, 29 CFR 1630, 34 CFR 75 or 76 as applicable, 77, 79, 80, 81, 82, 85, 99, 104, 47 CFR 0 and 64, and OMB Circulars A-87 (Cost Principles) and A-133 (Audits);
  - For Education Service Centers (ESCs): 28 CFR 35 Subparts A-E, 28 CFR 36 Subparts C & D, Appendix A, 29 CFR 1630, 34 CFR 75 or 76 as applicable, 77, 79, 80, 81, 82, 85, 99, 104, 47 CFR 0 and 64, and OMB Circulars A-87 (Cost Principles) and A-133 (Audits);
  - 3. For Institutions of Higher Education (IHEs): 28 CFR 35 Subparts A-E, 28 CFR 36 Subparts C & D, Appendix A, 29 CFR 1630, 34 CFR 74, 77, 79, 81, 82, 85, 99, 104, OMB Circular A-21 (Cost Principles), 47 CFR 0 and 64, OMB Circular A-133 (Audits), and OMB Circular A-110 (Uniform Administrative Requirements);
  - For Nonprofit Organizations: 28 CFR 35 Subparts A-E, 28 CFR 36 Subparts C & D, Appendix A, 29 CFR 1630, 34 CFR 74, 77, 79, 81, 82, 85, 99, 104, 47 CFR 0 and 64, OMB Circulars A-122 (Cost Principles) and A-133 (Audits), and OMB Circular A-110 (Uniform Administrative Requirements);
  - 5. For State Agencies: 28 CFR 35 Subparts A-E, 28 CFR 36 Subparts C & D, Appendix A, 29 CFR 1630, 34 CFR 76, 80, 81, 82, 85, 99, 104, 47 CFR 0 and 64, OMB Circulars A-87 (Cost Principles) and A-133 (Audits), and OMB Circular A-110 (Uniform Administrative Requirements); and
  - 6. For Commercial (for-profit) Organizations: 29 CFR 1630 and 48 CFR Part 31.
  - 7. For American Recovery and Reinvestment Act funded projects: FAR 52.204-11, 52.212-5, 52.214-26, 52.215-2, and OMB Guidance Memo M-09-15.

- R. Time and Effort Recordkeeping: For those personnel whose salaries are prorated between or among different funding sources, time and effort records will be maintained by Contractor that will confirm the services provided within each funding source. Contractor must adjust payroll records and expenditures based on this documentation. This requirement applies to all projects, regardless of funding source, unless otherwise specified. For federally funded projects, time and effort records must be in accordance with the requirements in the applicable OMB cost principles.
- Federal Rules, Laws, and Regulations That Apply to all Federal Programs: Contractor shall be subject to and shall abide by all federal laws, rules, and regulations, pertaining to the Contract Project, including, but not limited to:
  - 1. Americans With Disabilities Act, P.L. 101-336, 42 U.S.C. sec. 12101, and the regulations effectuating its provisions contained in 28 CFR Parts 35 and 36, 29 CFR Part 1630, and 47 CFR Parts 0 and 64;
  - 2. Title VI of the Civil Rights Act of 1964, as amended (prohibition of discrimination by race, color, or national origin), and the regulations effectuating its provisions contained in 34 CFR Part 100;
  - Title IX of the Education Amendments of 1972, as amended (prohibition of sex discrimination in educational institutions) and the regulations effectuating its provisions contained in 34 CFR Part 106, if Contractor is an educational institution;
  - 4. Section 504 of the Rehabilitation Act of 1973, as amended (nondiscrimination on the basis of handicapping condition), and the regulations effectuating its provisions contained in 34 CFR Parts 104 and 105.

TEA shall be responsible for reporting to the proper authorities any failure by Contractor to comply with the foregoing laws and regulations coming to TEA's attention, and may deny payment or recover payments made by TEA to Contractor in the event of Contractor's failure so to comply. Contractor who is indebted or owes delinquent taxes to the state will have any payments under the Contract applied toward the debt or delinquent taxes owed the state until the account is paid in full, regardless of when the debt or delinquency was incurred. This provision does not apply if the warrant or transfer results in payments being made in whole or in part with money paid to the state by the Federal Government.
- Signature Authority; Final Expression; Superseding Document: Contractor certifies that the person signing this Contract has been properly delegated this authority. The Contract represents the final and complete expression of the terms of agreement between the parties. The Contract supersedes any previous understandings or negotiations between the parties. Any representations, oral statements, promises or warranties that differ from the Contract shall have no force or effect. The Contract may be modified, amended or extended only by formal written amendment properly executed by both TEA and Contractor.
- Antitrust: By signing this Contract, Contractor, represents and warrants that neither Contractor nor any firm, corporation, partnership, or institution represented by Contractor, or anyone acting for such firm, corporation or institution has, (1) violated the antitrust laws of the State of Texas under Tex. Bus. & Com. Code, Chapter 15, or the federal antitrust laws; or (2) communicated directly or indirectly the Proposal to any competitor or any other person engaged in such line of business during the procurement process for this Contract.

- Family Code Applicability: By signing this Contract, Contractor, if other than a state Party, certifies that under Section 231.006, Family Code, that Contractor is not ineligible to receive specified grant, loan, or payment under this Contract and acknowledges that this Contract may be terminated and payment may be withheld if this certification is inaccurate. TEA reserves the right to terminate this Contract if Contractor is found to be ineligible to receive payment. If Contractor is found to be ineligible to receive payment and the Contract is terminated, Contractor is liable to TEA for attorney's fees, the costs necessary to complete the Contract, including the cost of advertising and awarding a second contract, and any other damages or relief provided by law or equity.
- **Dispute Resolution**: The dispute resolution process provided for in Chapter 2260 of the Texas Government Code must be used by TEA and Contractor to attempt to resolve all disputes arising under this Contract. The parties may agree to mediation of their dispute at any time. However, if all issues in dispute are not completely resolved through direct negotiations between the parties within 180 days after the agency receives Contractor's notice of claim, then the parties must submit the dispute to mediation before a mutually acceptable mediator in Travis County, Texas. The mediation must be completed on or before 270 days after the agency receives Contractor's notice of claim. Completion of the mediation is a condition precedent to the filing of a contested case hearing under Chapter 2260. The agency's participation in mediation or any other dispute resolution process shall not waive any of the agency's contractual or legal rights and remedies, including but not limited to sovereign immunity.
- Interpretation: In the case of conflicts arising in the interpretation of wording and/or meaning of various sections, parts, Appendices, General Provisions, Special Provisions, Exhibits, and Attachments or other documents, the TEA Contract and its General Provisions, Appendices and Special Provisions shall take precedence over all other documents which are a part of this contract.
- Education Service Center: No funds transferred to Regional Education Service Centers or to school districts may be used to hire a registered lobbyist.
- **Compliance with Laws**: Contractor shall comply with all federal, state, and local laws, statutes, ordinances, rules and regulations, and the orders and decrees of any court or administrative bodies or tribunals in any matter affecting Contractor's performance, including if applicable, workers' compensation laws, minimum and maximum salary and wage statutes and regulations, prompt payment and licensing laws and regulations. For the entire duration of the Contract, Contractor shall maintain all required licenses, certifications, permits, and any other documentation necessary to perform this Contract. When required or requested by the Agency, Contractor shall furnish TEA with satisfactory proof of its compliance with this provision.
- Public Information: The TEA is subject to the provisions of the Texas Public Information Act. If a request for disclosure of this Contract or any information related to the goods or services provided under the Contract or information provided to the TEA under this Contract constituting a record under the Act is received by the TEA, the information must qualify for an exception provided by the Texas Public Information Act in order to be withheld from public disclosure. Contractor authorizes the TEA to submit any information contained in the Contract, provided under the Contract, or otherwise requested to be disclosed, including information Contractor has labeled as confidential proprietary information, to the Office of the Attorney General for a determination as to whether any such information may be exempt from public disclosure under the Act. If the TEA does not have a good faith belief that information may be subject to an exception to disclosure, the TEA is not obligating itself by this Contract to submit the information to the Attorney General. It shall be the responsibility of the Contractor to make any legal argument to the Attorney General or appropriate court of law regarding the exception of the information in question from disclosure. The Contractor waives any claim against and releases from liability the TEA, its officers, employees, agents, and attorneys with respect to disclosure of information provided under or in this Contract or otherwise created, assembled, maintained, or held by the Contractor and determined by the Attorney General or a court of law to be subject to disclosure under the Texas Public Information Act.
- **Gratuities**: By signing this Contract, Contractor represents and warrants that the Contractor has not given, offered to give, nor intends to give at any time hereafter any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor, or service to a public servant in connection with the submitted response.
- Venue and Jurisdiction: Subject to and without waiving any of the Agency's rights, including sovereign immunity, this Contract is governed by and construed under and in accordance with the laws of the State of Texas. Venue for any suit concerning this solicitation and any resulting contract or purchase order shall be in a court of competent jurisdiction in Travis County, Texas.
- **Protests**: Any actual or prospective bidder, offeror, or contractor who is aggrieved in connection with the solicitation, evaluation, or award of this or any other contract by the Texas Education Agency may submit a formal protest to the Director of the Agency's Contracts and Purchasing Division. This protest procedure shall be the exclusive method by which anyone may make a challenge to any aspect of the Agency's contracting process.

The Agency will not be required to consider the merits of any protest unless the written protest is submitted within ten (10) working days after such aggrieved person knows, or reasonably should have known, of the occurrence of the action which is protested. The protest document must meet with all requirements in applicable law and Agency's rules (Title 19 of the Texas Administrative Code, at § 30.2002) <a href="http://ritter.tea.state.tx.us/rules/tac/index.html">http://ritter.tea.state.tx.us/rules/tac/index.html</a>.

If the protest procedure results in a final determination by the Agency that a violation of law has occurred in its contracting process in a case in which a contract has been awarded, then the Agency may declare the contract void at inception. In that event, the party who had been awarded the contract shall have no rights under the contract and no remedies under the law against the Agency.

- Liability for and Payment of Taxes: Contractor represents and warrants that it shall pay all taxes or similar amounts resulting from this Contract, including, but not limited to, any federal, State, or local income, sales or excise taxes of Contractor or its employees. TEA shall not be liable for any taxes resulting from this Contract.
- **Severability:** In the event that any provision of this Contract is later determined to be invalid, void, or unenforceable, the invalid provision will be deemed severable and stricken from the contract as if it had never been incorporated herein. The remaining terms, provisions, covenants, and conditions of this Contract shall remain in full force and effect, and shall in no way be affected, impaired, or invalidated.
- **Conformance**: The Contractor warrants that all goods and services furnished shall conform in all respects to the terms of this Contract, including any drawings, specifications or standards incorporated herein, and any defects in materials, workmanship, and free from such defects in design. In addition, respondent warrants that goods and services are suitable for and will perform in accordance with the purposes for which they are intended.
- **Felony Criminal Convictions:** Contractor represents and warrants that Contractor has not and Contractor's employees assigned to TEA projects have not been convicted of a felony criminal offense, or that, if such a conviction has occurred, Contractor has fully advised TEA as to the facts and circumstances surrounding the conviction.
- **Criminal Background Checks:** If during the term of this Contract, Contractor, and/or Contractor staff, or subcontractor have access to Texas public school campuses, all Contractor and/or Contractor's staff must submit to a national criminal history record information review (includes fingerprinting) and meet all eligibility standards and criteria as set by Agency before serving in assignments on behalf of the Agency. This requirement applies to all individuals who currently serve or will serve in Agency assignments that have the possibility of direct contact with students. Assignments are contingent upon meeting Agency eligibility standards. Contractor and/or any staff member of Contractor who may perform services under this contract must complete this criminal history review before the beginning of an assignment. If said individuals have not completed this requirement or the review results in a determination that Contractor is not eligible for assignment, this contract will be terminated effective immediately or the date of notice of non-eligibility, whichever is earliest.
- Assignment of Contract: This Contract may not be assigned, sold, or transferred without the express written consent of the TEA Purchasing and Contracts Division. An attempted assignment after Contract award without the TEA approval will constitute a material breach of contract.
- **Buy Texas:** In accordance with Government Code, Section 2155.444, the State of Texas requires that during the performance of a contract for services, Contractor shall purchase products and materials produced in the State of Texas when available at a price and time comparable to products and materials produced outside the state. This provision does not apply if Contractor receives any federal funds under this Contract.
- **Excluded Parties List System:** The Texas Education Agency is federally mandated to adhere to the directions provided in the President's Executive Order (EO) 13224, Executive Order on Terrorist Financing Blocking Property and Prohibiting Transactions With Persons Who Commit, Threaten to Commit, or Support Terrorism and any subsequent changes made to it via cross-referencing respondents/vendors with the Federal General Services Administration's Excluded Parties List System (EPLS, <u>http://www.epls.gov</u>), which is inclusive of the United States Treasury's Office of Foreign Assets Control (OFAC) Specially Designated National (SDN) list. - **Suspension and Debarment:** Contractor certifies that neither it nor its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntary excluded from participation in this transaction by any federal, state or local government entity. If Contractor is unable to certify to any of the statements in this certification, such prospective participant shall attach an explanation to this contract.

- **Independent Contractor**: Contractor shall serve as an independent contractor in providing services under this Contract. Contractor's employees are not and shall not be construed as employees or agents of the State of Texas.
- **Vendor Performance:** All state agencies must report unsatisfactory vendor performance on purchases over \$25,000. Respondents who are in default or otherwise not in good standing under any other current or prior contract with TEA at the time of selection will not be eligible for award of this contract. Agencies report satisfactory and exceptional vendor performance to assist in determining best value. In accordance with Texas Government Code, §2155.074 and §2155.75, vendor performance may be used as a factor in future contract awards.

- **Termination:** This contract shall terminate upon full performance of all requirements contained in this contract, unless otherwise extended or renewed as provided in accordance with the contract terms and conditions.
  - 1. Termination for Convenience: Either Party may terminate this Contract at any time, in whole or in part, without penalty, by providing thirty (30) calendar days advance written notice to the other Party. In the event of such a termination, the Contractor shall, unless otherwise mutually agreed upon in writing, cease all work immediately upon the effective date of termination. TEA shall be liable for reimbursing only those expenses incurred by the Contractor that are permitted under this Contract and were incurred prior to the effective termination date.
  - 2. Termination for Cause/Default: If the Contractor fails to provide the goods or services contracted for according to the provisions of the Contract, or fails to comply with any of the terms or conditions of the Contract, TEA may, upon written notice of default to the Contractor, immediately terminate all or any part of the Contract. Termination is not an exclusive remedy, but will be in addition to any other rights and remedies provided in equity, by law or under the Contract.

TEA may exercise any other right, remedy or privilege which may be available to it under applicable law of the state and any other applicable law or may proceed by appropriate court action to enforce the provisions

of the Contract, or to recover damages for the breach of any agreement being derived from the Contract. The exercise of any of the foregoing remedies will not constitute a termination of the Contract unless TEA notifies the Contractor in writing prior to the exercise of such remedy.

The Contractor shall remain liable for all covenants and indemnities under the Contract. The Contractor shall be liable for all costs and expenses, including court costs, incurred by TEA with respect to the enforcement of any of the remedies listed herein.

- 3. Termination Due to Changes in Law: If federal or state laws or regulations or other federal or state requirements are amended or judicially interpreted so that either Party cannot reasonably fulfill this Contract and if the Parties cannot agree to an amendment that would enable substantial continuation of the Contract, the Parties shall be discharged from any further obligations under this Contract.
- 4. Rights upon Termination or Expiration of Contract: In the event that the Contract is terminated for any reason, or upon its expiration, TEA shall retain ownership of all associated work products and documentation obtained from the Contractor under the Contract.
- 5. Survival of Terms: Termination of the Contract for any reason shall not release the Contractor from any liability or obligation set forth in the Contract that is expressly stated to survive any such termination or by its nature would be intended to be applicable following any such termination, including the provisions regarding confidentiality, indemnification, transition, records, audit, property rights, dispute resolution, and invoice and fees verification.

#### Amendments:

An amendment to this Contract will become effective on the date of signature of TEA.
- 2. The Contractor is permitted to rebudget among direct cost categories within the approved budget to meet unanticipated requirements and to make limited changes (less than 10%) to the approved budget without submitting a written amendment. However, a revised budget document must be submitted to the TEA Project Manager for approval. Once approved, the documents must be submitted and Contracts office and will be incorporated into the Contract file. Failure to submit the budget documents will result in invoices being rejected or payment delayed.
- 3. Written amendments are required for the following Contract changes:

In no manner shall encumbrances be considered or reflected as accounts payable or as expenditures.
- 3. Contractor who is indebted or owes delinquent taxes to the state will have any payments under the contract applied toward the debt or delinquent taxes owed the state until the amount is paid in full, regardless of when the debt or delinquency was incurred. TEA shall determine whether a payment law prohibits the Comptroller from issuing a warrant or initiating an electronic funds transfer to a person before TEA enters into a written contract with that person.
