What's New in Performance Reporting

A–F Development

The Notice of Interest forms for districts interested in participating in the local accountability system pilot are due by 5:00 p.m. on October 31, 2017. TEA will review the Notice of Interest forms and announce which districts will participate in the pilot by December 1, 2017. TEASE Access

Do you have access to Texas Education Agency Secure Environment (TEASE) Accountability? The Accountability application in TEASE is the repository for unmasked accountability data, performance reports, listings of schools identified under the Public Education Grant (PEG) program, and information specific to alternative education accountability (AEA), pairing, and campus comparison groups.

District superintendents and accountability administrators who need access to TEASE Accountability are encouraged to apply by completing this form:

The form must be completed, signed by the district superintendent (or equivalent for charter operators), and submitted to Performance Reporting. Depending on the volume of requests, it may take several days for a request to be processed. District staff receive an email from TEA Security once Accountability is added to their TEASE accounts.

PEIMS Coding; Industry Certifications; and the College, Career, and Military Readiness Indicator

When you submit this year's Fall PEIMS and code the class of 2017, you may have noticed that the industry certifications will not be collected for students who were on the Minimum/Recommended/Distinguished Plan. We are aware of the gap between this data collection of only Foundation HS Plan students and the CCMR indicator of a student earning an industry certification.

We encourage districts to note which students are on the former diploma plan in case this indicator affects their 2018 accountability rating enough to warrant an appeal.

What is Performance Reporting's most frequently asked question of all time?

Which students and/or assessment results will be included in my accountability calculations?

Performance Reporting uses the accountability subset to determine district and campus accountability ratings and distinction designations.

A subset of assessment results from both districts and campuses is used to calculate each domain. For 2018 accountability, these test administration periods are considered:

Districts and campuses are responsible for the assessment results for students who meet the accountability subset.
