# What's New in Performance Reporting

### **A–F Development**

This week the U.S Department of Education announced its approval of the <u>state's ESSA plan</u>. The 2018 accountability system is currently in its final stages of development.

The commissioner's final decisions for 2018 accountability are expected to be posted in early April at <u>https://tea.texas.gov/2018AccountabilityDevelopment/</u>. The 2018 Accountability Manual—expected to be published in the *Texas Register* for a 30-day public comment period in late May and effective early August—will provide additional details about the new accountability system.

### **Assessment Scoring and Reporting**

Starting on Friday, March 30, 2018, districts can submit orders for additional printed copies of the Confidential Student Label for the April 2018 STAAR grades 5 and 8 mathematics and reading administration through the STAAR Assessment Management System. To receive the labels on time, orders must be submitted by **April 13, 2018**. Requests for additional copies of the labels received after the deadline may be subject to additional charges and processing fees.

**Reminder:** The STAAR report cards for the April 2018 grades 5 and 8 mathematics and reading administration will be available online only. No printed copies will be sent.

### Local Accountability Systems

This week the commissioner made the following decisions regarding Local Accountability Systems (LAS):

- A district will need to submit a plan for all campuses within a campus type (elementary, middle, high school, K–12, or alternative education campuses).
- A district can choose to only submit a plan for one campus type. For example, a district may choose to submit a plan for elementary campuses within its district but not middle or high schools.
- All campuses in that same campus type must submit the same plan.

These decisions will help districts as they streamline their plans for submission and refine their campus plans during the April LAS meeting.

As mentioned in last week's bulletin, the agency has been fortunate to partner with the Texas Comprehensive Center (TXCC) at the American Institutes for Research (AIR). AIR representatives, including Robyn Madison-Harris, Ed.D., Cheryl Harris, Ph.D., and Shannon Lasserre-Cortez, Ph.D., and TEA staff will continue to work with pilot participants as they create a framework for LAS. We look forward to working closely with them to develop this new accountability system.

# This Week's FAQ

Did the TSI criteria for the SAT change from last year?

The TSI criteria for SAT tests taken prior to 2016 did not change. The Texas Higher Education Coordinating Board adjusted the TSI exemption criteria for SAT tests taken in March 2016 or later. Subsequently, the TSI criteria used in accountability has also been adjusted. The following table shows the TSI criteria for each of the timeframes.

TSI Criteria	
SAT Taken Before March 2016	SAT Taken in March 2016 or Later
>= 500 on Critical Reading and >=1070 Total	>=480 on Evidenced-Based Reading
>= 500 on Mathematics and >=1070 Total	>=530 on Mathematics
