What's New in Performance Reporting

A–F Development

The College, Career, and Military Readiness (CCMR) component in the Closing the Gaps domain differs from the CCMR component in the Student Achievement domain. The denominator used in Closing the Gaps is annual graduates <u>plus</u> students in grade 12 who did not graduate. These grade 12 students are those who were in attendance during the last six weeks of school year 2016– \square , as reported in TSDS PEIMS attendance records.

The indicators included in the Closing the Gaps domain, as well as the domain's construction, align the state accountability system with the Every Student Succeeds Act (ESSA). For federal evaluation, the USDE required the agency to account for all students in grade 12 for CCMR, not just graduates.

Assessment Scoring and Reporting

STAAR April 2018

Reports for the April 2018 State of Texas Assessments of Academic Readiness (STAAR®) grades 5 and 8 mathematics and reading administration are scheduled to be posted on Friday, April 27. STAAR Report Cards, rosters, summary reports, and data files can be accessed through the STAAR Assessment Management System.

Reminder: The STAAR Report Cards for the April 2018 grades 5 and 8 mathematics and reading administration will be available online only. No printed copies will be sent.

The <u>Student Portal</u> will also be updated. Parents can access their child's results using a unique access code, which can be found at the bottom of their child's STAAR Report Card.

The raw score to scale score conversion tables will be posted <u>here</u>.

STAAR May 2018

Districts can submit orders for additional printed copies of the STAAR Report Card and the Confidential Student Label for the spring 2018 STAAR English I, English II, Algebra I, Biology, and U.S. History administrations through the

<u>STAAR Assessment Management System</u> beginning April 27. To receive the additional printed copies of the printed reports, orders must be submitted by **May 11, 2018**. Requests for additional copies of the student reports received after the deadline may be subject to additional charges and processing fees.

This Week's FAQ

How does TEA match Texas Success Initiative assessment (TSIA) results to students?

TEA uses TSIA data through October 2017 to match to the 2016–17 annual graduates file from TSDS PEIMS. TSIA results received from the Texas Higher Education Coordinating Board are matched to students on our annual graduates list using an algorithm which includes TSDS Unique ID, SSN, and a combination of first name, last name, and DOB. Then the results are attributed to the districts and campuses at which the students are identified as annual graduates in TSDS PEIMS.
