## What's New in Performance Reporting

## **Academic Accountability**

As mentioned in the September 14, 2018 weekly bulletin, the PDF version of the Texas Academic Performance Report (TAPR) will be released in the TEA Secure Environment (TEASE) and on the TEA public website shortly after final ratings are released in December. It will be scaled back to only include major, statutorily-required data points.

New this year, a comprehensive online data system, similar to the Texas Performance Reporting System (TPRS) will be produced. The TPRS will no longer be generated; the comprehensive online TAPR System will replace it. Data will be added to the online system as it becomes available. This weekly bulletin will provide information regarding releases within the TAPR System. Each tab within the system will include an accompanying glossary.

#### **Assessment Scoring and Reporting**

Districts can now access the Spring 2018 TELPAS Report Cards, rosters, summary reports, and data files through the TELPAS Assessment Management System at http://www.TexasAssessment.com/TELPAS under Reports > Published Reports. Reports can be accessed via the 2018 TELPAS administration. Printed copies of the report cards and any additional reports requested have been shipped and were scheduled to arrive by October 5, 2018. Final region reports and final region data files have been posted as well.

The TELPAS Reading raw score to scale score conversion tables are posted here.

The Student Portal has been updated with all spring results, including the Spring 2018 TELPAS administration. Parents can access their child's STAAR, STAAR Alternate 2, and TELPAS results using a unique access code, which can be found at the bottom of their child's Report Card. Additionally, parents can view their child's performance relative to the campus, district, and state.

## **Local Accountability Systems**

Local Accountability System (LAS) pilot districts are currently submitting their LAS plans for the 2017–18 school year. TEA staff are in the process of reviewing these plans and providing feedback and suggestions for final submissions. After receiving feedback from TEA, pilot districts were required to submit a final 2017–18 LAS plan by the end of September 2018. The final data, calculations, and grades will be submitted to TEA no later than the middle of October 2018.

Additionally, the LAS team has reached out to districts and ESCs to include additional districts for the developmental year of 2018–19. The districts selected will be in regions that are not currently represented in the first year pilot which are 2, 3, 5, 6, 8, 9, 17, and 20. Interested districts should read about the intent of the statute, LAS decisions, and examples, which are available at <a href="https://tea.texas.gov/las.aspx">https://tea.texas.gov/las.aspx</a>. Districts that have goals, methodologies, and baseline indicators for their components will be preferred but discussed on a case by case basis with TEA. The districts chosen for the 2018–19 year will be required to attend a one day training in Austin in late January 2019. The districts will be required to submit a final LAS plan in early spring 2019 and their data, calculations, and grades by mid-July 2019.

## This Week's FAQ

Students who pass the optional English III EOC and Algebra II EOC are considered (Texas Success Initiative) TSI exempt. Many of these students do not take the TSIA, ACT, or SAT; therefore, they do not meet the TSI requirement in ELA and mathematics through the TSIA, ACT, or SAT. Why don't students who meet the requirements on English III and Algebra II EOCs credit the College, Career, and Military Readiness (CCMR) components in accountability?

Statute (TEC §39.0238 [f][1]) prohibits the use of Algebra II and English III results in accountability calculations; therefore, they may not be used to credit the CCMR component.
