## **General Description:**

The purpose of the Statewide ESC Dyslexia Project is to assist the joint program of coordinators for dyslexia and related disorders services at each regional education service center (ESC) pursuant to Texas Education Code (TEC) §38.003.

Currently, ESC Region 10 receives funding from TEA to coordinate state dyslexia services. Responsibilities include staffing the State Dyslexia Hotline, maintaining the Dyslexia Handbook (available in both English and Spanish), and maintaining the online *Technology Integration for Students with Dyslexia* resource.

### **Authority:**

Texas Education Code (TEC), §38.003, Screening and Treatment for Dyslexia and Other Related Disorders

General Appropriations Act (GAA), Article III, Rider 29, 85th Texas Legislature, 2017

### **Project Objectives:**

- 1. Provide information regarding dyslexia through multiple means to parents, districts, educators, and other stakeholders
- 2. Provide training and support to a dyslexia contacts in each of the 20 ESCs so that they may serve the needs of their constituent districts related to dyslexia programs
- 3. Provide direct training regarding dyslexia to teachers and district administrators from across the state on issues related to identification, laws and rules, teaching strategies, assessments, and diversity
- 4. Implement *Texas Dyslexia Identification Academy* (TDIA) training for ESC dyslexia contacts and district-level dyslexia personnel for regional or district turnaround, as needed
- 5. Complete development, delivery, and marketing of cross-platform application for use with mobile devices that will assist parents of students exhibiting difficulties in reading development and of students identified with dyslexia
- 6. Provide, at the request of TEA, Spanish translation of sample parent letters or forms included in the various dyslexia projects (e.g., Dyslexia Handbook, TDIA, parent application) to provide equal access for Spanish-speaking parents of students exhibiting difficulties in reading development who are referred for assessment of, or identified with, dyslexia and related disorders
- 7. Remain current and connected with researchers in the area of dyslexia in order to provide training and assistance to educators
- 8. Support updates and revisions to the state Dyslexia Handbook (English and Spanish versions), the online tool *Technology Integration for Students with Dyslexia*, the TDIA, and the dyslexia application for mobile devices, as needed
- 9. Develop a list of training opportunities regarding dyslexia as required by new Texas Education Code (TEC) §38.032 (added by House Bill (HB) 1886, 85<sup>th</sup> Texas Legislature
