What's New in Performance Reporting

Academic Accountability

Districts may now view the modeled 2017 Closing the Gaps domain status and data tables in the <u>Texas Education Agency Secure Environment (TEASE</u>) Accountability application. These tables are a new report option located within the 2018 Accountability Reports.

The data shown in these tables are modeled 2017 Closing the Gaps domain data and are for district and campus use only; they will not be released publicly. These tables, along with data in tables from 2018 and 2019, will be used to identify campuses for Targeted Support and Improvement in August of 2019.

Beginning in August 2019, any campus having one or more student group that does not meet Closing the Gaps student group target for three consecutive years (2017, 2018, and 2019) will be identified for Targeted Support and Improvement. As a reminder, this identification is "cell specific," meaning the same student group missed the target in the same indicator for three consecutive years. For example, if the white student group did not meet the target for Academic Achievement in reading three years in a row, that campus would be identified for Targeted Support and Improvement.

Using the modeled 2017 Closing the Gaps domain data table, in conjunction with the 2018 Closing the Gaps domain data table released in August 2018, districts can identify campuses that have the potential for being identified for Targeted Support and Improvement next year. Please note that the modeled 2017 Closing the Gaps domain status and data tables do not include data for the English Language Proficiency (ELP) component. As such, the first year that a campus may be identified for Targeted Support and Improvement due to this indicator is 2020.

By November 16, 2018, districts will be able to download a single PDF that will include all modeled 2017 Closing the Gaps domain status and data tables for their campuses. Excel downloads of these reports will be available in early 2019.

Assessment Scoring and Reporting

The spring 2018 raw score to scale score conversion tables for STAAR, STAAR Alternate 2, and TELPAS are posted <u>here</u>.

The <u>Student Portal</u> has been updated with all spring results. Parents can access their child's STAAR, STAAR Alternate 2, and TELPAS results using a unique access code, which can be found at the bottom of their child's Report Card. Additionally, parents can view their child's performance relative to the campus, district, and state.

Local Accountability Systems

The Local Accountability Systems (LAS) team is seeking additional districts to participate in the LAS developmental year during the 2018–19 school year. Priority will be given to districts located in regions not currently represented in the pilot which are 2, 3, 5, 6, 8, 9, 17, and 20, but Notification of Interest (NOI) forms from all regions will be considered. All interested districts are encouraged to read about the intent of the statute, along with information about current LAS guidelines, which are available at https://tea.texas.gov/las.aspx. The districts chosen for the 2018–19 year will receive assistance developing their LAS plan including a mandatory one-day training in Austin in late January 2019, followed by additional opportunities to receive support and guidance as needed prior to submitting their LAS plan in early spring 2019 and campus ratings by mid-July 2019. Will the "all students" group be evaluated when identifying campuses for Targeted Support and Improvement in 2019?

Yes, beginning in August 2019, any campus having one or more student group, including the "all students" group, that does not meet Closing the Gaps student group target for three

consecutive years (2017, 2018, and 2019) will be identified for Targeted Support and Improvement.
