The State Board of Education approved the per-student costs for administering the state assessments to private school students in the 2013-2014 school year, as recommended by the Committee on School Finance/Permanent School Fund.

(2) Ratification of the Purchases and Sales of the Investment Portfolio of the Permanent School Fund for the Months of August and September 2013 (Board agenda page III-45) (COMMITTEE ON SCHOOL FINANCE/PERMANENT SCHOOL FUND)

The State Board of Education ratified the purchases and sales for the months of August and September 2013 in the amount of \$1,162,479,031 and \$1,111,582,786, respectively, as recommended by the Committee on School Finance/Permanent School Fund.

(3) Review of the Consent Form Related to the Sale of Credit Suisse Private Equity Customized Fund Investment Group (CFIG) (Board agenda page III-47) (COMMITTEE ON SCHOOL FINANCE/PERMANENT SCHOOL FUND)

The State Board of Education approved, subject to continued due diligence by Permanent School Fund staff of appropriate documentation, with respect to the Columbia CS Fund L.P., to consent to the change of control of the general partner and the investment manager from Credit Suisse controlled entities to Grosvenor controlled entities and the transfer of the financial obligation from Credit Suisse (USA) to Grosvenor Capital Management, L.P., as recommended by the Committee on School Finance/Permanent School Fund.

### (4) Decision on Real Estate Investments

(Board agenda page III-49) (COMMITTEE ON SCHOOL FINANCE/PERMANENT SCHOOL FUND)

The State Board of Education approved execution of agreements with Blackstone Real Estate Advisors L.P. necessary to make an investment commitment of up to \$75 million in Blackstone Real Estate Partners Europe IV, L.P. subject to continued due diligence and negotiation of fund terms; and, approved to execute agreement(s) with Tristan Capital Partners LLP, necessary to make an investment commitment of up to  $\epsilon$ 60 million in European Property Investors Special Opportunities 3, L.P., a euro denominated fund, subject to continued due diligence and negotiation of fund terms, to approve the relationship between Tristan and LAZARD FRÉRES & Co., LLC & Co., LLC, after determining it meets the standards of 19 TAC Chapter 33, Section (j)(5), which has been disclosed in writing, and also, to approve a waiver of the PSF Real Estate Investment Policy Statement requirement for the investment manager (Tristan) to be a registered investment advisor with the Securities Exchange Commission, as recommended by the Committee on School Finance/Permanent School Fund.

### **COMMITTEE OF THE FULL BOARD**

(Mr. Bradley and Mr. Cortez were absent for the vote.)

## 5. Proposed Revisions to 19 TAC Chapter 74, <u>Curriculum Requirements</u>, Subchapter B, <u>Graduation Requirements</u>

(First Reading and Filing Authorization) (Board agenda page I-61)

**<u>MOTION</u>**: It was moved by Mr. Ratliff to approve for first reading and filing authorization proposed revisions to 19 TAC Chapter 74, <u>Curriculum Requirements</u>, Subchapter B, <u>Graduation Requirements</u>, as recommended by the Committee of the Full Board.

**<u>MOTION AND VOTE</u>**: It was moved by Mr. Ratliff, seconded by Ms. Hardy, and carried to amend §74.13(e)(4), as follows:

- (4) Arts and humanities. A student may earn an arts and humanities endorsement by completing the requirements specified in subsection (d) of this section [including Algebra II, English IV, world history and world geography] and:
- (Mr. Bradley and Mr. Cortez were absent for the vote.)

**MOTION AND VOTE**: It was moved by Mr. Ratliff, seconded by Ms. Hardy, and carried to amend  $\S74.13(e)(4)(A)$ , as follows:

(A) four [College Board advanced placement or International Baccalaureate] social studies courses by selecting courses from Chapter 113 of this title or Chapter 118 of this title (relating to Texas Essential Knowledge and Skills for Economics with Emphasis on the Free Enterprise System and Its Benefits); or

(Mr. Bradley and Mr. Cortez were absent for the vote.)

- (B) four levels of the same language in a language other than English; or <u>two languages</u> other than English in one language and two languages other than English in a second language; or
- (Mr. Bradley and Mr. Cortez were absent for the vote.)

Ms. Ramos reminded the board that during the Committee of the Full Board meeting an amendment was made to add two levels of the same language in a language other than English and two levels in a different language other than English.

Mr. Ratliff withdrew his amendment, without objection from board members.

- (D) a coherent sequence of four <u>credits</u> [courses in art] by selecting courses <u>in fine arts</u> from Chapter 117 of this title or innovative courses approved by the commissioner; or
- (Mr. Bradley and Mr. Cortez were absent for the vote.)

- [(E) a coherent sequence of four courses in dance by selecting courses from Chapter 117 of this title or innovative courses approved by the commissioner; or
- (F) a coherent sequence of four courses in music by selecting courses from Chapter 117 of this title or innovative courses approved by the commissioner; or
- (G) a coherent sequence of four courses in theatre by selecting courses from Chapter 117 of this title or innovative courses approved by the commissioner.]
- (Mr. Bradley and Mr. Cortez were absent for the vote.)

- (E) A combination of four credits from two or more of the following categories that are a coherent sequence for the student's academic or career goals, as documented on the student's personal graduation plan: art, dance, music and theatre.
- (Mr. Bradley and Mr. Cortez were absent for the vote.)

**<u>MOTION</u>**: It was moved by Mr. Ratliff and seconded by Ms. Hardy to amend <sup>574.13</sup> by adding reference to Chapter 126 to the end of subsection(e)(2)(A)(iii).

Ms. Ramos explained that a coherence sequence of courses in Chapter 126 is already an option for students to earn an endorsement under STEM.

Mr. Ratliff withdrew his motion, without board objection.

**MOTION AND VOTE**: It was moved by Mrs. Bahorich, seconded by Mr. Ratliff, and carried to amend §74.13(e) to clarify CTE references by changing "a coherent sequence of four courses" to "a coherent sequence of three or more courses for four or more credits." (Mr. Bradley and Mr. Cortez were absent for the vote.)

**<u>VOTE</u>**: A vote was taken on the motion to approve for first reading and filing authorization proposed revisions to 19 TAC Chapter 74, <u>Curriculum Requirements</u>, Subchapter B, <u>Graduation Requirements</u>, as amended. The motion carried. (Mr. Bradley and Mr. Cortez were absent for the vote.)

6. Report and Recommendations from the Commissioner of Education Regarding Instructional Materials Offered for Adoption under Proclamation 2014 (Board agenda page I-95)

**<u>MOTION</u>**: *It was moved by Mr. Ratliff that the State Board of Education:* 

Require that all publishers make corrections listed in the Report Concerning Required Corrections of Factual Errors;

Require that all instructional materials meet established manufacturing standards and specifications;

Approve changes and corrections in response to written comments and public testimony;

Place the instructional materials submitted for adoption on the adopted list as indicated on the Proclamation 2014 List of Instructional Materials to be Considered for Adoption, and reject instructional materials as indicated on the Proclamation 2014 List of Instructional Materials to be Considered for Rejection;

Delegate to a committee of three board members – Mrs. Cargill (the board chair), Mrs. Melton-Malone, and Dr. Dominguez – to select three experts to resolve within four weeks the alleged errors found in <u>Pearson Biology</u>, <u>Texas Edition-Student Edition</u> and <u>Pearson</u> <u>Biology</u>, <u>Texas Edition-Student eText</u>. If the alleged errors are resolved to the satisfaction of the experts, the instructional materials will be considered adopted. If they cannot be resolved, the instructional materials will be withdrawn or returned to the board for its consideration in January. **<u>MOTION AND VOTE</u>**: It was moved by Mr. Ratliff, seconded by Ms. Hardy, and carried to amend the motion by adding the following language:

Each special committee member shall appoint an expert that (1) did not serve on the original panel; and, (2) has at least a Ph.D. in a related field of study. The approval required by the experts is not unanimous approval but a majority opinion of the three experts.

(Mr. Bradley and Mr. Cortez were absent for the vote.)

**<u>VOTE</u>**: *A vote was taken on the main motion, as amended. The motion carried. (Mr. Bradley and Mr. Cortez were absent for the vote.)* 

**MOTION**: It was moved by Mr. Ratliff that the State Board of Education approve Houghton Mifflin Harcourt's <u>Environmental Science Digital Solution</u> and <u>Environmental Science</u> <u>Print/Digital Solution</u> contingent upon the publisher making changes according to the memo titled Houghton Mifflin Harcourt Response to Written Comments from Becky Berger.

**MOTION AND VOTE**: It was moved by Mr. Maynard and carried to amend the motion by adding the words "and in response to the memo from Leslie Savage, chief geologist for the Oil & Gas Division of the Railroad Commission of Texas." (Mr. Bradley and Mr. Cortez were absent for the vote.)

**<u>VOTE</u>**: A vote was taken on the motion that the State Board of Education approve Houghton Mifflin Harcourt's <u>Environmental Science Digital Solution</u> and <u>Environmental Science</u> <u>Print/Digital Solution</u> contingent upon the publisher making changes according to the memo titled Houghton Mifflin Harcourt Response to Written Comments from Becky Berger, as amended. The motion carried. (Mr. Bradley and Mr. Cortez were absent for the vote.)

7. Proposed Amendments to 19 TAC Chapter 66, <u>State Adoption and Distribution of Instructional Materials</u>, Subchapter B, <u>State Adoption of Instructional Materials</u> (First Reading and Filing Authorization) (Board agenda page I-99)

Because of time constraints, this item was not considered during the Committee of the Full Board meeting held the previous day.

John Lopez, managing director, instructional materials and educational technology, explained that the proposed amendments to this chapter would update and clarify specific processes for the review and adoption of instructional materials.

**<u>MOTION</u>**: It was moved by Mrs. Melton-Malone and seconded by Ms. Hardy to approve for first reading and filing authorization proposed amendments to 19 TAC Chapter 66, <u>State</u> <u>Adoption and Distribution of Instructional Materials</u>, Subchapter B, <u>State Adoption of Instructional Materials</u>.

**MOTION AND VOTE**: It was moved by Mr. Ratliff, seconded by Ms. Perez, and carried to amend §66.33(a), as follows:

(a) The commissioner of education shall determine the number of review panels needed to review instructional materials under consideration for adoption, determine the number of persons to serve on each panel, and determine the process for selecting panel members. Each appointment to a state review panel shall be made by the commissioner of education with priority given to qualified individuals that are nominated by State Board of Education (SBOE) members. The commissioner of education shall make appointments to state review panels to achieve diversity to the extent possible and to ensure that each team has members with sufficient content expertise and experience [-] that ensure participation by academic experts in each subject area for which instructional materials are being considered. The appointments shall include educators, parents, business and industry representatives, and employers. The role of each appointee shall be designated and disclosed to all appointees on each panel.

**MOTION**: It was moved by Mr. Cortez and seconded by Dr. Dominguez to amend §66.33(a), as follows:

(a) The commissioner of education shall determine the number of review panels needed to review instructional materials under consideration for adoption, determine the number of persons to serve on each panel, and determine the process for selecting panel members. Each appointment to a state review panel shall be made by the commissioner of education with priority given to <u>content-relevant and current educators and professors [qualified individuals</u>] that are nominated by State Board of Education (SBOE) members. The commissioner of education shall make appointments to state review panels to achieve diversity to the extent possible and to ensure that each team has members with sufficient content expertise and experience that ensure participation by academic experts in each subject area for which instructional materials are being considered. The appointments shall include educators, parents, business and industry representatives, and employers. The role of each appointee shall be designated and disclosed to all appointees on each panel.

<u>MOTION AND VOTE</u>: It was moved by Mrs. Melton-Malone, seconded by Dr. Dominguez, and carried to amend Mr. Cortez's motion by deleting the words "and current".

Mr. Cortez withdrew his motion, without objection from Mrs. Melton-Malone and board members.

**MOTION AND VOTE**: It was moved by Mr. Rowley, seconded by Mr. Cortez, and carried to amend §66.33(a), as follows:

(a) The commissioner of education shall determine the number of review panels needed to review instructional materials under consideration for adoption, determine the number of persons to serve on each panel, and determine the process for selecting panel members. Each appointment to a state review panel shall be made by the commissioner of education with priority given to qualified individuals that are nominated by State Board of Education (SBOE) members. The commissioner of education shall make appointments to state review panels to achieve diversity to the extent possible and to ensure that each team has members with sufficient content expertise and experience that ensure participation by academic experts in each subject area for which instructional materials are being considered giving priority to content-relevant educators and professors. The appointments shall include educators, parents, business and industry representatives, and employers. The role of each appointee shall be designated and disclosed to all appointees on each panel.

**<u>MOTION</u>**: It was moved by Dr. Dominguez and seconded by Mr. Rowley to amend §66.33(a), by reinserting the following previously deleted language: <u>the advice and consent of the State</u> Board of Education (SBOE) member whose district is to be represented.

Dr. Dominguez withdrew her motion, without objection from board members.

**MOTION**: It was moved by Ms. Perez and seconded by Ms. Dominguez to amend §66.33(a), as follows:

*(a)* The commissioner of education shall determine the number of review panels to include the current citizen review panels and a secondary expert panel needed to review instructional materials under consideration for adoption, determine the number of persons to serve on each panel, and determine the process for selecting panel members. The expert panel shall serve as an appellate panel to citizen review panels should concerns be raised with regard to content. Each appointment to a state review panel shall be made by the commissioner of education with priority given to qualified individuals that are nominated by State Board of Education (SBOE) members. The commissioner of education shall make appointments to state review panels to achieve diversity to the extent possible and to ensure that each team has members with sufficient content expertise and experience that ensure participation by academic experts in each subject area for which instructional materials are being considered giving priority to content relevant educators and professors. The appointments shall include educators, parents, business and industry representatives, and employers. The role of each appointee shall be designated and disclosed to all appointees on each panel.

**MOTION AND VOTE**: It was moved by Mr. Bradley to move the previous question. The motion carried by a two-thirds vote.

**<u>VOTE</u>**: A vote was taken on Ms. Perez's motion. The motion failed.

**MOTION AND VOTE**: It was moved by Mr. Rowley, seconded by Mr. Cortez, and carried to amend §66.33(a), as follows:

(a)The commissioner of education shall determine the number of review panels needed to review instructional materials under consideration for adoption, determine the number of persons to serve on each panel, and determine the process for selecting panel members. Each appointment to a state review panel shall be made by the commissioner of education with priority given to qualified individuals that are nominated by State Board of Education (SBOE) members. Any SBOE member may veto the placement of a review panel member from his or her district upon written objection of said SBOE The commissioner of education shall make appointments to state review member. panels to achieve diversity to the extent possible and to ensure that each team has members with sufficient content expertise and experience that ensure participation by academic experts in each subject area for which instructional materials are being considered giving priority to content relevant educators and professors. The appointments shall include educators, parents, business and industry representatives, and employers. The role of each appointee shall be designated and disclosed to all appointees on each panel.

**<u>MOTION</u>**: It was moved by Mr. Ratliff and seconded by Dr. Dominguez to amend  $\frac{66.36(a)(1)(B)}{66.36(a)(1)(B)}$ , as follows:

(B) State review panel members must participate in a team during the review and reach a consensus, or a simple majority if the panel members are unable to reach consensus, to determine whether the TEKS have been covered sufficiently in the instructional materials. <u>If consensus is not reached, the panel may adopt majority or</u> <u>minority reports that disclose which member or members support or oppose the</u> <u>panel member's findings.</u>

The State Board of Education recessed at 12:03 p.m., and reconvened at 12:30 p.m.

**<u>MOTION AND VOTE</u>**: It was moved by Mr. Maynard, seconded by Mr. Ratliff, and carried to postpone action on the pending amendment until 2 p.m.

At 2 p.m., the State Board of Education continued consideration of Mr. Ratliff's pending amendment.

Mr. Ratliff withdrew his motion to amend §66.36(a)(1)(B), without board objection.

**<u>MOTION AND VOTE</u>**: It was moved by Mr. Maynard, seconded by Mr. Ratliff, and carried to amend  $\S66.36(a)(1)$  by adding a new subparagraph (C), as follows:

(C) <u>A member of the panel shall be designated as a recording secretary who shall keep</u> minutes of all panel deliberations in a format determined by the commissioner. <u>Consensus and minority concerns shall be reflected in the minutes with the objectors</u> <u>identified by team role only.</u> **<u>MOTION</u>**: It was moved by Mr. Maynard to postpone further consideration of this item until the January board meeting.

There being no objection from board members, Mrs. Cargill stated this item would be considered for second reading at the January board meeting.

**<u>VOTE</u>**: A vote was taken on the motion to approve for first reading and filing authorization proposed amendments to 19 TAC Chapter 66, <u>State Adoption and Distribution of Instructional</u> <u>Materials</u>, Subchapter B, <u>State Adoption of Instructional Materials</u>, as amended. The motion carried.

# 8. Amendments to Proclamation 2015 of the State Board of Education Advertising for Bids on Instructional Materials

(Board agenda page I-103)

This item was not considered during the Committee of the Full Board meeting, because of time constraints.

Mr. Lopez presented proposed amendments to Proclamation 2015, which included updates to requirements related to accessible instructional materials.

**MOTION AND VOTE**: It was moved by Mrs. Bahorich and seconded by Mr. Maynard to include the language, "All electronic samples provided to the state review panels must include a search feature that allows reviewers to locate key words in the content. The search feature must be fully operational when samples are submitted. Electronic samples sent to the review panels that do not include a fully operational search feature will not be reviewed, and those products will not be considered for adoption." The motion failed. (Mr. Bradley, Mr. Cortez, Mrs. Melton-Malone, and Mr. Mercer were absent for the vote.)

The board directed TEA staff to contact publishers to determine the feasibility of requiring a search feature in electronic samples and requiring a common End User License Agreement (EULA) to access web-based samples.

**MOTION AND VOTE**: It was moved and carried unanimously that the State Board of Education amend Proclamation 2015 of the State Board of Education Advertising for Bids on Instructional Materials as proposed. (Mr. Bradley, Mr. Cortez, Mrs. Melton-Malone, and Mr. Mercer were absent for the vote.)
