Call to Order

Sheri Messer, TEA, called the meeting to order at 1:00 p.m.

2. Public Comment

There were no public comment registrations.

3. School Liaison Panel: the role of the school liaison

- Mrs. Messer introduced the panelist of school liaisons.

- Ms. Hendricks gave an overview of the role of the school liaison. The panelists explianed how they support military connected-students and families, school districts, and installations. The panelists explained the supports and programs they use in their work and services they provide to parents and educators. They also described some of the challenges they encounter in their work and challenges students encounter as they transition to new schools.

4. Staff Reports

- Ms. Ramos gave general information about the upcoming Military Interstate Childrens Compact Commission (MIC3) 2023 Annual Business Meeting and explained that she would provide a debrief of the meeting at the January 22, 2024, State Advisory Council meeting.
- Mrs. Messer shared a social media post that was posted on October 20, 2023, to share information about the State Advisory Council.
- Mrs. Messer presented data from the Military Compact district trainings that TEA has conducted since July 2023. The report showed that the trainings had reached approximately 750 educators across Texas.
- Mrs. Messer presented information about council member term lengths collected from other Texas state advisory councils. Ms. Ramos explained that certain positions on the council are designated by other offices or are tied to an individual's job responsibilities. Individuals in those positions serve until there is a change in post or they step down. Ms. Ramos suggested that for positions on the council that are not designated, the council may wish to consider an appropriate term length. She presented for consideration varying length terms for these council positions.
 - Dr. Craft made a motion that the membership for certain positions not appointed would serve two-year terms with the option to extend one year.
 Terms would be staggered so each year that term are to end, only up to one half of the membership for non-appointed positions would be new.

- o Dr. Roper seconded the motion.
- The motion carried unanimously.
- Dr. Bowser presented an update on relevant new legislation, Purple Star Campus designations, and the military student identifier (MSI).
- Ms. Ramos presented on the implementation of new legislation, Senate Bill 1008, relating to establishing residency for purposes of admission into public schools.
- The floor was open to council members to share any state advisory council-related announcements, topics, or issues. No council members shared.

5. 2024 Council Priorities

 Mrs. Messer initiated a conversation about the priorities the council would like to direct attention to for the upcoming year, 2024. The council determined that parents, registrars, and school principals could be better informed about the Military Compact. Mrs. Messer will provide additional information about these priorities at the January meeting.
