#### 1. Call to Order

- Jessica Snyder, TEA, called the meeting to order at 1:00 p.m.

#### 2. Public Comment

- There were no public comment registrations.

### 3. Introduction of new member(s)

Jessica Snyder, Texas Education Agency, Senior Director, Curriculum Standards and Student Support (CSSS) Division introduced herself as the new Compact Commissioner, effective earlier this month. She provided a brief overview of her previous roles, including 9 years as a classroom teacher before joining the Texas Education Agency in 2010.

## 4. Discussion of council membership

- Ms. Snyder recapped her notes from viewing recordings of the council's prior discussions about adding an ex-officio member(s) to the council from an organization that supports military families and students or from the National Guard/Reserve. She explained that she would bring the subject to a vote at the next meeting in January 2025.
- Ms. Snyder stated that the council is wrapping up its second year of operation. She explained that section 2.1(d) and (e) of the council's operating procedures state that certain member terms end after two years of service but have the option of a one-year extension. Ms. Snyder said she will send communication to those members whose terms will be ending to determine whether the individual wishes to extend their term for one year or step down from the council.

- 5. Council member and staff reports
  - Kelly Kravitz, from the Office of Special Populations & Student Supports (OSPSS) Highly Mobile and At-Risk Student Programs Unit shared the following updates about her unit's activities and data for military students in Texas that her unit is compiling.
    - Ms. Kravits shared that the 2024-2025 Purple Star Campus Designation (PSCD) application review process is wrapping up.
      - o 542 campuses awarded the designation Published 9/19/24
      - o Designations saw a 202% increase from 2023-24 PSCD
      - o 72% of awardees are earning PSCD for the first time.
      - A To The Administrator Addressed (TAA) announcing designations was published 9/19/24
      - The Office of the Governor issued a press release on 9/19/24
    - Ms. Kravitz explained that PSCD is a two-year designation after which campuses must reapply. She presented the following criteria for a campus to be identified as a Purple Star Campus:
      - Campus-based military liaison onsite
      - Web page for military-connected families
      - Student-led campus transition program
      - Professional development for staff
      - Participation in at least one of three special initiatives to support militaryconnected students and families
  - Jessica Snyder, Compact Commissioner, shared an update from the Curriculum Standards and Student Support Division.
    - Sheri Messer, former Curriculum Specialist in the Curriculum Standards and Student Support Division, conducted a Military Compact training with El Paso Area Directors of Guidance (EPADOG) in August. Ms. Snyder attended the MIC3 Annual Business Meeting (ABM) in Albuquerque, New Mexico, on October 16-17.
    - Topics of discussion at the ABM included a proposed increase to the annual dues. Ms.
      Snyder stated that she had requested additional information to share with the council members.
