### **ASVAB Required Reporting 2024-2025 School Year**

# Introduction

This report fulfills Texas Education Agency (TEA) requirements of <u>Senate Bill (SB) 1843</u> (85th Texas Legislature, Regular Session, 2017). Specifically: "Not later than August 1 of each year, the agency shall publish a list of school districts and open-enrollment charter schools that elected under Subsection (d) or (e) not to provide the Armed Services Vocational Aptitude Battery test during the previous school year."

#### **Notes**

- 1. The data included in this report were reported to the TEA through the 2024-2025 PEIMS fall data submission.
- 2. Districts and open-enrollment charter schools report the data in data element C217 (ARMED-SERVICES-VOC-APT-BATTERY-INDICATOR-CODE).<sup>1</sup>
- 3. Districts and open-enrollment charter schools serving students in grades 10-12 that are not included in this report did not certify the C217 data element in the 2024-2025 fall data submission. These districts' ASVAB or alternative test status are unknown by TEA.
- 4. There is no alternative data or errata reporting method.
- 5. Districts and open-enrollment charter schools who did not certify C217 in the 2024-2025 fall data submission but did offer the ASVAB or alternative test to students in grades 10-12 should consider maintaining local records of offering the ASVAB or alternative test available to students.<sup>2</sup> Staff should work annually to schedule time to meet this reporting requirement in future school years.
