

Introduction to Proclamation 2024 Chat Questions and Answers

Q: Will the future webinar dates be shared again at the end of the presentation?

A: Yes, we can definitely do that!

Q: What are due dates for titles with **?

A: We will share that in later slides, and you can see them in the proclamation.

Q: Do we know when in the summer the Publishers' Handbook will be shared?

A: We are working to finalize it now and hope to make it available in the next two to three weeks.

Q: Has the SBOE officially approved Proclamation 2024?

A: Yes, they issued Proclamation 2024 at the April 2022 meeting.

Q: Amie, how soon can publishers submit an intent to bid?

A: We have not yet set up EMAT to receive the statement of intent to bid, but we will work to do so before the July and August subject-specific webinars.

Q: Preliminary correlations are for 100% of the standards for that one product and course?

A: Preliminary correlations are typically about 5% of the correlations for a single course/grade level.

Q: Did I miss it being said when breakouts are available?

A: We are still working to create the breakouts, and plan to release them in batches as soon as they are ready. Once we have released the breakouts and have EMAT set up to receive SOITBs, you will be able to start entering correlations.

Q: Would there be an opportunity to discuss an API to allow correlations to be uploaded, rather than hand-entered? Hand-entry introduces a significant opportunity for errors and inaccuracies.

A: We are working with the vendor who manages the standards-alignment dashboard to consider ways to streamline the data entry process for correlations.

Q: thanks. are we talking weeks or months for the breakouts to be ready?

A: Re: breakout availability--We hope to have the breakouts for courses adopted in April available in the next few weeks. It will be a couple of months before the breakouts are available for courses adopted this month.

Q: Do pre-adoption samples need to be on the platform that will house the final program?

A: A: Re: platform--You do not necessarily have to host the pre-adoption sample on the platform you plan to use in the final version; however, you are supposed to submit a fully functional pre-adoption sample that includes all content and capabilities intended to be included with the final version.

Q: Are correlations to breakout standards required and uploaded through same portal?

A: All correlations to breakouts are entered in the standards-alignment dashboard.

Q: Are TEKS for courses adopted this month now available on TEA website?

A: The only version of the June TEKS I can find is what was provided to the SBOE at the meeting.
