

Introduction


The Highly Mobile and At-Risk (HMAR) webpages serve as a centralized resource for Texas school systems (e.g., districts and charter schools), stakeholders, families, and community members to access critical information, tools, and guidance related to supporting students experiencing homelessness, in foster care, or facing other high mobility challenges.

These webpages are designed to help school systems fulfill federal and state requirements, streamline communication, and ensure that designated liaisons and other key stakeholders are equipped to remove barriers to enrollment, attendance, and academic success. By navigating these pages effectively, school systems and stakeholders can maintain compliance, strengthen support systems, and promote educational stability for some of the state's most vulnerable student populations.








Student Services

This section outlines the core supports available to students who are experiencing homelessness, helping school systems remove barriers and promote educational stability. Each service area includes guidance, tools, and data to assist liaisons and staff in implementing effective supports.

How to Use It:

- Explore each service category to understand its role in supporting McKinney-Vento eligible students.

Key Service Areas:

- <u>Homeless Student Identification Data/Infographics</u> Visual tools and data to support awareness and identification efforts.
- <u>Homeless Student Enrollment</u> Guidance on immediate enrollment rights and removing documentation barriers.
- <u>Homeless Student School Determination</u> Support for determining the best school placement based on student needs and stability.
- <u>Dispute Resolution</u> Procedures and templates for resolving enrollment or eligibility disagreements.
- <u>Transportation</u> Strategies and requirements for ensuring access to school of origin or appropriate placement.
- <u>Title I Services</u> Information on how Title I funds can be used to support homeless students academically and socially.

- Share with campus administrators and legal teams to support district-wide compliance.


Local and Regional McKinney-Vento Liaisons

This directory helps users locate local homeless liaisons designated to support McKinney-Vento eligible students. These individuals are critical points of contact for identification, enrollment, and service coordination. How to Use It:

- Search by district or region to find your liaison.
- Use contact information to initiate collaboration or request support.
- Ensure your school system's liaison information is current in AskTED.

Regional liaisons provide technical assistance and program guidance across Texas. They serve as a bridge between TEA and local school systems. How to Use It:

- Contact your regional liaison for help with implementation, compliance, or training.
- Collaborate on regional initiatives or professional learning events.
- Use this support to troubleshoot complex student scenarios or program questions.






Professional Development

- Share relevant sessions with campus teams, counselors, and administrators to promote consistent understanding and implementation of McKinney-Vento supports.

This section is ideal for onboarding new staff, refreshing knowledge, and deepening expertise in serving students experiencing homelessness.




Resources






Guidance for Navigating the Foster Care & Student Success Webpage

Program Overview


Start here to understand the mission of the Foster Care and Student Success initiative, housed within TEA's Highly Mobile and At-Risk (HMAR) Unit. This section outlines the program's commitment to improving academic, social, and emotional outcomes for students in foster care.

Professional Learning & Support Opportunities

Access current and upcoming training events, including webinars. These sessions offer expert insights and collaborative learning to help educators and support staff build capacity. A downloadable calendar is available to help plan your participation.

Coordinated Care & Points of Contact

Learn about the roles of Foster Care Liaisons, ESC Foster Care Champions, and DFPS Regional Education Specialists. This section emphasizes cross-system collaboration and provides contact information to support coordinated services.



School System's Foster Care Points of Contact (POC)

Each school district and charter school must designate a Foster Care Liaison to support enrollment, advocacy, and coordination of services. Liaisons work with internal departments and external partners to ensure students in foster care receive appropriate support. Contact information must be submitted to TEA via AskTED and reviewed annually.

ESC Foster Care Champions

Every Education Service Center (ESC) has a volunteer Foster Care Champion who serves as a regional point of contact. Champions may offer professional development, host collaborative forums, and support cross-agency efforts. Their contact information is available in AskTED and via a downloadable PDF.



DFPS Regional Education Specialists

Each DFPS region has at least one Education Specialist who acts as a liaison between child welfare and education systems. These specialists assist with best-interest decisions, transportation, dispute resolution, and ESSA coordination. They are valuable partners for building local collaboration and accessing training.

Cross-System Collaboration: Guiding Principles

This section outlines eight guiding principles that support collaboration between education, child welfare, and community partners to improve outcomes for students in foster care. These principles promote school stability, smooth transitions, full participation, and long-term success.

Strategic Partnerships Supporting Foster Youth in Texas Schools

Texas improves foster youth outcomes through cross-system collaboration. The Texas Blueprint Task Force—led by TEA, courts, and child welfare—focuses on school stability, training, and data. The Texas Blueprint outlines strategies across readiness, transitions, school experience, and post-secondary success. The Texas Trio (TEA, DFPS, Children's Commission) continues this work, modeling effective statewide collaboration.

The PRS webpage provides essential guidance and resources to help Texas school systems support pregnant and parenting students. PRS aims to reduce dropout risks and promote academic success through targeted services.

Program Overview

Start here to understand the purpose and goals of PRS. This section introduces the program's focus on helping pregnant and parenting students stay enrolled and succeed through academic instruction and wraparound services. Use this section to get a quick understanding of what PRS is and why it matters.

PRS Guidance

Use this section to learn when PRS services apply, what districts are required to offer (especially CEHI), and how PRS supports students academically and emotionally. It also outlines funding rules and links to official guidance documents. This is your go-to for understanding the structure and compliance requirements of PRS.

PRS Documentation Checklist Overview

Use the checklist to track student eligibility, service timelines, and required documentation. It helps ensure that all records—medical forms, CEHI logs, and attendance—are complete and aligned with state rules. This section is especially useful for district staff managing PRS compliance and funding.

Compensatory Education Home Instruction (CEHI)

This section explains how CEHI works as the required academic service under PRS. Use it to understand who delivers CEHI, how instruction is logged, and what qualifies for PRS coding. It's essential for ensuring students receive proper instruction when they can't attend school and for securing PRS funding.

Support Services

Use this section to explore optional services that districts may offer alongside CEHI, such as counseling, transportation, parenting education, and childcare. These services help students stay engaged and supported beyond academics. This section is helpful for building a more comprehensive support plan for students.

Pregnancy-Related Services Rules

Use this section to review the official rules for PRS and CEHI found in Section 9 of the Student Attendance Accounting Handbook. It helps ensure your district is meeting eligibility, documentation, and funding requirements accurately.

General State Waivers for PRS CEHI

Use this section to learn how to apply for a waiver that allows CEHI to be delivered on campus during the postpartum period. It outlines the purpose of the waiver, how long it can last, and what responsibilities districts must meet to maintain compliance.

Serving Pregnant Students Receiving Special Education Services

Use this section to understand how to coordinate PRS with special education services. It provides guidance from Chapters 4 and 9 of the Student Attendance Accounting Handbook and includes a flow chart to help with decision-making and proper coding.

The Texas Education Agency is dedicated to ensuring military-connected students thrive academically and socially by offering targeted resources, fostering statewide partnerships, and addressing the unique challenges these students face, such as frequent relocations and parental deployments.

The Commissioner of Education warmly welcomes military families to Texas, affirming the state's commitment to providing high-quality education and support tailored to the needs of military-connected children as they transition into new schools and communities.

Military-Connected Student and Family Resources

General Resources

Non-academic Supports and Enrichment

National Guard, Reserve, and Veterans

Provides targeted programs for dependents of National Guard members and veterans, including STEM education, leadership camps, and access to veteran family services.

Purple Star Campus Designation (PSCD)

The Purple Star Campus Designation honors Texas schools that go above and beyond in supporting military-connected students through dedicated staff, tailored transition programs, and visible campus initiatives. Campuses meeting the criteria receive formal recognition and are featured on TxSchools.gov.

The Dropout Prevention in Texas webpage serves as a central hub for educators, administrators, and stakeholders working to reduce dropout rates and improve student outcomes. Latest Dropout Data

Understanding current dropout trends helps districts and schools identify where support is most needed. This section provides the most recent statewide dropout statistics, including longitudinal and annual rates, offering insight into progress and areas for improvement.

Calculating Dropouts

Accurate data ensures accountability and informs effective interventions. Texas uses a nationally recognized method (NGA Compact Rate) to calculate dropout rates, ensuring consistency and transparency. This section explains how student cohorts are tracked and how dropout rates are determined.

Dropout Prevention Strategy Plan

Required for districts with high dropout rates, this plan drives targeted action. Districts and charters must submit a strategy plan detailing how they will use state funding to implement evidence-based dropout prevention strategies. This ensures that resources are aligned with student needs.

Proven Dropout Recovery and Prevention Strategies

Offers actionable tools for schools to reduce dropout rates and re-engage students. This section highlights research-based practices such as early intervention, flexible learning environments, and strong family engagement—strategies proven to help students stay in school and graduate.
