The purpose of this correspondence is to notify the Como-Pickton Consolidated Independent School District (CISD) of the correction of noncompliance identified in the Cyclical Desk Review.

Como-Pickton CISD received notification of noncompliance in a letter dated 1/31/2023 listing the following areas of noncompliance:

- IEP Development: Measurable Annual Goals 34 Code of Federal Regulations (CFR) §300.320(a)(3)(i)
- Properly Constituted ARDs: ARD Committee Membership 19 Texas Administrative Code (TAC) § 89.1050(c)(1)(l)
- Properly Constituted ARDs: IEP Team Attendance
 34 CFR §300.321(e)(3)(2); 34 CFR §300.321(a)(2)-(a)(5)

A plan for correction of the noncompliance was included in your corrective action plan. Subsequently, the local education agency (LEA) was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the issues of noncompliance noted above. The documentation submitted by the LEA indicated that these areas of
