Dear Mr. Larry Markert:

The purpose of this correspondence is to notify the Prairie Lea Independent School District (ISD) of the correction of noncompliance identified in the Cyclical Desk Review.

Prairie Lea ISD received notification of noncompliance in a letter dated 7/27/2023 listing the following areas of noncompliance:
