Dear Mr. Chris Sodek:

The purpose of this correspondence is to notify the Flatonia Independent School District (ISD) of the correction of noncompliance identified in the Cyclical Desk Review.

Flatonia ISD received notification of noncompliance in a letter dated 7/27/2023 listing the following areas of noncompliance:

- Individualized Education Program (IEP) Development: Present Levels of Academic Achievement and Functional Performance (PLAAFP)
 - Chapter 34 Code of Federal Regulations (CFR) § 300.320(a)(1)
- Properly Constituted Admission, Review, Dismissal (ARD) Committee Meetings: Language Proficiency Assessment Committee (LPAC) representative
 - 19 Texas Administrative Code (TAC) §89.1050(c)(1)(I)
- Transition-Initial Transition by 14
 19 TAC §89.1055(h); TEC §29.0111

A plan for correction of the noncompliance was included in your corrective action plan. Subsequently, the local education agency (LEA) was required to submit documentation to
