Subject: Notification of Correction of Noncompliance

Dear Mr. Clifton James Womack:

The purpose of this correspondence is to notify the Richland Springs Independent School District (ISD) of the correction of noncompliance identified in the **Cyclical Desk Review**.

Richland Springs ISD received notification of noncompliance in a letter dated 4/28/2023 listing the following areas of noncompliance:

- IEP Development: Development of Present Levels of Performance of Academic and Functional Performance (PLAAPF)  
**34 Code of Federal Regulations (CFR) §300.320(a)(1)**
- Transition: Initial Transition held prior to the student's 14<sup>th</sup> birthday  
**Texas Education Code (TEC) §29.011; 19 Texas Administrative Code (TAC) §89.1055(h)**
- Transition: Transfer of Rights  
**TEC §29.017(c); 19 TAC §89.1049(a)**

A plan for correction of the noncompliance was included in your corrective action plan. Subsequently, the local education agency (LEA) was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the abovementioned noncompliance. The documentation submitted by the LEA indicated that this area of
