Subject: Notification of Correction of Noncompliance

Dear Mr. Gary Laramore:

The purpose of this correspondence is to notify the Iraan-Sheffield Collegiate Independent School District (ISD) of the correction of noncompliance identified in the Cyclical Desk Review.

Iraan-Sheffield Collegiate Independent School District (ISD received notification of noncompliance in a letter dated 1/31/2023 listing the following area of noncompliance:

• §300.320(a)(1)(i) How the child's disability affects the child's involvement and progress in the general education curriculum (i.e., the same curriculum as for nondisabled children);

A plan for correction of the noncompliance was included in your corrective action plan. Subsequently, the local education agency (LEA) was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the abovementioned noncompliance. The documentation submitted by the LEA indicated that this area of noncompliance has been addressed, and the noncompliance has been corrected.
