The purpose of this correspondence is to notify the Southside Independent School District (ISD) of the correction of noncompliance identified in the Cyclical Desk Review.

Southside ISD received notification of noncompliance in a letter dated 4/28/2023 listing the following areas of noncompliance:

- IEP Development: Measurable Goals  
**34 Code of Federal Regulation (CFR) §300.320(a)(2)(i)**
- IEP Development: Progress Reporting  
**34 CFR §300.320(a)(3)(i)**
- IEP Content: Notice of ARD  
**34 CFR §300.324(b)(1)(i)**

A plan for correction of the noncompliance was included in your corrective action plan. Subsequently, the local education agency (LEA) was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the abovementioned noncompliance. The documentation submitted by the LEA indicated that this area of
