The purpose of this correspondence is to notify the Eagle Pass Independent School District (ISD) of the correction of noncompliance identified in the Cyclical On-site.

Eagle Pass ISD received notification of noncompliance in a letter dated 1/31/2023 listing the following areas of noncompliance:

- Present Level of Academic Achievement and Functional Performance (PLAAFP)

- Measurable Annual Goals

A plan for correction of the noncompliance was included in your corrective action plan. Subsequently, the local education agency (LEA) was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the issue of noncompliance noted above. The documentation submitted by the LEA indicated that this area of noncompliance
