# Submissions to the Texas Education Agency (TEA)

Although most local education agencies (LEAs) with a Determination Level (DL) of DL 1 – DL 4 will engage in continuous improvement activities, submissions of the strategic support plan (SSP) will vary by program. **LEAs will not be required to develop a goal for every indicator in the Results Driven Accountability (RDA) Framework.** The LEA is encouraged to complete a root cause analysis to identify and prioritize goals represented on the SSP.

LEAs engaging in RDA continuous improvement activities are no longer required to submit a District Coordinator of School Improvement (DCSI) Superintendent Attestation in the Ascend Texas application located in the Texas Education Agency Login (TEAL); however, the superintendent should appoint a DCSI to facilitate the SSP process. The DCSI should be an individual serving in a position to impact and/or influence the implementation of best practices aligned to increasing positive student outcomes.
