Subject: Notification of Correction of Noncompliance

Dear Dr. Muhammad-Rodgers:

The purpose of this correspondence is to notify the DeSoto Independent School District of the correction of noncompliance identified in the Cyclical Desk Review.

DeSoto ISD received notification of noncompliance in a letter dated 4/28/2023 listing the following area of noncompliance:

- **Properly Constituted ARD:** PCA10 - 19 TAC §89.1050(c)(1)(I)
- **Properly Constituted ARD:** PCA12 - 34 CFR §300.321(a)(2); 34 CFR §300.321(a)(3); 34 CFR §300.321(a)(4); 34 CFR §300.321(a)(5); 34 CFR §300.321(e)(2)
- **IEP Content:** IC1 - 34 CFR §300.324(b)(1)(i)
- **IEP Development:** ID4 - 34 CFR §300.320(a)(3)(ii)
- **IEP Development:** ID10 - 34 CFR §300.320(a)(2)(i)
- **Transition:** TR1 - TEC §29.011; 19 TAC §89.1055(h)

A plan for correction of the noncompliance was included in your corrective action plan. Subsequently, the local education agency (LEA) was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the abovementioned noncompliance. The documentation submitted by the LEA indicated that this area of noncompliance has been addressed, and the noncompliance has been corrected. Therefore, no further action on this issue is required at this time.
