"The State submitted a formal inquiry (Ticket #25-01927) to the EDFacts Partner Support Center (PSC) on April 16, 2025, requesting program office review of the scoring applied to Texas's FFY 2023 assessment data (FS185 and FS188) under the Section 618 data rubric. Although the submission was marked Timely and Complete in EDPass, the State received a score of "0" for the Passed Edit Check (Accuracy) due to a discrepancy greater than 1% between Category Set C (total students with disabilities) and Category Set J (disaggregated by race/ethnicity). This discrepancy was due to records with unknown race/ethnicity, which were appropriately excluded from Category Set J in accordance with FS185/FS188 guidance. The State provided a detailed explanation citing relevant federal specifications and requested clarification and potential reconsideration of the scoring outcome."
