The agency offers multiple ways for stakeholders, including local educational agencies (LEAs), to help shape the activities outlined in the Excel Interactive Spreadsheet. Agency staff regularly meet with special education directors from LEAs through both formal and informal channels to understand their needs. This includes a state-created panel of special education directors that meets regularly and represents the geographic and demographic diversity of the state's 1200+ LEAs. The agency also works closely with the state's 20 regional education service centers (ESCs), which maintain strong relationships with local LEAs. Weekly meetings with ESC staff, along with ongoing communication between ESCs and the agency's Office of Special Populations and Student Supports, ensure a steady two-way exchange of information.

A common message from the field is that needs change quickly, and LEAs value the state's ability to respond promptly. As a result, the state's worksheet allows flexibility in how funds are allocated to address emerging needs.

Additionally, monitoring teams provide technical assistance to LEAs based on student outcome data from the Results Driven Accountability (RDA) system. LEAs use this data to identify the support they need. Throughout the grant year, agency staff stay engaged with LEAs and ESCs to adjust and enhance initiatives as needed. The ongoing input helps the agency use its funding flexibility to launch projects that meet the diverse needs of students across the state.


Total Amount of State Financial Support Made Available for Special Education and Related Services for Children with Disabilities
