Dear Mr. Matt Kimball:

The purpose of this correspondence is to notify the Sunnyvale Independent School District (ISD) of the correction of noncompliance identified in the Cyclical Desk Review.

Sunnyvale ISD received notification of noncompliance in a letter dated 4/27/2023 listing the following areas of noncompliance:

- IEP Development: Measurable Annual Goals  
34 CFR §300.320(a)(2)(i)
- Transition: Timeline: First Transition held by 14<sup>th</sup> birthday  
TEC §29.011; 19 TAC §89.1055(h)
- Transition: Postsecondary Goals  
34 CFR §300.320(b)(1); 19 TAC §89.1055(j)(1)
- Transition: Transfer of Rights  
TEC §29.017(c); 19 TAC §89.1049(a)

A plan for correction of the noncompliance was included in your corrective action plan. Subsequently, the local education agency (LEA) was required to submit documentation to the Texas Education Agency (TEA) verifying correction for the abovementioned
